

COMMENCING AT THE CENTER OF SAID SECTION 8; THENCE NORTH 88°16'14" WEST ALONG THE EAST-WEST ONE-QUARTER (E-W 1/4) SECTION LINE OF SAID SECTION 8 A DISTANCE OF 668.47 FEET; THENCE SOUTH 01"43'46" WEST A DISTANCE 254.13 FEET TO A POINT BEING THE NORTHEAST CORNER OF SAID CERTAIN PARCEL OF LAND AND THE POINT OF BEGINNING; THENCE NORTH 88'09'42" WEST ALONG THE NORTH LINE OF SAID PARCEL OF LAND A DISTANCE OF 221.87 FEET TO THE POINT OF BEGINNING OF A CURVE CONCAVE TO THE SOUTHWEST HAVING A RADIUS OF 250.00 FEET AND A CENTRAL ANGLE OF 10°00'00" A RADIAL LINE PASSING THROUGH SAID POINT OF CURVATURE BEARS NORTH 01°50'18" EAST: THENCE DEPARTING FROM THE NORTH LINE OF SAID PARCEL EASTERLY AND SOUTHEASTERLY ALONG THE ARC OF SAID CURVE A DISTANCE OF 43.63 FEET TO A TANGENT LINE; THENCE SOUTH 78°09'42" EAST ALONG SAID TANGENT LINE A DISTANCE OF 51.88 FEET TO THE BEGINNING OF A CURVE CONCAVE TO THE NORTHEAST HAVING A RADIUS OF 300.00 FEET AND A CENTRAL ANGLE OF 13°03'10"; THENCE EASTERLY ALONG THE ARC OF SAID CURVE A DISTANCE OF 68.34 FEET TO A REVERSE CURVE CONCAVE TO THE SOUTHWEST HAVING A RADIUS OF 32.00 FEET AND A CENTRAL ANGLE OF 92°08'12"; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE A DISTANCE OF 51.46 FEET TO A REVERSE CURVE CONCAVE TO THE EAST HAVING A RADIUS OF 422.97 FEET; THENCE SOUTHEASTERLY THROUGH A CENTRAL ANGLE OF 18'52'28" AND ALONG THE ARC OF SAID CURVE A DISTANCE OF 139.34 FEET TO THE INTERSECTION WITH THE EAST LINE OF SAID CERTAIN PARCEL OF LAND: THENCE NORTH 02°02'40" EAST ALONG SAID EAST LINE A DISTANCE OF 184.83 FEET TO POINT OF THE BEGINNING.




