Know ALL MEN BY THESE PRESENTS, that HENRY P. WILKINSON, joined by his wife, VERA M. WILKINSON, and LONNIE L. ISBELL, joined by his wife, LORENE ISBELL, the owners in fee simple of the land lying and being in PALM BEACH COUNTY, FLORIDA, and shown on the attached plot as "PALM ACRES ESTATES", and more particularly described as:

The South Three-quarters of the South Half of the Southwest One-quarter of the Northwest One-quarter, (5 3/4 of 5 1/4 of S.W. 1/4 of N.W. 1/4) and the North Half of the Northwest One-quarter of the Southwest One-quarter (1 1/2 of N.W. 1/4 of S.W. 1/4), in SECTION 5, TOWNSHIP 44, S., RANGE 43 E., containing 35 acres, more or less,

have caused the same to be surveyed and plotted as shown hereon and do hereby dedicate to the perpetual use of the public as public highways the streets and avenues as shown, reserving however unto themselves, their heirs, successors, assigns or legal representatives, the reversion or reversions thereof whenever the same shall be abandoned by the public or discontinued by law.


