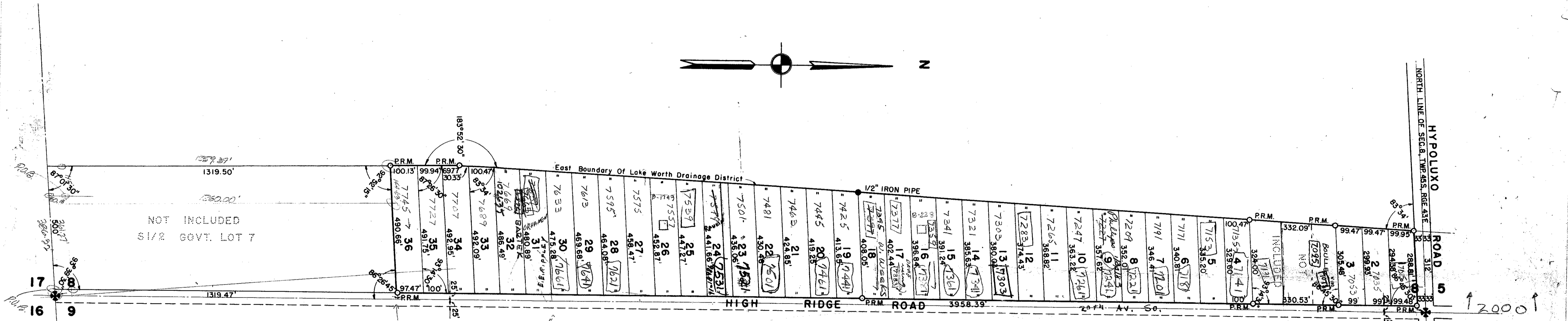
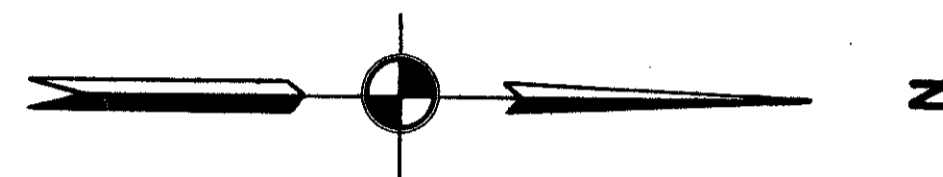

KNOW ALL MEN BY THESE PRESENTS, that MARY A. LYMAN, INCORPORATED, a Florida Corporation, the Owner in fee simple of the tract of land lying and being in Palm Beach County, Florida, shown on the attached plat as HIGH RIDGE SUBDIVISION and more particularly described as follows, to wit:
Government Lot 1, except the South 330 feet of the North 660 feet, and the North half of Government Lot 7, Section 8, Township 45 South, Range 43 East; also all that part of Section 8 lying between the Westerly extensions of the North and South lines of the herein described two tracts of land, and extending Westerly from the Government Meander line of said Section 8 to the Easterly boundary line of the Lake Worth Drainage District.
has caused the same to be surveyed and platted as shown hereon, and does hereby dedicate to the perpetual use of the public as public highways, the roads as shown hereon, reserving, however, unto itself, its successors, assigns or legal representatives, the reversion or reversions thereof, whenever the same shall be abandoned by the public or discontinued by law.
