KNOW ALL MEN BY THESE PRESENTS THAT JUPITER INLET CORP., A FLORIDA CORPORATION OWNER OF THE LAND HEREON, BEING IN GOVERNMENT LOT 1, SECTION 30, TOWNSHIP 40 SOUTH, RANGE 43 EAST, PALM BEACH COUNTY, FLORIDA, SHOWN HEREON AS BROADVIEW CONDOMINIUM APARTMENTS. BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

THAT PART OF GOVERNMENT LOT 1, SECTION 30, TOWNSHIP 40 SOUTH, RANGE 43 EAST, PALM BEACH COUNTY, FLORIDA, LYING EASTERLY OF THE RIGHT-OF WAY FOR UNITED STATES HIGHWAY NO. 1 (STATE POAD NO. 5)

THAT PROMONTORY OF LAND IN GOVERNMENT LOT 1, SECTION 30, TOWNSHIP 40 SOUTH, RANGE 43 EAST, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

FROM THE INTERSECTION OF THE NORTH LINE OF SAID GOVERNMENT LOT 1 AND THE CENTERLINE OF UNITED STATES HIGHWAY 1, (STATE ROAD 5) RUN SOUTHEASTERLY ON SAID CENTERLINE 419.57 FEET TO A POINT IN A LINE WHICH IS 400 FEET SOUTHERLY OF AND PARALLEL TO THE SAID NORTH LINE OF GOVERNMENT LOT 1; THENCE EASTERLY PARALLEL TO SAID NORTH LINE OF GOVERNMENT LOT 1 A DISTANCE OF 347.45 FEET, MORE OR LESS, TO THE EAST SHORE OF HOBE SOUND, (ALSO KNOWN AS JUPITER SOUND); THENCE CONTINUE EASTERLY ON SAME COURSE ACROSS THE MOUTH OF AN ESTUARY OF HOBE SOUND (WHICH EXTENDS SOUTHEASTERLY 200 FEET, MORE OR LESS) 110 FEET, MORE OR LESS, TO THE WESTERLY SHORE OF A PROMONTORY EXTENDING NORTHERLY TO THE SHORE OF HOBE SOUND WHICH IS THE POINT OF BEGINNING; THENCE CONTINUE EASTERLY ON SAME COURSE 235 FEET, MORE OR LESS, TO THE WESTERLY SHORE OF HOBE SOUND; THENCE MEANDER SAID SHORE IN THE NORTHWESTERLY, WESTERLY AND SOUTHWESTERLY DIRECTION 300 FEET, MORE OR LESS, TO THE POINT OF BEGINNING.


