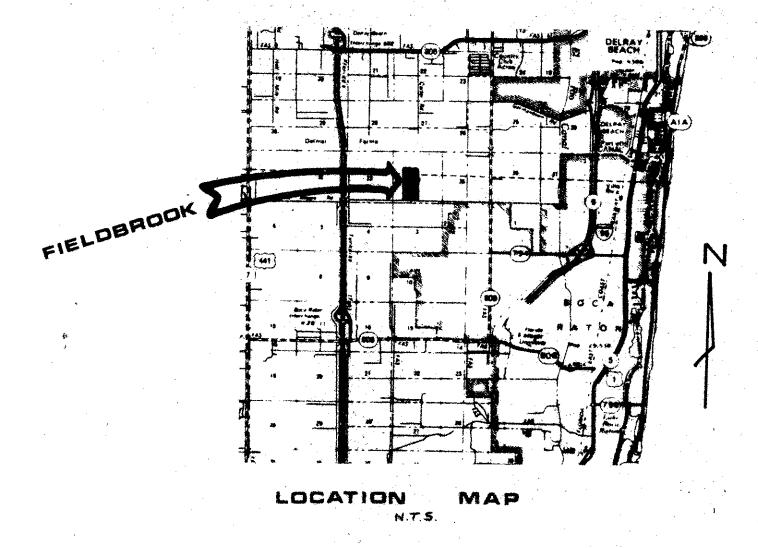
A Planned Unit Development FIELDBROOK

DEDICATION:

KNOW ALL MEN BY THESE PRESENTS THAT BARSMITH CORPORATION, A FLORIDA CORPORATION, OWNERS OF THE LAND SHOWN HEREON, LYING IN THE SOUTHWEST ONE-QUARTER OF SECTION 34. TOWNSHIP 46 SOUTH, RANGE 42 FAST. PALM BEACH COUNTY, FLORIDA: SHOWN HEREON AS FIELDBROOK. A PLANNED UNIT DEVELOPMENT. AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTH ONE-QUARTER CORNER OF SAID SECTION 34; THENCE, RUN SOUTH 00°04'11" WEST, ALONG THE EAST LINE OF THE SOUTHWEST ONE-QUARTER OF SAID SECTION 34, A DISTANCE OF 60.00 FEET TO A POINT IN THE NORTHERLY RIGHT OF WAY OF CLINTMORE ROAD AND THE POINT OF BEGINNING (P.O.B.)

THENCE, NORTH 00°17'28" EAST, ALONG SAID EAST LINE, A DISTANCE OF 2533.82 FEET; THENCE, SOUTH 89°28'46" EAST, ALONG THE LINE 95.00 FEET SOUTHERLY OF AS MEASURED AT RIGHT ANGLES TO THE NORTH LINE OF THE SOUTHWEST ONE-QUARTER OF SAID SECTION 34, A DISTANCE OF 1352.55 FEET TO A POINT IN THE EAST LINE OF THE SOUTHWEST ONE-QUARTER OF SAID SECTION 34; THENCE, SOUTH 00°04'11" WEST, ALONG SAID EAST LINE, A DISTANCE OF 2532.39 FEET TO THE POINT OF BEGINNING.

CONTAINING: 78.94 ACRES, MORE OR LESS.

HAVE CAUSED THE SAME TO BE SURVEYED AND PLATTED AS SHOWN HEREON AND DO HEREBY DEDICATE AS FOLLOWS:

- 1. UTILITY EASEMENTS, DRAINAGE EASEMENTS, AND DRAINAGE MAINTENANCE EASEMENTS, AS SHOWN HEREON ARE HEREBY DEDICATED IN PERPETUITY FOR THE PURPOSES OF CONSTRUCTION AND MAINTENANCE OF UTILITYES AND DRAINAGE.
- 2. THE LAKE (TRACT "A") AS SHOWN HEREON, IS HEREBY DEDICATED TO THE FIELDBROOK PROPERTY OWNERS' ASSOCIATION, INC., A NON-PROFIT FLORIDA CORPORATION, FOR PROPER PURPOSES AND IS THE PERPETUAL MAINTENANCE OBLIGATION OF SAID HOME OWNERS' ASSOCIATION.
- THE ROAD RIGHTS OF WAY (TRACT "B") AS SHOWN HEREON. ARE HEREBY DEDICATED TO THE FIELDBROOK PROPERTY OWNERS' ASSOCIATION, INC., A NON-PROFIT FLORIDA CORPORATION, FOR PROPER PURPOSES AND ARE THE PERPETUAL MAINTENANCE OBLIGATION OF SAID HOME OWNERS' ASSOCIATION, AND ARE RESERVED FOR THE USE OF, CONSTRUCTION AND MAINTENANCE OF UTILITIES AND DRAINAGE.
- THE RIGHT OF WAY FOR BONIELLO ROAD AND POWER LINE ROAD AS SHOWN HEREON, IS HEREBY DEDICATED TO THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, FOR THE PERPETUAL USE OF THE PUBLIC FOR PROPER PURPOSES.
- 5. THE LIMITED ACCESS EASEMENT, AS SHOWN HEREON, IS HEREBY DEDICATED TO THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, FOR THE PURPOSE OF CONTROL AND JURISDICTION OVER ACCESS RIGHTS.
