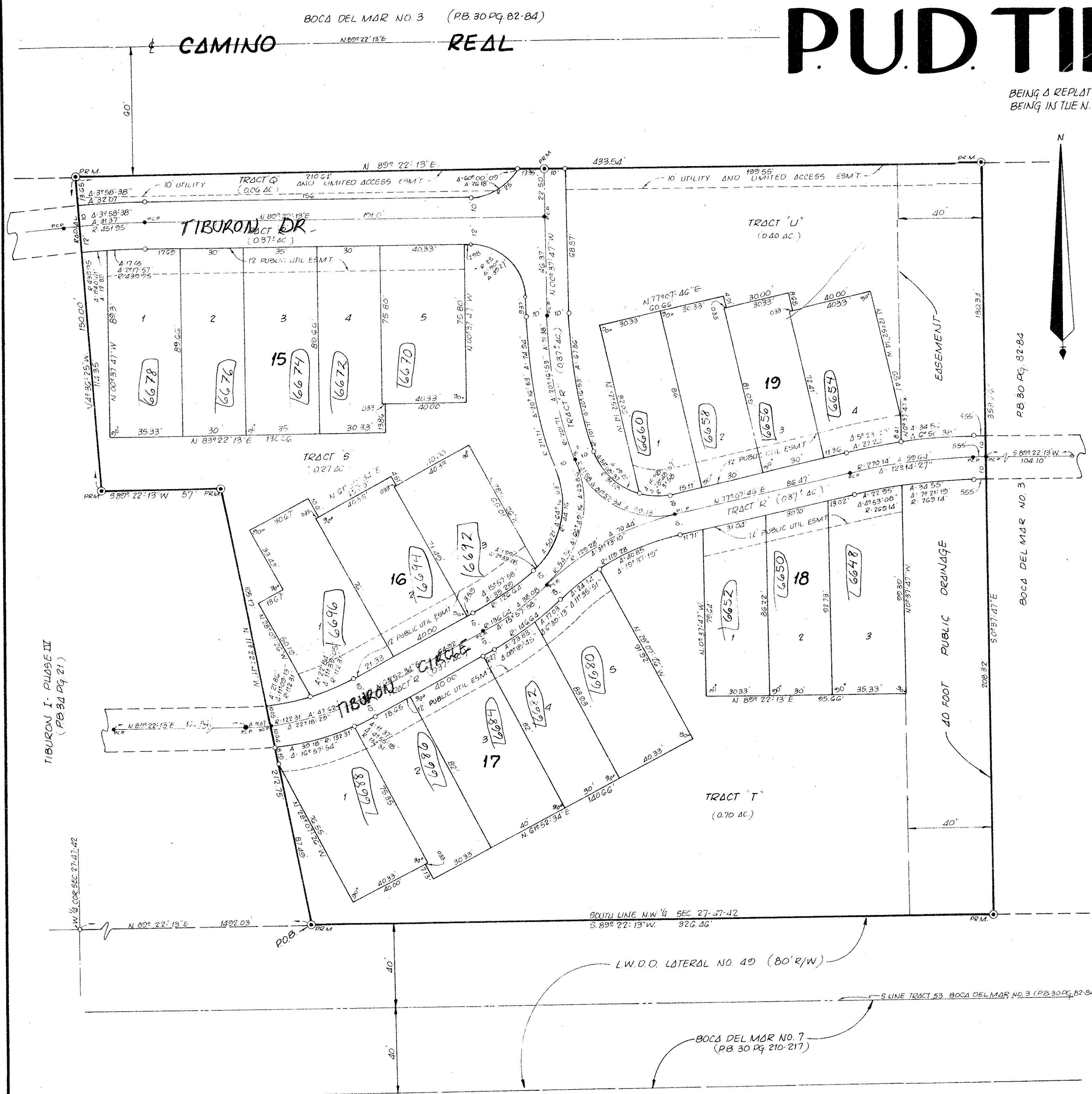

### DEDICATION

**KNOW ALL MEN BY THESE PRESENTS:** THAT THE BABCOCK COMPANY, A FLORIDA CORPORATION, AND THE OWNER OF THE LAND SHOWN HEREON BEING IN THE N.W. 1/4 OF SECTION 27, TOWNSHIP 47 SOUTH, RANGE 42 EAST, PALM BEACH COUNTY, FLORIDA, BEING ALSO A PORTION OF TRACT 53 OF THE PLAT OF "BOCA DEL MAR NO. 3" AS RECORDED IN PLAT BOOK 30, PAGES 82-84 OF THE PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA, SHOWN HEREON AS "TIBURON I, PHASE V" AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCE AT THE WEST 1/4 CORNER OF SAID SECTION 27, THENCE N. 89° 22' 13" E, ALONG THE SOUTH LINE OF THE N.W. 1/4 OF SAID SECTION 27, FOR 1492.03 FEET TO THE POINT OF BEGINNING OF THE FOLLOWING DESCRIBED PARCEL OF LAND; THENCE N. 11° 22' 41" W. FOR 212.75 FEET, THENCE S. 89° 22' 13" W. FOR 57.00 FEET, THENCE N. 4° 36' 25" W. FOR 150.00 FEET; (THE LAST THREE MENTIONED COURSES BEING COINCIDENT WITH THE EASTERLY BOUNDARY OF TIBURON I - PHASE IV AS RECORDED IN PLAT BOOK 30, PAGE 21 OF THE PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA), THENCE N. 89° 22' 13" E ALONG THE NORTH LINE OF SAID TRACT 53 OF THE PLAT OF "BOCA DEL MAR NO. 3" FOR 433.54 FEET, THENCE S. 0° 37' 47" E. FOR 358.66 FEET, THENCE S. 89° 22' 13" W. ALONG THE SOUTH LINE OF THE N.W. 1/4 OF SAID SECTION 27, FOR 326.46 FEET TO THE POINT OF BEGINNING.

HAS CAUSED THE SAME TO BE SURVEYED AND PLATTED AS SHOWN HEREON, AND WHEREBY DEDICATE AS FOLLOWS: TRACTS Q, R, S, T, AND U ARE HEREBY DEDICATED TO THE TIBURON I HOMEOWNERS ASSOCIATION, AND ARE THE PERPETUAL MAINTENANCE OBLIGATION OF SAID ASSOCIATION. TRACTS Q, S, T, AND U ARE HEREBY RESERVED AS COMMON AREA, AND AS AN EASEMENT FOR THE INSTALLATION AND MAINTENANCE OF PUBLIC UTILITIES AND PRIVATE DRAINAGE FACILITIES. TRACT R IS RESERVED FOR INGRESS, EGRESS, AND UTILITY EASEMENTS. THE PUBLIC UTILITY AND DRAINAGE EASEMENTS AS SHOWN HEREON ARE HEREBY DEDICATED AS PERPETUAL EASEMENTS FOR THE INSTALLATION AND MAINTENANCE OF PUBLIC UTILITIES AND DRAINAGE FACILITIES. THE AREA INDICATED AS A LIMITED ACCESS STRIP IS DEDICATED TO THE BOARD OF COUNTY COMMISSIONERS FOR THE PURPOSE OF CONTROL AND JURISDICTION OVER ACCESS RIGHTS.

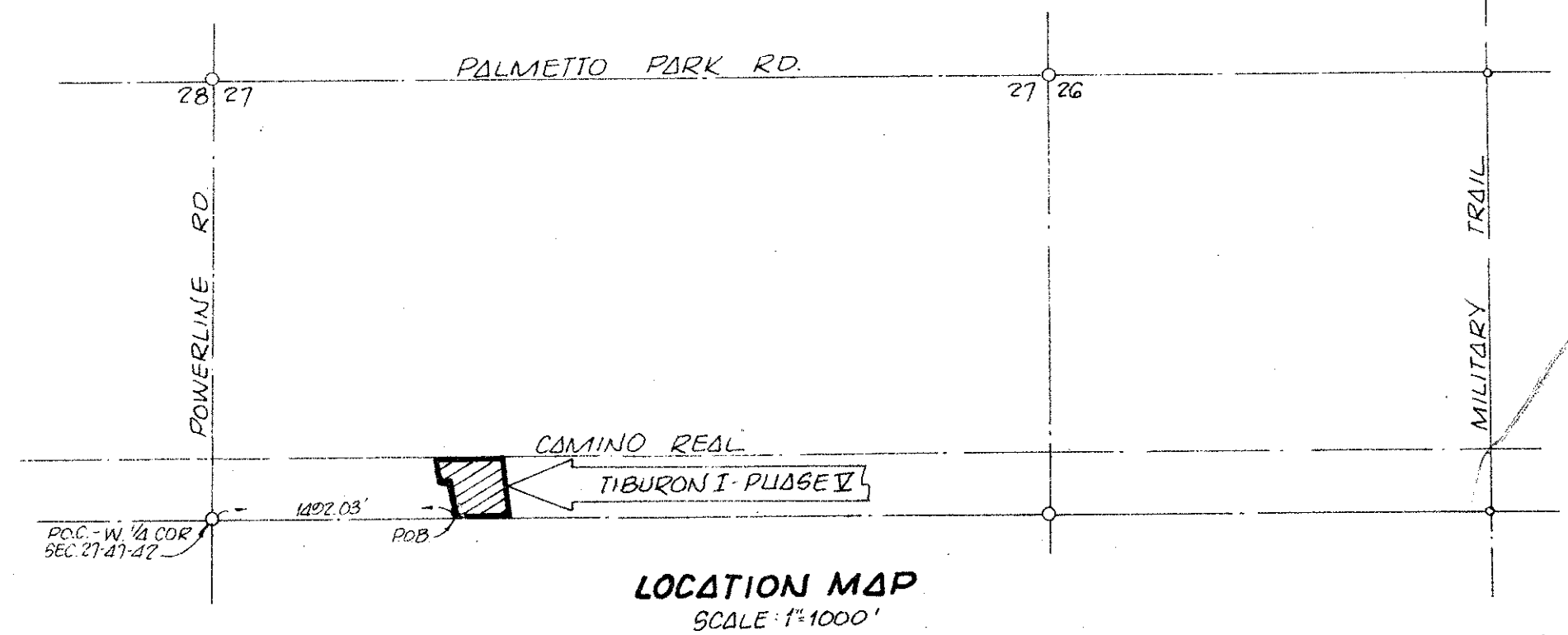

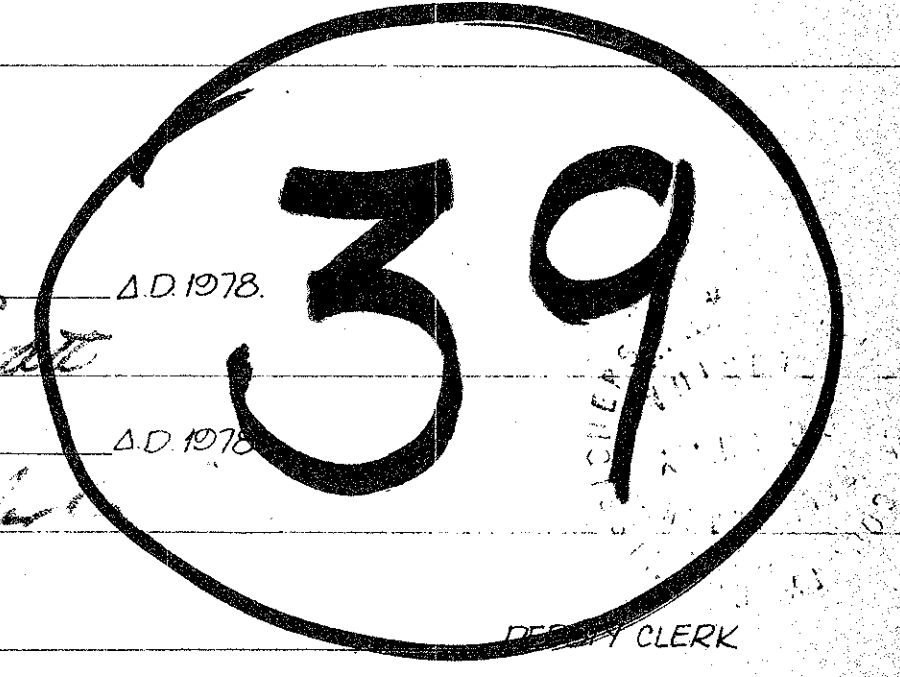
