KNOW ALL MEN BY THESE PRESENTS, THAT GEORGE H. SPARLING AND DAN J. RICKER, TRUSTEES, THE OWNERS OF A TRACT OF LAND LYING AND BEING IN SECTIONS 30 AND 31, TOWNSHIP 44 SOUTH, RANGE 42 EAST, PALM BEACH COUNTY, FLORIDA, SHOWN HEREON AS BOCA PATIOS, BEING A REPLAT OF PORTIONS OF LOTS 86, 87, 88, 103, 104, AND 105, BLOCK 81, PALM BEACH FARMS COMPANY PLAT NO. 3, RECORDED IN PLAT BOOK 2, PAGE 53, PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHEAST CORNER OF SAID LOT 86, BLOCK 81; THENCE SOUTH 65°50'15" WEST, A DISTANCE OF 159.53 FEET TO THE WEST RIGHT OF WAY LINE OF SOUTHWEST LYONS ROAD, AS SAID RIGHT OF WAY LINE IS SHOWN ON THE PLAT OF SANDALFOOT COVE SECTION EIGHT, RECORDED IN PLAT BOOK 30, PAGE 225 THROUGH 228, INCLUSIVE, PUBLIC RECORDS OF SAID COUNTY, AND THE POINT OF BEGINNING THENCE SOUTH ON SAID RIGHT OF WAY LINE AND ITS SOUTH EXTENSION, A DISTANCE OF 1245.51 FEET THENCE NORTH 84°08'30" WEST, A DISTANCE OF 645.16 FEET TO THE BEGINNING OF A CURVE CONCAVE TO THE SOUTH, HAVING A RADIUS OF 600 FEET AND A CENTRAL ANGLE OF 19°53'40"; THENCE WESTERLY ALONG THE ARC OF SAID CURVE, A DISTANCE OF 208.33 FEET TO A TANGENT LINE; THENCE SOUTH 75°57'50" WEST ALONG SAID TANGENT LINE, A DISTANCE OF 208.38 FEET TO THE BEGINNING OF A CURVE CONCAVI TO THE NORTHEAST, HAVING A RADIUS OF 85 FEET AND A CENTRAL ANGLE OF 152°24'09"; THENCE WESTERLY, NORTHERLY, AND NORTHEASTERLY ALONG THE ARC OF SAID CURVE, A DISTANCE OF 226.09 FEET TO A TANGENT LINE; THENCE NORTH 48°21'59" EAST, ALONG SAID TANGENT LINE, A DISTANCE OF 978.49 FEET; THENCE NORTH 41°27'02" EAST, A DISTANCE OF 598.92 FEET TO THE POINT OF BEGINNING.

- 2. THE STREET AS SHOWN IS HEREBY DEDICATED TO THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, FOR PERPETUAL USE OF THE PUBLIC FOR PROPER PURPOSES.
- 3. RECREATION AREA TRACTS A, B, C AND D ARE HEREBY DEDICATED TO THE BOCA PATIOS HOME OWNERS ASSOCIATION, FOR RECREATION PURPOSES AND ARE THE PERPETUAL MAINTENANCE OBLIGATION OF SAID ASSOCIATION.


