- 1. The Utility and Drainage Easements, as shown, are hereby dedicated in perpetuity for the construction, operation and maintenance of utilities and drainage facilities.
- 2. Parcel R-I, as shown hereon, is hereby designated as and declared to be a "Recreation Area" as such term is defined in the Declaration of Protective Covenants and Restrictions for Loggers' Run, as recorded in O.R. Book 2793, Page I, of the Public Records of Palm Beach County, Florida, and is the perpetual maintenance obligation of Loggers' Run, Inc.
