

DESCRIPTION

A Parcel of land lying and being in Section 17, Township 44 South Range 41 East, Palm Beach County, Florida, and more particularly described as follows:
Commencing at the Northwest Corner of Section 17, Township 44 South Range 41 East, Palm Beach County, Florida, thence S. 00° 50' 00" W. along the West line of said Section 17, a distance of 5000 feet to the POINT OF BEGINNING, said point being the westerly extension of the South Right of Way Line of Acme Improvement District C-15 as described in Deed Book 1037, Page 689, Public Records of Palm Beach County, Florida, thence S. 88° 26' 11" E., a distance of 5359.50 feet to a point on the East line of said Section 17, thence S. 00° 51' 23" W. along the said East line of Section 17 being the West Line of Greenview Shores No. 2 as recorded in Plat Book 31, Pages 120 to 136, incl., shown on Sheet No. 5, Public Records of Palm Beach County, Florida, a distance of 4000.68 feet to the Northeast corner of a Parcel of land as described in Official Record Book 1826, pages 233 and 234 of said Public Records, thence N. 89° 39' 54" W. a distance of 354.86 feet, thence S. 00° 51' 18" W. a distance of 1350.02 feet to the Southwest corner of the above parcel of land and a point on the South line of said Section 17, thence N. 89° 37' 45" W. along said South line of Section 17, a distance of 5022.40 feet to the Southwest Corner of said Section 17, thence N. 00° 50' 00" E. along the West line of said Section 17, a distance of 5437.83 feet to the POINT OF BEGINNING.

DEDICATION

KNOW ALL MEN BY THESE PRESENTS, that GOULD FLORIDA, INC., a Delaware Corporation organized to do business in Florida, joined by ACME IMPROVEMENT DISTRICT, its sole member, the land shown hereon as SADDLE TRAIL PARK OF WELLINGTON P.U.D. lying in part in Section 17, Township 44 South Range 41 East, Palm Beach County, Florida, and being more particularly described by the dedication hereon have caused the same to be surveyed and plotted as shown hereon and do hereby dedicate to the Mayor, Streets, Greenview Boulevard and Wellington Tract, and hereby dedicate to the Board of Commissioners of Palm Beach County, Florida, for the use of the public, the portion of said land shown on the plan as follows: the Bridge Path and Acme Improvement District Right of Way as shown on a hereby dedicated to ACME IMPROVEMENT DISTRICT, as fee simple, provided however, that in the event ACME IMPROVEMENT DISTRICT ceases to exist or to have the authority to maintain the same, then in that event the aforementioned shall revert to FIRST WELLINGTON, INC. and shall be owned by First WELLINGTON, INC. as provided in the Restated Articles of Incorporation of First Wellington, Book 211, Pages 154.5, to 155.4, inclusive, and Amended in Official Record Book 2280, Pages 221 to 223, inclusive, Public Records of Palm Beach County, Florida, 1973.
