COMMUNITY, AREAS

TRACT "A" IS FOR PRIVATE ROAD, UTILITY AND DRAINAGE PURPOSES; TRACT "B" IS FOR INGRESS, EGRESS, PARKING, UTILITY AND DRAINAGE PURPOSES AND TRACT "C" IS FOR RECREATION AND OTHER COMMUNITY PURPOSES AND ALL ARE HEREBY DEDICATED TO "THE VILLA SONESTA AT BOCA POINTE HOMEOWNERS' ASSOCIATION, INC." AND ARE THE PERPETUAL MAINTENANCE OBLIGATION OF SAID ASSOCIATION, ITS SUCCESSORS OR ASSIGNS WITHOUT RECOURSE TO PALM BEACH COUNTY.

2. EASEMENTS

UTILITY AND DRAINAGE EASEMENTS - THE UTILITY EASEMENTS AND DRAINAGE EASEMENTS AS SHOWN ARE HEREBY DEDICATED IN PERPETUITY FOR THE CONSTRUCTION AND MAINTENANCE OF UTILITIES AND DRAINAGE. THE DRAINAGE EASEMENTS ARE "THE PERPETUAL MAINTENANCE OBLIGATION OF "THE VILLA SONESTA AT BOCA POINTE HOMEOWNERS ASSOCIATION, INC.", ITS SUCCESORS OR ASSIGNS. HOWEVER, PALM BEACH COUNTY SHALL HAVE THE RIGHT, BUT NOT THE OBLIGATION, TO MAINTAIN THAT PORTION OF THE DRAINAGE SYSTEM WITHIN VILLA SONESTA WHICH IS ASSOCIATED WITH A COUNTY ROAD.

INGRESS AND EGRESS EASEMENTS AS SHOWN, ARE HEREBY DEDICATED FOR ACCESS PURPOSES AND SHALL BE THE MAINTENANCE OBLIGATION OF ANY CONDOMINIUM ASSOCIATION WHICH MAY BE ESTABLISHED FROM TIME TO TIME BY THE OWNER, ITS SUCCESSORS OR ASSIGNS. PURSUANT TO DECLARA-TION (S) OF CONDOMINIUM RECORDED IN THE PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA CREATING NEW SUCH CONDOMINIUM (S); WITHOUT RECOURSE TO PALM BEACH COUNTY.
