

Properties, Inc., being more particularly described as follows:

Tract "A" - Tract "A" as shown hereon, is hereby dedicated to the Board of County Commissioners of Palm Beach County, Florida, for the perpetual use of the public for public street purposes.

Tract "B" - Tract "B" as shown hereon is hereby dedicated to S.T.J. Properties, Inc., a Florida corporation, its successors and assigns, for commercial purposes and other purposes not inconsistant with this reservation and is the perpetual maintenance obligation of said corporation, its successors and assigns, without recourse to Palm Beach County.

Utility Easement - The utility easement as shown hereon is hereby dedicated in perpetuity for the construction and maintenance of utility facilities, including cable television systems. The installation of cable television systems shall not interfere with the construction and maintenance of other utilities.

Limited Access Easement - The limited access easement as shown hereon is hereby dedicated to the Board of County Commissioners of Palm Beach County, Florida, for the purpose of control and jurisdiction over access rights.




