

O'BRIEN, AS TRUSTEE, UNDER LAND TRUST AGREEMENT DATED MARCH 8, 1989 OWNER OF THE LAND SHOWN HEREON AS "WINSTON TRAILS SOUTH", PART OF WINSTON TRAILS P.U.D., SITUATE IN SECTION 2, TOWNSHIP 45 SOUTH, RANGE 42 EAST, PALM BEACH COUNTY, FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

A PARCEL OF LAND SITUATE IN SECTION 2, TOWNSHIP 45 SOUTH, RANGE 42 EAST, PALM BEACH COUNTY, FLORIDA, MORE PARTICULARLY DESCRIBED AS

COMMENCING AT THE SOUTHWEST CORNER OF SAID SECTION 2, TOWNSHIP 45 SOUTH, RANGE 42 EAST; THENCE SOUTH 89'00'36" EAST, ALONG THE SOUTH LINE OF THE SOUTHWEST ONE-QUARTER OF SAID SECTION 2, A DISTANCE OF 951.22 FEET; THENCE NORTH 00'59'24" EAST, DEPARTING SAID SOUTH LINE, A DISTANCE OF 110.00 FEET TO THE POINT OF BEGINNING, SAID POINT BEING ON THE NORTH RIGHT-OF-WAY LINE OF HYPOLUXO ROAD, 110 FEET IN WIDTH, AS SHOWN ON THE PALM BEACH COUNTY RIGHT-OF-WAY MAP NO. 87-3-5161-01, PALM BEACH COUNTY PROJECT NO. 87098;

THENCE NORTH 45*59'24" EAST, DEPARTING SAID NORTH RIGHT-OF-WAY LINE, A DISTANCE OF 56.57 FEET; THENCE NORTH 00'59'24" EAST, A DISTANCE OF 367.73 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE WESTERLY HAVING A RADIUS OF 1060.00 FEET; THENCE NORTHWESTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 30°18'35", AN ARC DISTANCE OF 560.74 FEET TO THE POINT OF TANGENCY; THENCE NORTH 29'19'11" WEST, A DISTANCE OF 146.70 FEET TO INTERSECT THE SOUTH LINE OF WINSTON TRAILS BOULEVARD, TRACT A, AS SHOWN ON THE PLAT OF WINSTON TRAILS BOULEVARD PHASE III, AS RECORDED IN PLAT BOOK 76 PAGES 179 THROUGH 180, INCLUSIVE, OF THE PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA; THENCE NORTH 60°40'48" EAST, ALONG SAID SOUTH LINE, A DISTANCE OF 80.00 FEET; THENCE SOUTH 29'19'11" EAST, DEPARTING SAID SOUTH LINE, A DISTANCE OF TO THE POINT OF CURVATURE OF A CURVE CONCAVE WESTERI HAVING A RADIUS OF 1140.00 FEET; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 30'18'35". AN ARC DISTANCE OF 603.06 FEET TO THE POINT OF TANGENCY; THENCE SOUTH 00'59'24" WEST, A DISTANCE OF 367.73; THENCE SOUTH 44.00.36" EAST, A DISTANCE OF 56.57 FEET TO INTERSECT THE NORTH RIGHT-OF-WAY LINE OF THE AFOREMENTIONED HYPOLUXO ROAD; THENCE NORTH 89'00'36" WEST, ALONG SAID NORTH RIGHT-OF-WAY LINE OF HYPOLUXO ROAD, A DISTANCE OF 160.00 FEET TO THE POINT OF

THE ABOVE DESCRIBED PARCEL CONTAINS 2.123 ACRES OF LAND, MORE OR LESS.

HAVE CAUSED THE SAME TO BE SURVEYED AND PLATTED AS SHOWN HEREON AND DO HEREBY DEDICATE AS FOLLOWS:

TRACT A, AS SHOWN HEREON, IS HEREBY RESERVED FOR THE WINSTON TRAILS FOUNDATION, INC., ITS SUCCESSORS AND ASSIGNS, FOR PRIVATE STREET PURPOSES AND OTHER PURPOSES NOT INCONSISTENT WITH THIS RESERVATION AND IS THE PERPETUAL MAINTENANCE OBLIGATION OF SAID ASSOCIATION, ITS SUCCESSORS AND ASSIGNS, WITHOUT RECOURSE TO PALM BEACH COUNTY.

2. PALM BEACH COUNTY SHALL HAVE THE RIGHT, BUT NOT THE OBLIGATION, TO MAINTAIN ANY PORTION OF THE DRAINAGE SYSTEM ENCOMPASSED BY THIS PLAT WHICH IS ASSOCIATED WITH THE DRAINAGE OF PUBLIC STREETS, INCLUDING THE RIGHT TO UTILIZE FOR PROPER PURPOSES ANY AND ALL DRAINAGE, LAKE MAINTENANCE, AND LAKE MAINTENANCE ACCESS EASEMENTS AND PRIVATE ROADS ASSOCIATED WITH SAID DRAINAGE SYSTEM.

THE PERMANENT CONSTRUCTION EASEMENT, AS SHOWN HEREON, IS HEREBY DEDICATED IN PERPETUITY TO THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY. FLORIDA, FOR THE PURPOSES OF PERFORMING ANY AND ALL CONSTRUCTION ACTIVITIES ASSOCIATED WITH ADJACENT THOROUGHFARE ROADS.


