


DEDICATION AND RESERVATION

KNOW ALL MEN BY THESE PRESENTS THAT THE CITY OF BELLE GLADE, OWNER OF THE LAND SHOWN HEREON AS BELLE GLADE BUSINESS PARK. BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

PART OF THE NORTHWEST QUARTER OF SECTION 29, TOWNSHIP 43 SOUTH, RANGE 37 EAST, PALM BEACH COUNTY, FLORIDA, AS FOLLOWS: COMMENCING AT THE NORTHWEST CORNER OF SECTION 29, TOWNSHIP 43 SOUTH, RANGE 37 EAST, THENCE SOUTH O DEGREES 22 MINUTES 48 SECONDS EAST, 150.00 FEET TO THE WESTERLY EXTENSION OF THE SOUTH RIGHT-OF-WAY LINE OF CURLEE ROAD AS NOW LAID OUT AND IN USE;

THENCE NORTH 89 DEGREES 56 MINUTES 34 SECONDS EAST, 60.00 FEET TO THE EAST RIGHT-OF-WAY LINE OF STATE ROAD 15, SECTION 93130-2505, SHEET 3 OF 5, DATED 5-13-70, LATEST REVISION DATED 3-14-78 AND THE POINT OF BEGINNING OF THE HEREINAFTER DESCRIBED PARCEL;

THENCE CONTINUE NORTH 89 DEGREES 56 MINUTES 34 SECONDS EAST, 1034.28 FEET ALONG THE SOUTH RIGHT-OF-WAY LINE OF CURLEE ROAD: THENCE SOUTH 0 DEGREES 22 MINUTES 48 SECONDS EAST, 2101.42 FEET ALONG A LINE PARALLEL WITH THE EAST RIGHT-OF-WAY LINE OF STATE ROAD 15 TO THE NORTH RIGHT-OF-WAY LINE OF A RAILROAD SPUR TRACK OF THE FLORIDA EAST COAST RAILWAY TO THE SUGAR CANE GROWERS COOPERATIVE;

THENCE SOUTH 89 DEGREES 27 MINUTES 07 SECONDS WEST, 1034.27 FEET ALONG THE NORTH RIGHT-OF-WAY LINE OF SAID RAILROAD SPUR TRACK. TO THE EAST RIGHT-OF-WAY LINE OF STATE ROAD 15: THENCE NORTH 0 DEGREES 22 MINUTES 48 SECONDS WEST, 2110.28 FEET ALONG THE EAST RIGHT-OF-WAY LINE OF STATE ROAD 15 TO THE

HAS CAUSED THE SAME TO BE SURVEYED AND PLATTED AS SHOWN HEREON AND DO HEREBY DEDICATE AND RESERVE AS FOLLOW:

1. ROADWAY TRACT

POINT OF BEGINNING.

TRACT R-1 AS SHOWN HEREON, IS HEREBY DEDICATED IN FEE SIMPLE TO THE CITY OF BELLE GLADE AS PUBLIC RIGHT OF WAY FOR STREET. UTILITY AND DRAINAGE PURPOSES.

2. DRAINAGE TRACTS

TRACTS L-1, L-2, AND L-3, AS SHOWN HEREON. ARE HEREBY RESERVED IN FEE SIMPLE BY THE CITY OF BELLE GLADE FOR STORMWATER MANAGEMENT AND DRAINAGE PURPOSES.

3. DRAINAGE EASEMENTS

DRAINAGE EASEMENTS, AS SHOWN HEREON, ARE HEREBY RESERVED BY THE CITY OF BELLE GLADE FOR THE INSTALLATION AND MAINTENANCE OF DRAINAGE FACILITIES.

4. LANDSCAPE BUFFER EASEMENTS

LANDSCAPE BUFFER EASEMENTS, AS SHOWN HEREON, ARE HEREBY RESERVED BY THE CITY OF BELLE GLADE FOR LANDSCAPE BUFFER PURPOSES.

5. UTILITY EASEMENTS

THE UTILITY EASEMENTS, AS SHOWN HEREON, ARE HEREBY RESERVED BY THE CITY OF BELLE GLADE IN PERPETUITY FOR THE CONSTRUCTION AND MAINTENANCE OF UTILITY FACILITIES, INCLUDING CABLE TELEVISION SYSTEMS. THE INSTALLATION OF CABLE TELEVISION SYSTEMS SHALL NOT INTERFERE WITH THE CONSTRUCTION AND MAINTENANCE OF OTHER UTILITIES.

6. CANAL MAINTENANCE AND UTILITY EASEMENTS

CANAL MAINTENANCE AND UTILITY EASEMENTS, AS SHOWN HEREON, ARE HEREBY RESERVED BY THE CITY OF BELLE GLADE FOR CANAL MAINTENANCE AND UTILITY PURPOSES. THE UTILITY PORTION OF SAID EASEMENT SHALL ADHERE TO THE SAME STIPULATIONS AS RECITED ABOVE IN THE PREVIOUS NOTE.

7. LIMITED ACCESS EASEMENTS

LIMITED ACCESS EASEMENTS, AS SHOWN HEREON, ARE HEREBY RESERVED BY THE CITY OF BELLE GLADE FOR THE PURPOSES OF PROHIBITING ACCESS BETWEEN LOTS AND ADJACENT RIGHTS-OF-WAY.

8. FUTURE ROAD EASEMENT

THE FUTURE ROAD EASEMENT, AS SHOWN HEREON, IS HEREBY RESERVED BY THE CITY OF BELLE GLADE FOR FUTURE ROAD RIGHT-OF-WAY.

9. EMERGENCY ACCESS EASEMENTS

EMERGENCY ACCESS EASEMENTS, AS SHOWN HEREON, ARE HEREBY RESERVED BY THE CITY OF BELLE GLADE FOR EMERGENCY ACCESS PURPOSES.




