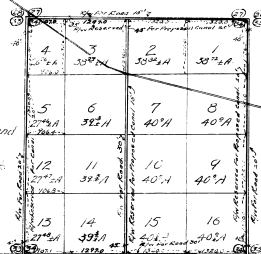
DEDICATION
