Commissioner Marcus commented on the restudy funding program as follows:

- C The resolution was specific in suggesting the state documentary stamp revenue be used to provide up to \$100 million a year.
- C She had been working with 16 other counties in an attempt to develop consensus on the documentary stamp as the single funding source and on filing resolutions similar to the one just adopted.
- C Even though some counties had differing opinions, and the South Florida Water Management District (SFWMD) was identifying other sources of funding, the documentary stamp remained the most consistently recommended statewide funding source.
- C Last year 51 percent of the documentary stamp revenue was generated in south Florida.
- C When the documentary stamp commitments are met, the overflow goes to the General Revenue Fund. Last year \$562 million was returned to General Revenue.
- C There is the potential to take \$8 million annually for 20 years to bond for debt service on the \$100 million needed to fund the Everglades program.
- C The Treasure Coast Regional Planning Council, at its

last meeting, took the position that a statewide funding source, such as the documentary stamp was appropriate.

MOTION to adopt the resolution. Motion by Commissioner Marcus and seconded by Commissioner Roberts.

Commissioner Marcus said similar resolutions, when adopted by all 16 counties, will be presented to the SFWMD at its March 14, 2000, meeting. SFWMD then will be able to make a recommendation to Governor Jeb Bush, she added.

Commissioner Roberts said if SFWMD cuts staff, some muchneeded programs would be affected in counties throughout its regulatory area. As a result, those counties would be contributing more than their share of funding to the restudy.

Commissioner Marcus informed the Board that several cities in the Miami-Dade area showed up at the Governor's Commission meeting yesterday and emphasized the hardship a cut in the program would cause them. She said the League of Cities would address the issue tomorrow to take a position on a similar resolution.

### PUBLIC COMMENT:

Audubon Society representative <u>Erin Deady</u> said some of the programs SFWMD proposed to cut were critical. She emphasized the importance of getting all 16 counties to voice the same message at the next legislative session in Tallahassee. She alerted the Board that a lot of northern counties would be in opposition because they think that south Florida should bear more than its fair share. She asked the Board to use its influence to change that opinion.

Commissioner Marcus pointed out that the Florida Association of Counties' main issue this year was the Everglades funding, with part of the support coming from a statewide funding source. She said she anticipated support from the senate.

Commissioner Masilotti said there was no need to give staff direction at this time.

Commissioner Aaronson pointed out that clubs in his district had been purchasing defibrillators. He said a Countywide effort should be made for all communities and clubhouses to have them on hand. He suggested a public relations campaign be done and that the Channel 20 mailer could be used as a means.

Commissioners Masilotti and Roberts asked staff to copy them on the number of defibrillators being discussed and requested that future items disclose quantities.

County Engineer George T. Webb pointed out that the job included Congress Avenue and three adjoining side streets. He said the work was completed except for one of the side streets. He explained that Board authorization would allow his staff to sign off on the completed portion of the project and open the road to traffic.

County Engineer Webb located the Las Verdes community at the intersection of Linton Boulevard and Military Trail. He introduced the standard warrant sheet used as part of the analysis done when the traffic information for the area was compiled. He outlined the findings as follows:

- C The two exits from the Las Verdes community were on Linton Boulevard and Military Trail. There was a signal at the Linton Boulevard exit and a flasher at the exit on Military Trail. The request was to convert the flasher at Military Trail to a traffic signal.
- C The standard for major street traffic of 900 vehicles per hour for each of eight different hours had been met on Military Trail.
- C The standard for minor street traffic of 100 vehicles per hour for each of eight different hours had not been met for any single hour on Las Verdes Drive.
- C Two accidents without injuries occurred from August 31, 1998, to July 31, 1999, the period when the traffic study was conducted. A fatality occurred at the

location in December 1999.

- C In comparing traffic studies from 1997 to 1999, data showed that the County had denied traffic lights at 105 locations around the County because they did not meet the criteria.
- C The Las Verdes traffic signal study ranked in the low eighties compared to the other intersections in the study.

### REGULAR AGENDA - CONTINUED

### 7.D.3. - CONTINUED

Commissioner Aaronson said extenuating circumstances had to be taken into consideration. He pointed out that:

- C The count onto Military Trail was low because residents of the Las Verdes community were afraid to enter Military Trail and thus entered onto Linton Boulevard.
- C The Linton Boulevard entrance to the Los Verdes community was located directly opposite the entrance to the Delray Community Hospital. The additional traffic caused by residents fearful of entering Military Trail, along with the traffic on Military Trail itself, often made it difficult for emergency vehicles to reach the hospital entrance quickly.
- C If a traffic light was installed on Military Trail, the flow of traffic would be alleviated on Linton Boulevard and the count would be higher.

Commissioner Newell asked Mr. Webb to update the forms used to report studies so as to make them easier to read. He questioned the limited crossovers being built in his district at Military Trail, Congress Avenue, and Boynton Beach Boulevard.

Mr. Webb explained that those roadways were property of the state, which adopted strict access guidelines. He said the County had not adopted similarly strict rebuild standards.

In response to Commissioner Masilotti's inquiry, Mr. Webb said although Orange Boulevard and Coconut Boulevard were heavily traveled roads, the standard was not met to warrant traffic signals because of how the traffic flow varied during morning and evening rush hours on those roads. Commissioner Masilotti stated that the standards throughout the County needed to be reviewed and right turns should be included.

Assistant County Attorney Marlene R. Everitt pointed out that the Florida Statutes state that the Commissioners control County roads and may install traffic lights which conform with the Uniform Manual on Traffic Control Devices. She said there was some leeway in what the Board can do to amend County standards, but staff may not be able to advise REGULAR/WORKSHOP 33 FEBRUARY 29, 2000

concerning that leeway on every issue, although some judgment could be exercised.

Commissioner Marcus recommended a restudy of the standards and examination of such considerations as peak-hour situations, fully activated signals during rush hours only, and level-of-service activity in order to provide the Board some insight into the sorts of exceptions that might reasonably be allowed.

Commissioner Roberts pointed out that extenuating circumstances existed in her district in the vicinity of Roebuck Road and Haverhill Boulevard. She suggested that area be used as a test because it meets the criteria which warrant traffic signals.

### 7.D.3. - CONTINUED

County Engineer Webb concurred with Commissioner McCarty that a traffic light does not necessarily reduce the severity or number of accidents, but only changes the type. Commissioner McCarty said she thought state standards protected the County from liability. If the County approved installation of a signal that did not meet the state standards, and if there was later an accident at that intersection, she asked, would the County be exposed to liability as a result of not observing the state standards. Staff responded that there would be exposure. Commissioner McCarty then suggested that strict parameters be set on the circumstances that would permit the standards to be changed.

Commissioner Aaronson maintained his position that a light was needed at this location because of the two fatalities that had occurred there.

MOTION to install a traffic signal at Las Verdes on Military Trail. Motion by Commissioner Aaronson and seconded by Commissioner McCarty.

The Board suggested that staff research the following issues:

- C Deviation from the guidelines to allow traffic signals or flashers at locations where the state warrants did not support them.
- C Consideration of exceptions such as the location of schools and hospitals, as well as levels of service and right turns, and fully activated signals versus flashers during certain hours as these might allow departures from state standards.

SUBSTITUTE MOTION to POSTPONE the item until the March 21, 2000, meeting, and draft a policy for signal warrant standards with input from the Board. Motion by Commissioner Marcus and seconded by Commissioner Newell.

Commissioner Masilotti asked staff to retrieve information on the amount paid in liability settlements within the past 10 years because of traffic signals the County installed. Commissioner McCarty concurred. Mr. Webb explained that most of the signals installed within the past 10 years met the warrants. Mr. Masilotti also requested information on litigation against the County for not having installed signals at intersections considered dangerous but unwarranted.

Mr. Webb remarked that almost all the signals the County had installed during the 10-year period in question had met the warrants.

County Administrator Weisman informed the Board that the County had lost lawsuits because it did not have projects

designed and installed according to the state standards.

In response to Commissioner Newell, Mr. Webb offered to investigate whether signals were installed for schools which had not met the requirement for number of trips. He informed the Board that the signals were timed with the schools' schedules and operated only at peak hours.

UPON CALL FOR A VOTE, the motion carried 4-3. Commissioners Aaronson, McCarty, and Roberts opposed.

### 5. ADMINISTRATION

PALM BEACH COMMUNITY COLLEGE PRESENTATION. DISCUSSED 2-29-2000

Dennis Gallon, president of Palm Beach Community College, commented on how large and diverse the community was. He commended the Board for the superb job it had been doing in addressing the needs of a complex community. He also thanked County Administrator Weisman for the invitation to address the Board. Dr. Gallon thanked Commissioner McCarty for her involvement as the Governor's appointee to the committee nominating candidates for the college's Board of Trustees. He then commented on activities at the college over the past two years as follows:

- C Although the comprehensive mission of the college was being expanded to include workforce preparation, management was not in the process of converting to a technical institution.
- The Associate in Arts degree prepared the student to make a successful transition to the baccalaureate program in universities in the state and throughout the country. That degree would always be the college's core mission. The college is ranked by an independent source as the thirteenth greatest producer of the Associate in Arts degree of over 1,200 two-year institutions in the country. The current difficulty in finding money to establish community colleges makes it important to identify and focus on the core mission.
- C Management wanted to create an institution with students as the main focus of all the programs. The college should have a compelling and a future-oriented "roadmap" to guide its institutional decisions.
- C The strategic plan was developed by gathering information from all levels of students, the Board of Trustees, and the community by means of forums. A mission statement was developed and a five-year plan was put in place.
- C The college is trying to develop partnerships with both private and other public institutions in the community. The relationship experienced with those institutions was successful and encouraging.
- C The Early Learning Center at the Eissey Campus originated as a facility to house the children of students. Recently, the decision was made to open the facility to children up to five years of age who require access to quality childcare. The college was asked to train individuals to work in childcare

centers, which was being done aggressively. Last year the Legislative Delegation successfully lobbied for \$250,000 that now provides for the development of a institute within the childcare center.

C Research links were being created with Florida State University and the University of North Carolina to study the needs of children at early stages of development, and to create a national rating scale for daycare centers.

#### 5. - CONTINUED

- C The college, in partnership with Communities in the Schools, the Simon Foundation, and the School Board, would be creating a retail academy at the Palm Beach Mall. This project would attempt to give students experience in the retailing industry.
- C A public leadership institute to train individuals with interests in politics would open in June 2000.
- The Glades Initiative was developed to ensure that residents of the Glades were taking full advantage of all of the resources of the college. Conversations had been held over the past year with individuals throughout the County to identify barriers. The college began steps that would make a positive difference in that community. A partnership council consisting of Glades residents had been created. As a result, some new programs had been implemented to meet the needs of the students and to make them employable within a short period.
- C The college employed a former student of Glades Central High School to recruit prospective students from that area to the college. A group of professional football players from the Glades had lectured to students about the importance of an education.
- C The Workforce Program needed to be pursued more aggressively. Although the college already offered numerous programs, it was inquiring about the needs of customers and providing customer service training.
- C Dr. Gallon requested the Board's support for the continuing three-year transition that is moving some 45 post-secondary adult vocational programs from the school system to the college. There was difficulty in obtaining support in the legislature last year and problems are anticipated again this year.
- C The governor and other elected officials agreed that workforce preparation was essential if the state was to be economically viable. At the same time, they were

saying that the initiative was cost neutral. It was difficult to teach some of the transition programs in the current facility. A facility was needed to house those programs if the college was to continue to provide workforce training superior to the other community colleges within the state. Dr. Gallon requested the Board's support in the lobbying effort.

Commissioner Newell commented that the tuition was now at \$46 per credit instead of the \$16 he paid when he studied there. He praised Dr. Gallon for the work he was doing and invited him to make a yearly report to the Board. He suggested Dr. Gallon join in the grant pool for landscaping on Lake Worth Road and Congress Avenue. He also inquired about Panther Park. College staff had been working on the landscaping issue, Dr. Gallon replied, but some concern about possible liability had developed. He also indicated that the occupancy rate for Panther Park had remained the same as last reported but that students were being recruited as tenants.

(CLERK'S NOTE: Commissioner Aaronson rejoined the meeting.)

#### 5. - CONTINUED

Commissioner McCarty said she was pleased that the outcome of the listening sessions, of which she was a part, had been included in the strategic plan. She praised State Representative Lois Frankel for spearheading the early childhood initiative and drawing attention to it on the national level. Dr. Gallon noted that Representative Frankel had been instrumental in helping the college obtain the \$250,000 grant.

Commissioner McCarty also expressed her concern over the state's reduced participation in funding educational programs for the disabled. In support of one of the college's legislative priorities, she said one of the basic responsibilities of government was to make sure funding was in place to educate disabled adults to be self supporting. Dr. Gallon concurred that funding for these programs had become difficult. Dollars were no longer allocated according to enrollment but, rather, according to performance. Fully 85 percent of the college's funding for disabled students was based on successful completion of the program and placement in a job. Unfortunately, Dr. Gallon said, disabled students were the population whose placement in the workforce was the most problematic. He agreed with Commissioner McCarty that a separate standard was necessary for determining the success of disabled students.

Commissioner Roberts asked if an offender workforce program similar to Pinellas County's was offered at the college. She explained that the program paid for two years of higher education for young offenders. She emphasized the importance of following up on Department of Education grants. She sought a process that could be used to go directly to the federal government to obtain grant monies and suggested that the college consult the County's grants advisor, Michael Langton. Dr. Gallon agreed to have his staff look into the offender workforce program. He also reported that the college had a grants writer on staff.

Commissioner Masilotti thanked Dr. Gallon for the renewed interest in the Glades campus. He expressed concern about the low priority given to athletic and educational programs for the disabled. He said the Healthcare District had been working to get the state to allow the County Healthcare Taxing Authority to apply directly for Medicaid matching funds. He encouraged Dr. Gallon to support the issue because his students also were eligible to receive those funds. He asked Dr. Gallon to meet with him to discuss the issue further. Dr. Gallon agreed that funding for programs to serve the disabled was difficult to obtain, noting that the legislature did not typically consider the disabled as viable participants in the workforce.

Commissioner Aaronson thanked Dr. Gallon for the college's program on film education and for the film awards program.

He suggested inviting representatives of the film industry  $% \left( 1\right) =\left( 1\right) +\left( 1\right)$ to talk with the students in the Glades area because that too was a high-paying field.

No backup provided.

#### 7.E. PALM TRAN

STAFF RECOMMENDATIONS FOR CONCEPTUAL MODIFICATIONS TO THE SPECTRAN PROGRAM AS FOLLOWS: (1) PALM TRAN OR A PARA-TRANSIT MANAGEMENT FIRM TO PROVIDE ALL OVERSIGHT OF THE SERVICE, INCLUDING ELIGIBILITY CERTIFICATION, QUALITY ASSURANCE, PERFORMANCE MONITORING AND INVOICE VERIFICATION; (2) TRANSPORTATION CARRIERS TO DIRECTLY ACCEPT RESERVATIONS, SCHEDULE TRIPS, AND PROVIDE SERVICE; (3) NUMBER OF TRANSPORTATION CARRIERS TO INCREASE TO BETWEEN FOUR AND SIX CARRIERS WHO MUST BE IN FULL COMPLIANCE WITH THEIR CONTRACTS, AND ADDITIONAL CARRIERS TO BE SELECTED THROUGH AN EMERGENCY PROCUREMENT PROCESS; (4) ALL RIDERS TO HAVE THE OPPORTUNITY TO CHOOSE THEIR TRANSPORTATION CARRIERS, WITH THE ABILITY TO CHANGE CARRIERS EVERY 30 DAYS; AND (5) PROVIDER CONTRACTS TO BE PAID ON A PER-TRIP BASIS. APPROVED A MODIFIED BROWARD MODEL 2-29-2000

Perry Maull, executive director of Palm Tran, introduced Broward County Para-Transit Services Manager Edward Wisnewski.

(CLERK'S NOTE:: Commissioner McCarty left the meeting.)

Mr. Maull informed the Board that:

- C Staff had prepared six options and had reviewed those options at two Palm Tran Accessibility Advisory Board (PTAAB) meetings.
- C Staff was recommending a modified Broward model, the chief feature of which was that users had a choice of providers.
- C Staff was in the process of determining the cost of the program and believed that staffing costs would be within the existing budget. The per-trip cost, which included the Medicaid cost of \$13.50, should also be within the existing budget.
- C Start-up costs for the computer system, both software and hardware, were still being determined.

In response to Commissioner Aaronson, Mr. Maull said a modified Broward model was staff's strongest recommendation. Commissioners Aaronson and Masilotti agreed that, although they were willing to listen to the public's comments, they would support staff's recommendation without hesitation. They commented that the public had been requesting a copy of the Broward program at previous meetings and by telephone calls to their offices.

MOTION to approve staff's recommendation of a modified Broward model. Motion by Commissioner Aaronson and seconded by Commissioner Masilotti.

Commissioner Masilotti asked about Broward County safeguards REGULAR/WORKSHOP 43 FEBRUARY 29, 2000

to eliminate fraud or poor service to users.

Mr. Wisnewski said:

C Broward reconstructed a system from scratch after studying systems nationally for nearly six months.

- The concept of riders' choice, lacking in previous systems, was the change that was having the greatest impact, along with changing from payment by the hour to payment by the trip. The latter change was causing contractors to compete on quality of service because their income was tied to the number of trips, which was in turn dependent on user satisfaction.
- C The transit agency should control all aspects of the system, including the computer hardware, the software, and the client database. Furthermore, the agency should provide a strict definition to the contractors of which trips were eligible for reimbursement and which were not.
- C Broward had a staff of seven, of whom two were contract managers.

Commissioner Masilotti stated that competition would increase the quality of service. He inquired as to the amount of time staff needed to set up the program.

Assistant County Administrator Vince Bonvento said staff decided at an earlier meeting that about six months would be enough time to have a system in place. He said staff believed that this program would enhance the quality of service in this County. He also stated that staff would continue to monitor compliance requirements under the new system.

County Administrator Weisman pointed out that Palm Beach County's size would make trip length an issue to consider. He said Broward County had not addressed that issue because of its smaller physical size.

In response to the Commissioners, staff said:

- C More carriers would be added and payments would be made on a per-trip basis.
- C Contract managers would be out in the field monitoring the service, and the system safety plan would remain in effect.
- C Providers would be dropped if they were not in compliance with the contract. Whenever a safety violation was discovered, the vehicle would be taken out of service. Once the new format was implemented, providers would be required to comply with Americans with Disabilities Act requirements. It would be the vendors' responsibility to deliver quality service.
- C Safety would be immediately addressed through the

liquidated damages clause, under which a vender could be assessed for damages; or through the default clause, under which a vendor could be terminated. Staff would review the liquidated damages clause in an attempt to strengthen it by allowing the immediate assessment of damages for substandard service and, if such substandard service continued, by allowing termination through default after a specified number of instances.

C Taxicabs would not be excluded from the new provisions.

C Broward disbursed trips by ZIP Code among four providers, giving the riders and vendors 90 days to get established. At the end of the 90 days, the riders could begin exercising their option to change providers every 30 days.

# PUBLIC COMMENTS:

Genevieve Cousminer, chair of the Palm Tran Accessibility Advisory Board (PTAAB) reported on the breakdown of the votes of the subcommittee meeting on February 17 regarding the para-transit options. She said of the committee's eight members, five supported elimination of the para-transit management company and three opposed. She said the members of the public present at the meeting unanimously favored the Broward model.

Richard Broderick, David Evans, a member of PTAAB and the Metropolitan Planning Organization Transportation Disadvantaged Coordinating Board (MPO-POTDCB), Mike Nagelberg, Bobby Valentine, Stanley Voice, and Sandy White, a member of PTAAB and the MPO-POTDCB, added their comments as follows;

- C The Broward system had many merits. Authority in SpecTran was diffuse and poorly defined.
- C Six months was too long a time for the County to put the Broward system into service. It should be done in three months. In the meantime, the Board had failed to hire either a contract manager or an accountant to audit the operations of SpecTran as it had earlier agreed to do.
- C The public should have input in future decisions.
- C The people who have been riding the longest should have choice as to the provider.
- C The three main providers were doing excellent jobs and should be allowed to continue.

C The County, not some private entity, should be the entity that determines a rider's eligibility for service.

Ann Buckman said she was in support of the Broward system. She stated that she was forced to pay about \$56 in cab fare for rides to her dentist even though she had earlier bought a rider's ticket. She complained of being left stranded on January 20 after her dental visit. She asked for her \$20 ticket fee to be reimbursed.

Commissioner Masilotti asked staff to meet with Ms. Buckman in an attempt to resolve the issue.

UPON CALL FOR A VOTE, the motion carried 6-0. Commissioner McCarty absent.

### **RECESS**

At 12:25 p.m., the Chair declared a recess.

#### RECONVENE

At 2:02 p.m., the Board reconvened with Commissioners Lee, McCarty, Marcus, Masilotti, Newell, and Roberts present.

MOTION to adopt the ordinance pertaining to burglar alarms. Motion by Commissioner Marcus and seconded by Commissioner Newell.

### PUBLIC COMMENT:

# Gary Brandenburg stated that:

- C The alarm industry had been working with Sheriff's Office staff and had reached agreement that the implementation date of the ordinance should be June 1, 2000, as opposed to the date of adoption.
- C The delayed implementation date would allow the alarm companies time to notify the 80,000 customers of contract changes.

REGULAR/WORKSHOP 47 FEBRUARY 29, 2000

(CLERK'S NOTE: Commissioner Aaronson joined the meeting.)

Patrick Kenney, the Sheriff's Office representative, stated that the June 1, 2000, commencement date would allow Sheriff's Office staff to perform a more accurate six-month review since many false alarms happened during holiday seasons.

AMENDED MOTION to include an implementation date of June 1, 2000. The maker and seconder agreed.

Mr. Kenney explained that the review period would extend from June 1, 2000, through January 1, 2001.

Mr. Brandenburg said the industry would work with the Sheriff's Office during the review period in an attempt to monitor other factors previously brought out.

Assistant County Attorney Dawn Wynn requested the Board receive and file an e-mail sent by Joseph Lawrence. Commissioner Masilotti said the e-mail had suggested a sixmonth review which had already been addressed.

UPON CALL FOR A VOTE, the motion carried 7-0. MOTION to receive and file the e-mail from Mr. Lawrence. Motion by Commissioner McCarty, seconded by Commissioner Roberts, and carried 7-0.

### RECESS

At 2:09 p.m., the Chair declared a recess.

### RECONVENE

At 2:29 p.m., the Board reconvened with Commissioners Aaronson, Lee, McCarty, Marcus, Masilotti, and Newell present.

#### 2.C. UNSCHEDULED ITEMS

#### 2.C.1.

APPOINTMENT OF COMMISSIONER ROBERTS TO THE CANVASSING BOARD. APPROVED 2-29-2000

Commissioner Lee stated that Supervisor of Elections Theresa LePore had requested the appointment of a Commissioner to the Canvassing Board and said Commissioner Roberts had agreed to serve.

MOTION to appoint Commissioner Roberts to the Canvassing Board. Motion by Commissioner Masilotti, seconded by Commissioner Marcus, and carried 6-0. Commissioner Roberts absent.

### 2.C.2.

DISCUSSION OF THE LOCAL BILLS FOR THE LEGISLATIVE SESSION IN TALLAHASSEE. DISCUSSED 2-29-2000

Commissioner Marcus pointed out that there had been no analysis of the local bills filed for the current legislative session. She said it would be helpful to have a synopsis of the bills before the Board traveled to Tallahassee.

(CLERK'S NOTE: Commissioner Roberts joined the meeting.)

Commissioner Marcus outlined concerns relating to issues with the Children's Services Council, drainage district changes, the Health Care District, and the Criminal Justice Commission. She said the Board needed to develop a way to better share information and to get analysis of filed local bills. The Florida Association of Counties could not perform these functions, Commissioner Marcus observed. She suggested the Board consider restructuring the Legislative Delegation office after this session, but she insisted that the Board needed immediate information and that someone needed to be in charge.

Commissioner McCarty inquired if it was not the job of the director of the Legislative Delegation office to send the Board, in two pages or less, the local bills and what the delegates were proposing.

Commissioner Masilotti also expressed concern over not knowing about the daily occurrences in Tallahassee. In response to Commissioner Masilotti's inquiry, staff pointed out that a budgeted amount not to exceed \$60,000 had been allocated to the lobbyist to contract with other firms if help was needed. Staff said the lobbyist had recently

expressed the need for help but had not followed through with hiring someone. Commissioner Masilotti asked if a portion of those monies could be used to hire local help who would track the bills and give the Board weekly updates.

County Administrator Weisman said staff had requested that the lobbyist prepare a written explanation for the Commissioners before they arrive in Tallahassee.

# UNSCHEDULED ITEMS - CONTINUED

### 2.C.2. - CONTINUED

Commissioner Roberts stated that Denise Coté was the County's coordinator and that information should be going to her for dissemination to the Board. Commissioner Roberts also reported that a statewide moving bill was being lobbied. She said the bill had support in both the House and Senate. She sought the Board's approval to add it to the County's priority list. Commissioner McCarty suggested the moving bill be added to the support list.

Commissioner Aaronson commented on the \$60,000 being used for bookkeeping as opposed to using it for lobbying efforts. He said he refused to use money slated for lobbying efforts to pay for clerical work instead.

Commissioner McCarty pointed out that it was the job of the delegation office's director, not Denise Coté or Kathleen Daley Montoya, to report to the County through Ms. Coté's office.

APPROVED:

Commissioner Aaronson said communication between the lobbyist in Tallahassee and County staff needed to be improved.
