## WORKSHOP SESSION

## 3. - 9:30 A.M.

MANAGED GROWTH TIER SYSTEM (MGTS) ISSUE PAPER: POINT/MERIT SYSTEM. DISCUSSED WITH DIRECTION 7-17-2001

Zoning Director William C. Whiteford introduced consultants Lane Kendig of Lane Kendig, Inc., and James Duncan and Marty Hodgkins of Duncan Associates, Inc.

<u>Lane Kendig</u> presented an issue paper outlining the point/merit system in other jurisdictions, administration and implementation of various point systems, and recommendations for a point system in the county.

Commissioners Aaronson and Masilotti contended the point system was not viable for the county. Commissioner Aaronson recommended the implementation of the point system within the Agricultural Reserve on a trial basis, however.

Commissioners Masilotti and Newell identified the need for more stringent guidelines to create quality development in the county and for a system that would ensure that the developments that get approved are the best as opposed to acceptance of the first application put forward for approval.

Commissioner Aaronson said that traffic performance standards in the county are too high. He did not believe a conclusion could be made, he said, until after the Traffic Performance Standards Committee had made its recommendations. After this foundation was in place, planning and development recommendations could be established.

Commissioner Newell proposed that the board commit to more community plans and regions instead of a point system. He asked staff to make recommendations to raise development and traffic standards. Staff responded that a meeting to present these reports would be held in approximately six to eight months.

## 4. - 11:30 A.M.

WEST PALM BEACH CITY HALL. DISCUSSED WITH DIRECTION 7-17-2001

West Palm Beach Mayor Joel Daves introduced Planning Director Dan Cary.

<u>Dan Cary</u> made a presentation for the construction of a new city hall. The site identified for development of the new city hall was owned by the county and located four blocks west of the old city hall. The city was ready to begin negotiations for acquisition of the property, he said, along with the 167-space parking lot, which was also owned by the county.

Commissioner Masilotti said he supported the plan for a new city hall but objected to its development on county property. Private property should be acquired for this venture, he said.

Commissioner Aaronson expressed support of the plan, provided the county received fair economic value for its properties.

Commissioner Newell recommended that Mr. Cary take into consideration the parallel space along Quadrille Boulevard that would be lost as part of the negotiations. He asked staff to begin working with Mr. Cary on the appraisals and cost analysis with all due diligence.

Commissioner Greene was assigned by the board as lead negotiator on this venture.

## 5. - 2:00 P.M.

#### JAIL POPULATION FORECAST. DISCUSSED WITH DIRECTION 7-17-2001

L. Diana Cunningham, executive director of the Criminal Justice Commission (CJC), introduced Richard G. Lubin, CJC chair; Darlene Halstedt, major in the Sheriff's Office; William Bales, director of the Bureau of Research and Data Analysis, Florida Department of Corrections; and Kristina Gulick of the CJC.

Kristina Gulick reviewed the 1986 jail population forecast of Justice Systems, Inc., and highlighted its accuracy throughout the years.

<u>William Bales</u> presented a long-term forecast/model for jail population in the county. Commissioner Aaronson questioned whether the forecast allowed for adjustment during an economic downturn. Dr. Bales responded that economic adjustment was not a part of the model.

Ms. Cunningham stated that the CJC was working closely with the National Crime Mapping Center in Denver to establish a law enforcement training center in conjunction with Florida Atlantic University.

Commissioner Newell requested an updated budget for the Criminal Justice Information System.

Commissioner Newell noted that some CJC recommendations were possibly controversial, particularly the creation of a community corrections department.

On behalf of the board and the CJC, Commissioner Newell presented a token of appreciation to Dr. Bales for his exceptional assistance.
