3. 9:30 A.M. - REDISTRICTING. DISCUSSED WITH DIRECTION 9-25-2001

Assistant County Administrator Verdenia C. Baker introduced Patricia Schapley, associate director of the Joint Center for Environmental & Urban Problems, and David Buffington, chief legal counsel for Reapportionment Group 2000.

Ms. Baker noted that on April 17, 2001, the board approved a contract with the Joint Center to prepare commission district boundary maps based on the 2000 census and other criteria approved by the board at that time and with Reapportionment Group 2000 for outside legal review.

Staff was seeking direction in order to hold a preliminary reading of an ordinance to adopt a version of the map on October 16 and to advertise a final public hearing November 6, 2001.

Commissioner Masilotti asked if minor modifications could be made before the first hearing.

3. 9:30 A.M. - CONTINUED

Assistant County Attorney Berger said modifications could be made before the first reading and that the board was not bound by any decision that it might make at the workshop meeting.

Mr. Buffington noted that the criteria adopted by the board for redistricting generally matched up with principles of law.

Criteria included:

- Achieving population equity among districts;
- Adhering to Section 2 of the Voting Rights Act to create or maintain districts reflecting minority voting;
- Following natural and manmade boundaries;
- Maintaining integrity of communities of interest;
- Ensuring compact and contiguous districts; and
- Preserving the core of existing districts.

Population equity among districts has implications for the one-person, one-vote principle which is always the highest priority in drawing districts, Mr. Buffington said.

Ideal population for a district is determined by dividing the total population of a county by the number of districts to be drawn so that they will be equal or nearly equal. Any deviation below 10 percent is constitutional, he said.

Commissioner Roberts said that she favored a standard of plus or minus one percent.

Commissioner Aaronson asked if high growth trends in certain areas of the county could be considered in drawing the boundaries. Mr. Buffington said law requires using existing census data.

Commissioner Masilotti noted that with population growth in his district in the year and a half since the census, the numbers were already skewered.

The county originally went to districts to comply with Section 2 of the Voting Rights Act and created a "majority minority" district in District 7, Mr. Buffington observed.

He said the problem in trying to maintain demographic character is that District 7 is 53 percent African-American, but "grossly underpopulated" compared to the population growth of the county as a whole and the relatively smaller growth of African-American population in the county (14 percent of the population, up from 12.5 percent in 1990).

The challenge was to raise District 7 to an acceptable population level, while maintaining its racial character, he said. The Joint Center designed two options, both of which kept District 7 with a 51 percent African-American population.

Because the Hispanic population had increased so dramatically in the county (12.5 percent of the population, up from 7.7 percent in 1990), the center looked at the possibility of creating a Hispanic district, but found the Hispanic population too dispersed over the county, Mr. Buffington reported.

The county is so large that the priority to follow natural, manmade, and municipal boundaries would be reflected in any proposed plan, he observed.

Ensuring compact and contiguous districts is a traditional districting criterion, subordinate to one-person, one-vote considerations and to Section 2 considerations, Mr. Buffington stated.

Preserving the core of existing districts translates to avoiding placing incumbents in the same district, he said.

The Supreme Court has recognized that districting is essentially a political process, Mr. Buffington disclosed. Once all the legalities have been observed, it is the political process that determines where district lines are going to be drawn, he noted.

Because of the number of census blocks and the large population in the county, a large number of districting plans could be drawn that complied with the law, he said.

Commissioner Newell noted that the law allows redistricting every other year and if certain districts in the county grow as expected, the board could redistrict that frequently.

The ultimate challenge to a redistricting plan lies in a court challenge to it, Mr. Buffington said.

Ms. Schapley presented a slide program of proposed districts. She noted that the maps grew out of 2000 census data and census blocks, elections data, precinct and municipal boundaries, interviews with commissioners, drawing, reviewing, and refining.

In a proposed districting map, districts would see population changes as follows: District 1, 157,600 from 160,000; District 2, 163,600 from 154,352; District 3, 166,000 from 180,456; District 4, 160,000 from 152,000; District 5, 167,000 from 175,000; District 6, 159,000 from 175,473; and District 7, 158,000 from 130,000.

Commissioners Newell, Masilotti, and Aaronson were particularly concerned about future growth patterns in the county and commissioners generally wanted more time to consider the expansion of District 7 while maintaining its racial integrity.

Commissioner Aaronson said he was concerned about having no municipalities in his newly drawn district.

Ms. Baker said she could develop another redistricting map, highlighting commissioners' specific areas of concern.

Commissioner Newell asked staff for further information on projected future growth patterns in the county over the next 10 years.

3. 9:30 A.M. - CONTINUED

Commissioner Roberts suggested the redistricting matter be put back on the commission agenda for October 16 for further discussion, and the board concurred.

Commissioner Aaronson said he regretted that the Sunshine Law did not allow commissioners to discuss redistricting matters with each other outside of commission meetings.

PUBLIC COMMENT:

<u>Mami Kisner</u> told the board that she was proud that the commission was finally showing diversity and expressed the hope that it would continue in the redistricting process. Voters like to see the commission reflect the diversity of the community, she said.

RECESS

At 11:50 a.m., the chair declared a recess.

RECONVENE

- At 2:05 p.m., the board reconvened with Commissioners Aaronson, Greene, Masilotti, McCarty, Newell, and Roberts present. Commissioner Marcus absent.
- 4. 2:00 P.M. TOURIST DEVELOPMENT COUNCIL PRESENTATION. DISCUSSED WITH DIRECTION 9-25-2001

J. Charles Lehmann, executive director of the Tourist Development Council (TDC), and representatives of the various agencies of the Tourist Development Council hosted a slide presentation for the board to review the council's variety of activities.

County tourism statistics presented showed that:

- The number of hotel guests in the county was up 77 percent in the last seven years. A total of 46 percent come for vacations and pleasure and 48 percent for conferences, conventions, or business.
- Of the total 2,152,682 hotel guests in the county during 1999-2000, 1,932,933 originated in the United States and 219,749 from outside the country.
- Most popular visitor activities were going to restaurants, fishing and water activities, shopping, going to bars and nightclubs, golf and tennis, sporting events and competitions, and performing arts and cultural activities.
- Daily room rate averages climbed from \$76 to \$118 over the past 10 years. The county gross bed tax showed collections peaking at about \$2.5 million a month during winter months, with February consistently highest over the past five winter seasons.

Among TDC agencies and programs:

- The Film and Television Commission has increased tourism dollars by upping both permit fees to access government property and hotel room nights. Production revenue in the past 12 months has climbed to almost \$120 million, and Mr. Lehmann called film and television production an important economic driver in the county. Ocean Studios, one of the original grantees in the film incentive program, is doing very well, he said. <u>Heartbreakers</u>, filmed mostly at the Breakers Hotel, was the largest film completed here recently, he noted.
- The Shoreline Protection Program replenishes sand on beaches and underwrites reef construction. Of the 33 percent county share of funding for coastal projects, 77 percent comes from the bed tax. Among recent shoreline projects are the South Boca Raton, Jupiter/Carlin and Delray Beach Renourishment projects, the Jupiter Enhancement Reef, and the Juno Mitigation Reef.
- The Sports Commission is contracted by the county to stimulate bed tax revenues, primarily in off-season, and to enhance the economic impact of sports. The commission has hosted the Maccabi Games, Unified Youth Sports Festival, Florida Fire Fighters Games, and the Sunshine State Games and is anticipating involvement in the 2002 Sunshine State Games, U.S.A. Baseball Headquarters relocation, Pan American Junior Water Polo championship, U.S. Field Hockey National Championship, Junior World Cup Inline Hockey Tournament, 2004 Florida Fire Fighters Olympics, and the U.S.A. Canoe/Kayak Federation relocation. It has been encouraging needed facilities in the county, including the Convention Center, the proposed Don King Arena, and South Florida Fairgrounds Expansion. Its Sports Institute hosts Unified Youth Sports Festival, Sports Achievement Awards, Year-Round Clinics, and the Lou Groza Award.
- The Convention and Visitors Bureau (CVB) is the TDC's largest agency, with a 2001 budget of \$8,830,000 and a staff of 45. It seeks to increase tourism in the county. Much of the county's tourism literature is done in-house, and the CVB maintains a web site, which includes the convention center.

Construction of the Convention Center is on schedule, with vertical construction to begin in December, Mr. Lehmann said. The center's banquet facilities will seat over 2,000 people and will also be used for exhibit space, he reported. A membership program for the convention center has generated over \$200,000, he disclosed.

Commissioner Newell asked that the TDC inquire as to the status of the new Don King Arena.

Commissioner Masilotti asked if the TDC was aware that the National Fisheries Council had voted to close reefs in the county to recreational fishing. He said the impact on tourism could be tremendous. He suggested joining with the county attorney's office in filing appeals. Commissioner Newell asked County Administrator Weisman to have staff look into the matter. Commissioner Aaronson said that he could not understand why TDC was unaware of the development.

Commissioner Newell reported that other counties around the Lake Okeechobee area had asked him to approach TDC for help in promoting the lake for tourism.

4. 2:00 P.M. - CONTINUED

Commissioner Aaronson noted that Lake Okeechobee would be great for fishing tournaments, but that there was a need for a hotel in that area.

Commissioner Newell asked about concerns about the reduction of tourism income in the aftermath of the September 11 terrorism.

Mr. Lehmann called concerns "extreme," with the terrorism issue and a falling economy. He conceded that no one knew when the public would be willing to travel by commercial airline and that represented 60 percent of the county's travel business. While 80 percent of flights were ongoing at the airport, they were carrying a smaller number of passengers, he said.

Mr. Lehmann revealed that many corporate groups are rebooking hotels for later dates. He said the real concern was with leisure travelers this winter. Most travelers to the county are of a certain age and extremely safety-conscious, he noted.

Commissioner Aaronson reported that the matter was discussed at the last TDC meeting. TDC agencies were asked to find additional dollars in their budgets to allow CVB to do more advertising for tourism.

Commissioner McCarty said she was a little leery of "re-dividing the pie" and suggested CVB examine its own budget first.

Commissioner Masilotti asked which tourist market was the most profitable for the county.

Warren ("Mac") McLaughlin, president of the CVB, replied that it was the northeastern United States. He said the CVB was investigating co-op advertising with airlines as well as joint programs with Amtrak, bus companies, and car rental agencies to accommodate people who are afraid to fly. He said for the short term, CVB was focusing its advertising in newspapers in the Northeast and Midwest.

Commissioner Masilotti said he traveled to Detroit, Chicago, and Milwaukee and that the county did no advertising there compared to the northeastern corridor.

Mr. McLaughlin noted that tourism overall was expected to be minimized for awhile. Since New York area residents were very emotional due to the terrorism, CVB was focusing its advertising in other areas, including Detroit and Chicago, he said.

Commissioner McCarty suggested using the half-million dollars that were expected to be donated by county employees to the Disaster Relief Fund to underwrite vacations to Palm Beach County for those affected by the tragedy. The money would go to the hotels and be reinvested in the county, she speculated.

Commissioner Aaronson said the money was insufficient for that and questioned the wisdom of deciding who could make such a trip and who could not.

Commissioner Greene observed that every time tourists come to the county, residents begin to ask when are they going to go home. She said that in the light of the national tragedy, there was more concern with the county's economy than giving people time to heal.

4. 2:00 P.M. - CONTINUED

Mr. McLaughlin conceded that tourists contribute to crowded roads, but that their purchases of gasoline generated taxes to build roads and their purchases in restaurants generated sales taxes that support state government. The county would not have as many facilities and restaurants if it were not for tourists and seasonal residents, he noted.

Commissioner Masilotti observed that it is the job of the county to promote tourism because it is an issue of employment.

Speaking as chair of the TDC, Commissioner Aaronson said it would continue to try to bring tourism to the county and still be sensitive to what has happened.

Mr. McLaughlin told the commission that there have been 11 firm commitments for bookings at the Convention Center, representing over 40,000 room nights, and another 26 pending, with the bookings starting in July of 2003.

Commissioner Roberts asked about the status of the hotel being built next to the Convention Center.

Mr. McLaughlin said it was a 400-room hotel, still on schedule, and the Sheraton and Hilton nearby are also expected to be adding rooms.

Responding to a question by Commissioner Masilotti, Mr. McLaughlin noted that the TDC was in the process of promoting the far-western county as "the Lake region" and was communicating with officials in other counties to promote tourism in that area.

The chair declared the meeting adjourned at 3:45 p.m.
