COMMISSIONER NEWELL'S FINAL REMARKS AS CHAIR. DISCUSSED 11-19-2002

Commissioner Newell relayed accomplishments from the last two years, of which he was very proud:

- He served on the governor's task force for election reform;
- The tragic time of 9/11 showed how strong the county was;
- The board made the right decision with the right company for changes in election equipment;
- Bond issues were passed for parks, culture, and libraries;
- Over 30,000 gun locks were provided to gun owners;
- The board fought hard for installation of sewer lines at Peanut Island;

COMMENTS FROM COMMISSIONERS - CONTINUED

4.A. - CONTINUED

- Restoration and cleanup of the Lake Worth Lagoon project was ongoing;
- Reduction in drowning deaths was attributed to the Drowning Coalition of Palm Beach County;
- Waterway access for boaters was improved;
- Hundreds of projects had been funded through the Recreation Assistance Program;
- The Artificial Reef Committee acquired boats that were confiscated from drug runners and sunk offshore to be used as reefs;
- The Marine Academy Program at Palm Beach Lakes High School provided training for students, who intend to work in the marine environment;
- The board purchased the *Trident*, a boat used for marine research, now operating in the lagoon;
- Solid Waste Authority recently approved a new transfer station at Lantana Road and Interstate 95;
- The board purchased the land for the West Boynton Recreation Center providing the opportunity to co-utilize the property. Today, a fire station, a park with major recreation fields, a community center, the school board with the design of a new high school, and a sheriff's office substation were all on site;
- The operation of title loan businesses was discontinued in the county and ultimately the state. People who needed money went to a title loan company and gave their car keys and were charged 360 percent interest per year on a loan they obtained; and
- Secondhand dealers were regulated and monitored to ensure that stolen materials were properly identified.

Commissioner Newell thanked his staff and colleagues for their support and assistance for the past two years.

Listed below were the issues Commissioner Newell said needed to be focused on in the future:

- Lake Worth Road corridor and revitalization areas need water, sewer, code enforcement, drainage, and more community parks; and
- Work on road congestion. Pass an ordinance or referendum that restricts the reduction of roadway corridors. Stop the county or municipalities from having the ability through political pressure to reduce and downgrade roadway capacities, because it ultimately hinders all transportation in the county.

- Need to prevent utility deficiencies in all areas of the county. Sewers were being installed west of the Village of Wellington, and there was still no water west of Congress Avenue.
- Bond issues were very important to make sure parks and cultural projects were built and completed together.

Commissioner Newell said he hoped the last two years had been successful. He said he tried hard to make sure that he was fair, and that the board had fun and worked well together.

Commissioner Newell again thanked all the members of his staff, with a special thanks to Administrative Assistant Sue Beaman, who will retire in March.
