REVISED TITLE & SUMMARY: Staff recommends motion to deny: the request to rescind have Palm Beach County release the rights under the Agreement to Reserve Future Right-of-Way for Wabasso Drive at Westgate Avenue, and Westgate Avenue, West Palm Beach, as recorded in Official Record Book (ORB) 6643, Page 1543, Public Records of Palm Beach County. **SUMMARY:** Joe Pitts, Realtor, with the support of the Westgate CRA has requested that the County release a Right-of-Way Reservation for Wabasso Drive and Westgate Avenue as it affects associated with the property on the southeast corner of Westgate Avenue and Wabasso Drive. The square footage encumbered by this road Right-of-Way Reservation is in conformance with the <u>current</u> Thoroughfare Plan. Staff is considering changes to the Comprehensive Plan, which could negate the need for this reservation. On April 8, 2002, the Board initiated a reconsideration of the amount of needed right-of-way as part of the upcoming Comprehensive Plan round. Until this (and if) any proposed change is approved by the Board, staff feels it is premature to release this reservation. REQUEST TO RESCIND AGREEMENT TO RESERVE FUTURE RIGHT-OF-WAY FOR PROPERTY IN THE AREA OF WABASSO DRIVE AT WESTGATE AVENUE. DISCUSSED 4-23-2002.

Realtor <u>Joe Pitts</u> had petitioned the county to rescind a right-of-way agreement on property near the southeast corner of Westgate Avenue and Wabasso Drive on behalf of owner Robert Lombardo. Staff originally had recommended denial of the request since pending changes to the Comprehensive Plan could negate the need for it. Mr. Pitts expressed to the board that the easement reservation had kept the property from being sold and that a potential buyer wanted to build a laundromat on it.

Commissioner Roberts said the county would be better off releasing rights to the property than facing the possibility of paying business damages. Commissioner Aaronson agreed.

After lengthy discussion, staff said the board could allow release of the agreement by waiving the base building line.

MOTION to release the agreement by waiving the base building line. Motion by Commissioner Roberts, seconded by Commissioner Greene, and carried 6-0. Commissioner McCarty absent.

(CLERK'S NOTE: Commissioner Marcus left the meeting.)

Staff ultimately suggested releasing the rights under the agreement.

MOTION to release the rights under the agreement for future right-of-way. Motion by Commissioner Roberts and seconded by Commissioner Masilotti.

<u>Robert Lombardo</u> said he hoped the sale and development of his property would eventually provide tax revenue for the county.

UPON CALL FOR A VOTE, the motion carried 5-0. Commissioners McCarty and Marcus absent.

(CLERK'S NOTE: Commissioner Marcus rejoined the meeting.)

WORKSHOP ITEMS – CONTINUED

5. 2:00 P.M. - RETENTION PONDS. DISCUSSED WITH DIRECTION 4-23-2002

County Engineer George T. Webb asked the board for direction in landscaping or otherwise developing existing and anticipated drainage ponds created throughout the county in conjunction with the road program.

After lengthy discussion, the board generally favored the possibility of converting some of the larger ponds and the areas surrounding them into "passive parks." Projects could be considered individually on a district-by-district basis, and gasoline tax allocations were a funding option.

Smaller ponds in residential areas could be blocked from neighborhood view with flame vines and cypress trees, as espoused by Mr. Webb, commissioners concluded.

Mr. Webb also sought approval of funding for the development of a six-acre concept park surrounding one of the ponds beside Coconut Boulevard near Northlake Boulevard. The project would be completed with the joint participation of the Indian Trail Improvement District, which would maintain the area, Mr. Webb noted.

(CLERK'S NOTE: Commissioner Marcus left the meeting.)

Commissioner Aaronson noted that the Indian Trail project showed a total cost of \$250,000 and called it a tremendous pilot program.

MOTION to proceed on the Indian Trail retention pond park project with the help of Indian Trail Improvement District. Motion by Commissioner Aaronson and seconded by Commissioner Masilotti.

Commissioner Roberts suggested that staff investigate if Indian Trail Improvement District ultimately would want to take over the property.

AMENDED MOTION to direct staff to look into whether Indian Trail Improvement District ultimately would want to take over the property. The maker and seconder agreed.

County Administrator Weisman confirmed that the board's intention to allot as much as could be justified for the county's share of the project from the road program and take the remainder out of general funds.

UPON CALL FOR A VOTE, the motion passed 5-0. Commissioners McCarty and Marcus absent.

STAFF WAS DIRECTED TO:

- Landscape retention ponds in residential areas at its discretion.
- Consider possible future development of larger retention ponds and their surrounding areas on an individual basis and to solicit local agency participation and stipulate municipal partnership where possible.

6. 3:30 P.M. - MEETING WITH THERESA LEPORE, SUPERVISOR OF ELECTIONS, REGARDING ELECTIONS AND VOTING MACHINES. DISCUSSED 4-23-2002

The board had submitted a series of questions to Supervisor of Elections Theresa LePore addressing concerns over elections issues and the operation of the new touch-screen voting machines.

Ms. LePore appeared before the board with John Krizka, representing Sequoia Voting Systems, vendor for the county's new touch-screen voting machines.

Ms. LePore said one of her biggest concerns was obtaining and training poll workers, 5,000 of whom were needed for the fall election. She thanked Property Appraiser Gary R. Nikolits for offering his staff to work at the polls and said she would be contacting other county officials to see if they would provide their employees as poll workers. Commissioners had suggested that poll workers with higher standards be found.

Commissioner Masilotti said in the Village of Wellington municipal election, of 2,600 voters, 78 were not recorded. He said he could not believe 78 people went to the polls and did not vote. He called the machines "suspect" and later inquired if the contract for them could be terminated prior to the November election. Ms. LePore reported that no voters had problems at the polls, according to precinct workers. State law provided for public testing of voting equipment before and after an election, she said.

Mr. Krizka said Sequoia stood behind the new voting machine system as 100 percent accurate and proven in like-size counties. A component to allow voters to automatically review their voting selections was expected to be added to the machines and in use by the fall election, he noted.

Commissioner Aaronson said he had been told that at an elections training session yesterday in south county, a voting machine failed to work. Ms. LePore said she was unaware of that, but if that were to happen during an actual election, an extra machine could be put into service.

Commissioner Marcus suggested the formation of a citizens review committee on election issues to communicate with the public. Commissioner Newell favored a review by the Collins Center on Public Policy.

Commissioner Aaronson proposed that the commission oversee a "mock vote" on the new machines.

Since Ms. LePore's appearance was restricted to 30 minutes as result of previous commitments, Commissioner Aaronson asked that she return for further discussion. She replied that she was extremely busy and though she would be happy to, "I can't just stop what I'm doing to come at your beck and call...."

STAFF WAS DIRECTED TO:

- Arrange a second meeting with Ms. LePore in June for further discussion of election issues and county employees serving as poll workers.
- Investigate the formation of a citizens review committee for election issues.
