MEETING: BOARD OF COUNTY COMMISSIONERS, BUDGET PUBLIC HEARING

I. CALL TO ORDER: September 19, 2002, at 7:01 p.m. in the Palm Beach County Governmental Center, West Palm Beach, Florida.

III. PUBLIC HEARINGS

III.A.

PERCENTAGE INCREASE IN MILLAGE OVER ROLLED-BACK RATE AND SPECIFIC PURPOSES FOR INCREASE. DISCUSSED 9-19-20002

County Administrator Weisman outlined that in accordance with the Truth in Millage (TRIM) Bill, the commissioners shall hold public hearings on the tentative budget and proposed millage rates.

As stipulated in the TRIM Bill, Mr. Weisman continued, the first substantive issue to be discussed should be the percentage increase/decrease in the millage over the rolled-back rate necessary to fund the budget, if any, and the specific purpose for which ad valorem tax revenues were being increased.

Mr. Weisman read into the record the millage over rolled-back rates for fiscal year 2003 with the proposed taxes and percent increase/decrease for the county, the Library District, Fire-Rescue Municipal Service Taxing Unit (MSTU), Jupiter Fire-Rescue and Glades Regional Fire MSTU.

SPECIFIC PURPOSES FOR AD VALOREM TAX INCREASES. DISCUSSED 9-19-2002.

Mr. Weisman read the explanation for specific increases over rolled-back revenue for fiscal year 2003 for the county, the Library District, Fire-Rescue Municipal Service Taxing Unit (MSTU), Jupiter Fire-Rescue and Glades Regional Fire MSTU.

III.B.

PUBLIC COMMENTS, AND DISCUSSION ON BUDGET. DISCUSSED 9-19-2002

PUBLIC COMMENT:

John O. Parsons of Jupiter encouraged the board to put control on spending. He said state government had cut 10,000 positions in four years under Governor Jeb Bush, who vetoed \$1 billion in budget-line items during the last four budget cycles. He contended that the state tax burden had been at its lowest rate since 1992. He suggested commissioners examine their individual budgets for possible reduction. He said the cities should fund their own projects instead of the board seeking voters' support to a \$50 million bond issue.

Commissioner Aaronson commented that it was easier for the state to reduce taxes because the burden was being shifted to county government. Commissioner Marcus added that residents might not have shown up to protest the budget because they were contented with the county's performance.

<u>John Earley</u> said that if the board could find eight percent waste in the \$2.9 billion budget, property owners could get a 40 percent reduction on property taxes.

In response to a request from Commissioner Newell, Finance and Budget Director Richard Roberts explained that the amount derived from countywide property taxes was \$779 million, of which about \$400 million was property tax dollars from residential and commercial properties. He said the \$2.9 billion budget included revenue from airports, water utilities, federal grants, and other sources.

III.B. - CONTINUED

Mr. Earley contended that county records showed that expenditures had gone up 55.8 percent since 1997 while the population had increased only 19.7 percent. He commented that about 80 percent of Palm Tran routes were not being used, the county motor pool was expensively fleeted, and that the new governmental center for Environmental Resources Management (ERM) was not needed.

Commissioner McCarty said she had been approached several times about the 55 percent increase issue. She explained that when adjustments were made for inflation, property tax remained the same with the increased population. She said the difference was voted debts that taxpayers approved. Mr. Weisman would send a memo to address Mr. Earley's concerns, the commissioner suggested.

Commissioner Newell stated that the building where ERM operates was a 1942 army barrack that had been used extensively. He said it was time for the department to be provided housing elsewhere.
