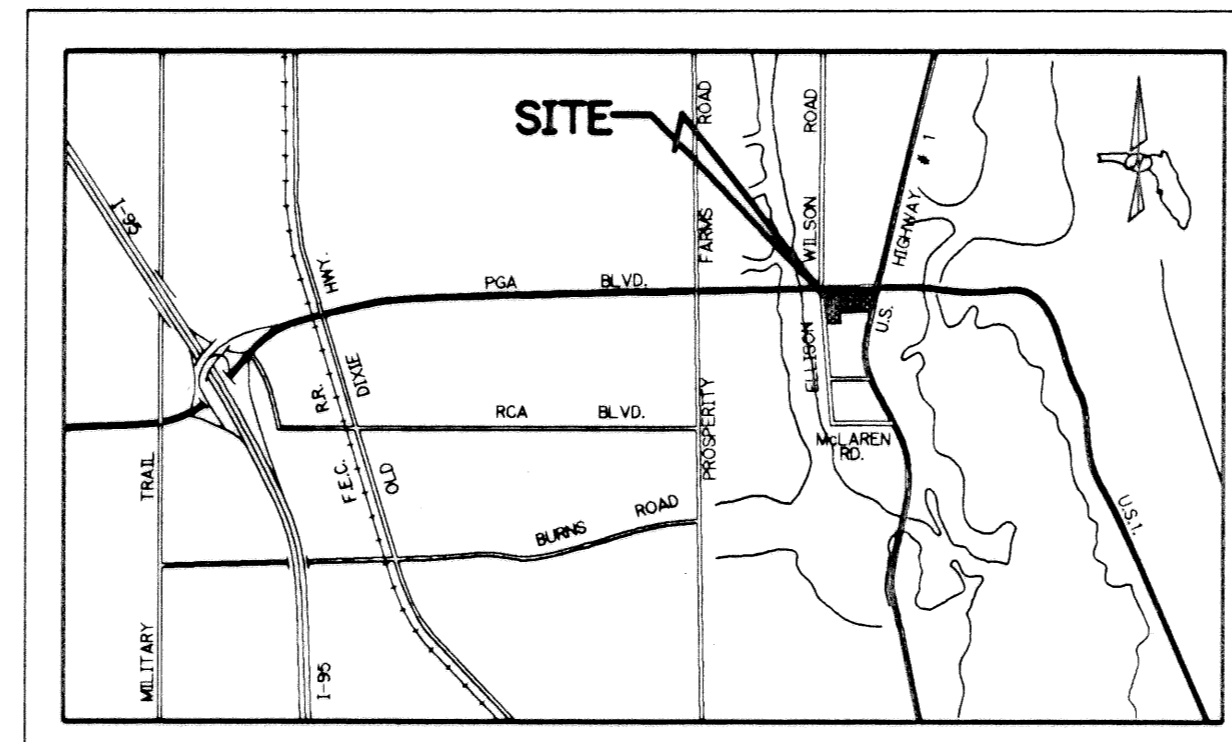

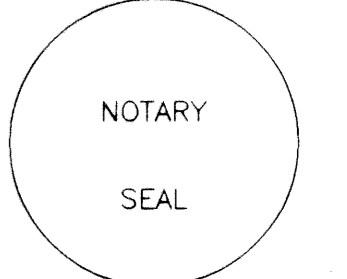
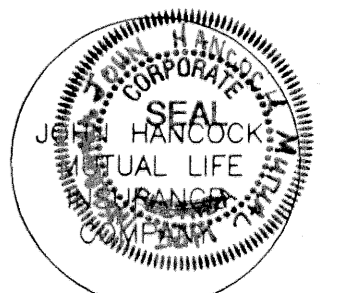


LOCATION MAP
