#### I. Roll Call

#### III. Presentation of Education Outreach Program

**Jody Gleason,** Executive Director of the Education Commission presented a detailed summation of the Commission's active relationship with Scripps. She expressed that the Commission is seeking a similar relationship with IBM. Ms. Gleason added that there are eight-hundred schools across the nation participating and proceeded to give examples of how the partnership works inclusive of paid internships being offered.

Commissioner Marcus thanked Ms. Gleason for the presentation; Councilwoman Cook reiterated the science portion of Ms. Gleason's presentation and informed the Board that the elementary and middle school's Science and Math Fair was scheduled for on April 23, 2007 at the South Florida Fairgrounds.

**Deborah Leach-Scampavia,** Scripps Florida Education & Outreach Administrator presented a detailed summation on Scripps' Biomedical Research Institute. She stated that it is one of the top Ph.D programs in the country with exceedingly high education standards. Mrs. Leach-Scampavia said that it is their goal to mimic La Jolla's program here in Florida. She touched briefly on the funding provided and the stipends given to teachers who participate in this

program. Mrs. Leach-Scampavia provided a brief description of the student-teacher activities held on Saturday. She informed the Board that her organization was very fortunate to be in partnership with a board that was as supportive as the Palm Beach County School Board has been.

A question/answer format took place between the Board and the presenters.
