## Legislative Update — June 2017

### **FEDERAL ISSUES**

#### **FY 2018 Appropriations Update**

On May 23 2017, the Trump Administration released the President's Fiscal Year (FY) 2018 Budget, which includes \$1.065 trillion in overall discretionary spending.

Here is a brief summary of the appropriations:

Department of Agriculture: Approximately \$21 billion in discretionary budget authority for FY 2018, approximately \$200 million above FY 2017 enacted levels to fund programs and operating expenses.

Department of Commerce: \$7.8 billion in discretionary budget authority for the Department of Commerce, an overall reduction of \$1.4 billion below the FY 2017 enacted level.

Department of Education: \$59 billion in total discretionary budget authority for the Department of Education, a decrease of approximately \$9.2 billion (or 13 percent) below the 2017 enacted level.

Department of Energy: \$28 billion in discretionary budget authority for the Department of Energy, an overall reduction of \$2.8 billion below the FY 2017 enacted level.

Environmental Protection Agency: \$5.65 billion in budget authority for the Environmental Protection Agency, an overall reduction of \$2.4 billion (30%) below the FY2017 enacted level. The department-wide cuts to EPA are the largest by percentage in the President's budget.

Department of Health and Human Services: \$65.7 billion in discretionary budget authority for the Department of Health and Human Services (HHS), which represents a reduction of approximately \$13 billion (or 16 percent) from the FY 2017 enacted level.

Department of Homeland Security: \$44.06 billion in Department of Homeland Security (DHS) funding – an overall increase of \$1.66 billion above the FY 2017 enacted level.

Department of Housing and Urban Development: \$40.874 billion in gross discretionary funding for the Department of Housing and Urban Development (HUD), approximately \$2.074 billion above FY 2017 enacted levels.

Department of the Interior: \$11.7 billion in total discretionary budget authority for the Department of the Interior, an overall reduction of \$550 million below the FY 2017 enacted level.

Department of Justice: \$28.63 billion, approximately \$37 million below the FY 2017 enacted

levels, in Department of Justice discretionary funding. This funding includes \$940.5 million, \$1.45 billion less than FY 2017 enacted levels, for State and Local Law Enforcement Programs.

Department of Labor: \$9.742 billion in discretionary funding is included for the Department of Labor (DOL) in FY 2018, a decrease of approximately \$2.36 billion below the FY 2017 enacted level, in addition to approximately \$34.5 billion in mandatory spending.

Department of Transportation: Approximately \$75.9 billion in discretionary and mandatory budgetary resources for the Department of Transportation (DOT), including \$16.2 billion in discretionary funding or approximately 12 percent less than the FY 2017 enacted level.

## **Everglades**

Florida lawmakers reintroduced legislation in both the Senate and House yesterday aimed at speeding up restoration projects in the Everglades.

"There's simply too much at stake here in Florida to wait around for Congress to pass a water bill every few years," said Sen. Bill Nelson (D), who introduced [S. 1234](#). "This bill will allow the [Army Corps of Engineers] to begin work on these projects as soon as they are ready."

Under current law, the Army Corps must tell Congress when it is prepared to start work on a project. Then the agency must wait for Congress to authorize the project under a broader water resources bill.

"This bill works to restore this unique ecosystem by ensuring that as final planning for restoration projects is completed, these projects are authorized and brought online as expeditiously as possible," said Rep. Alcee Hastings (D), who sponsored [H.R. 2691](#)

There are three Everglades projects in the planning stage: the Lake Okeechobee Watershed Project, Western Everglades Restoration Project and Loxahatchee River Watershed Restoration Project. Under the legislation, they would be authorized as soon as the Army Corps deems them ready.

## **STATE ISSUES**

The Florida Legislative Session ended on May 8, 2017 with the passage of the budget bill SB 2500. On May 31, 2017 the budget bill was delivered to the governor, and he signed it on Friday, June 2, 2017.

Here are other pieces of legislation that have been signed into law:

**HB 457:** The bill addresses terrorism by creating a crime of terrorism and related crimes. A person who violates any listed statute or statutory provision in furtherance of intimidating or coercing the policy of a government, or in furtherance of affecting the conduct of a government by mass destruction, assassination, or kidnapping, commits the crime of terrorism, a first degree felony (or a life felony if there is a death or serious bodily injury).

**HB 7109:** The tax cutting measure bill provides the following highlights:

- Provides a 3-day "back-to-school" holiday (August 4-6, 2017) for clothing and footwear costing \$60 or less, school supplies costing \$15 or less, and for computers with a sales price of \$750 or less.
- Provides a 3-day disaster preparedness sales tax holiday (June 2-4, 2017) for certain first-aid kits, tie-down kits, fuel tanks, batteries, food storage coolers, self-powered lights and radios, portable generators, and reusable ice.
- Reduces the state sales tax rate on the rental of commercial real estate from 6.0 percent to 5.8 percent.

- Exempts from sales tax feminine hygiene products.

**SB 80:** The bill requires a court to award attorney fees and costs to a plaintiff who sues an agency to enforce a public records request if the court determines that the agency unlawfully refused access to a public record and the plaintiff provided written request for the public records to the agency's records custodian at least five business days before filing the lawsuit.

**SB 818:** The bill amends the Florida Vacation Plan and Timesharing Act, which establishes requirements for the creation, sale, exchange, promotion, and operation of timeshare plans, including requirements for full and fair disclosure to purchasers.

The changes made by the bill:

- Revise the term “interest holder” with respect to a multisite timeshare plan governed by part II of the act;
- Revise requirements for instruments that establish or govern a component site property regime, including the requirement to issue or provide certain documents to creditors;
- Revise requirements for terminations of timeshare plans;
- Revise requirements for extensions of timeshare plans, which apply to all timeshare properties in the state;
- Allow reasonable termination expenses to be paid pro rata by owners of former timeshare properties;
- Amend requirements for voting upon an extension of a term of a timeshare plan, including meeting notices, voter eligibility, proxies, and quorum requirements.

**SB 852:** The bill amends multiple statutes to include the term “commercial sexual exploitation.” The term emphasizes the fact that sex is exchanged for money, goods, or services and better defines the victims served by the Department of Children and Families (DCF), sheriff's offices conducting child abuse investigations, and community-based care agencies.

**SB 884:** The bill prohibits possessing in or on the waters of the state a shark fin that has been separated from a shark or landing a separated shark fin (shark finning), unless such possession is authorized by the Florida Fish and Wildlife Conservation Commission or such fin has been lawfully obtained on land and prepared by taxidermy and is possessed for the purposes of display.

**SB 886:** The bill aligns the protection of court documents under the Marchman Act (involuntary assessment for substance abuse) with the Baker Act (involuntary assessment for mental health disorders). The bill provides legislative findings that making such petitions, orders, records, and identifying information confidential and exempt from disclosure will protect such persons from the release of sensitive, personal information which could damage their and their families' reputations, and that protecting such information is a public necessity.

**HB 7107:** HB 7107 provides the implementing language for the amendment to Article VII, Section 6(a) of the State Constitution, proposed in HJR 7105. HJR 7105 provides an additional homestead property tax exemption from all taxes, other than school district taxes, of up to \$25,000, by exempting assessed value greater than \$100,000 and up to \$125,000. The bill amends s. 196.031, F.S., to provide the dollar threshold for the additional homestead exemption in the constitutional amendment.

**SB 10:** The bill directs the expedited design and construction of a water storage reservoir in the Everglades Agricultural Area (EAA) to provide for a significant increase in southern storage to reduce the high-volume discharges from Lake Okeechobee. The reservoir is a project component of the Comprehensive Everglades Restoration Plan (CERP) and is designed to hold at least 240,000 acre-feet of water and include water quality features necessary to meet state and federal water quality standards. Upon the effective date of the act, the bill requires the South Florida

Water Management District (SFWMD) to identify the lessees and landowners of specified land in the EAA near the A-2 parcel.

**HB 7099:** The bill updates the Florida Income Tax Code to adopt the Federal Internal Revenue Code in effect on January 1, 2017. The legislation changes Florida’s extension period to file a corporate income tax return to match a similar federal time period, and it requires estimated payments that are due on the last Saturday or Sunday in June to be paid by the last Friday in June.

**HB 249:** The bill requires hospitals with emergency departments to develop best practice policies that focus upon the prevention of unintentional drug overdoses. The bill defines “overdose” and provides parameters for the contents of a hospital’s overdose prevention policy.

**Governor Signs SB 2500; Calls for a Special Session**

Gov. Rick Scott on Friday vetoed \$410 million in projects from the new state budget, as lawmakers prepare to return to Tallahassee next week to finalize a spending plan for the fiscal year that starts July 1.

Scott's office said it would release a detailed list of the vetoed projects later Friday, saying the projects “do not provide a great return for Florida families.” The targeted projects were included in an \$82.4 billion budget that lawmakers passed May 8. Scott also signed that budget Friday, his office said. But lawmakers will start a three-day special session Wednesday to approve legislation that would make changes in what was passed last month. Scott, Senate President Joe Negron, R-Stuart, and House Speaker Richard Corcoran, R-Land O' Lakes, announced the special session Friday.

The special session is expected to include increasing the amount of money that will go to public schools, increasing the planned amount of spending on the tourism-marketing agency Visit Florida and creating an \$85 million “Florida Job Growth Grant Fund,” according to information from Scott's office and legislative leaders. The News Service will have full stories later Friday on the special session and vetoes.
