# The Enterprise

This past quarter, the Office of Equal Business Opportunity (OEBO) has been working with the County Departments to implement the Equal Business Opportunity (EBO) Ordinance by providing group and individual trainings. We have also held several workshops for small businesses to introduce them to the EBO Program and the certification process. Over the next few months, we will continue to host workshops with our Small/Minority/Women Business Enterprises (S/M/WBE) and County vendors on the EBO Program and the vendors' role and responsibilities. The workshops will be held at various convenient locations throughout the county, so be on the lookout for our announcements.

As part of the EBO Program, Affirmative Procurement Initiatives (API) may be placed on County contracts based upon the availability of S/M/WBE firms. The County has created a Goal Setting Committee (GSC) to review upcoming contracts to determine the appropriate API. The GSC meets every first and third Wednesday of each month and is open to the general public. You can view the agenda and meeting minutes on the OEBO website under the OEBO Committee tab.

In addition to the many opportunities S/M/WBEs will have with the County, the Super Bowl LIV Business Connect Program has been created for the 2020 Super Bowl in Miami. The Business Connect Program has designated Palm Beach County as their certification resource and will accept OEBO certified S/M/WBEs to compete for special event related contracts.

We encourage our current S/M/WBEs to maintain your certification and other Palm Beach County small businesses to become certified. Remember, there is NO CERTIFICATION, RECERTIFICATION OR MODIFICATION FEE! Also, if you are a current OEBO S/M/WBE and are providing services for which you are not currently certified, please modify your certification to so we can add those service(s).

## **Palm Beach County Department of Airports**

#### The Department of Airports for Palm Beach County owns, operates and maintains the following airports:

- Palm Beach International Airport (PBI)
- North Palm Beach County General Aviation Airport (F45)
- Palm Beach County Park Airport (LNA)
- Palm Beach County Glades Airport (PHK)

The Board of County Commissioners establishes the Department of Airports policy. The Department of Airports operates as an enterprise fund, with no ad valorem tax support; rather user fees fund operations, while grants, passenger facility charges, revenue bonds and airport revenues fund construction.

#### **Services Contracted by the Department of Airports**

- Development program administration and management (CIP programming, consulting and implementation)
- Aviation planning, including air service studies, financial analyses, terminal and concessions planning
- Passenger Facility Charge (PFC) program support
- Land use planning, land acquisition, market assessment, appraisal services and land development consulting services
- Horizontal infrastructure design, such as general civil and airfield electrical design of runways, taxiways and aircraft parking aprons, as well as site development and roadway facility planning and design
- Vertical facility design, such as architectural, mechanical, electrical, structural and landscaping design of airport-related and ancillary facilities
- Facilities inspection
- Storm water and environmental planning, design, permitting and agency coordination
- Construction management, administration and coordination and construction engineering and inspection (CEI) services
- Quality assessment and quality assurance reviews
- Pavement management system development and support
- Aviation/airport information technology (IT) and geographic information system (GIS) services
- IT planning support services/technology master planning support
- Environmental planning and analysis, including preparation of National Environmental Policy Act (NEPA) documentation to support future development
- Disadvantaged Business Enterprise (DBE) outreach and support services

Retail Vending Concession Agreement at the Palm Beach International Airport (PBI) – The Department anticipates issuance of an RFP in May 2019 for a Retail Vending Concession at PBI commencing October 1, 2019, providing for vending machines at the PBI terminal.

**ATM Concession Agreement at the Palm Beach International Airport (PBI)** – The Department anticipates issuance of an RFP in May 2019 for the ATM Concession at PBI commencing October 1, 2019.

Palm Beach County Glades Airport (PHK) Fuel Farm Improvements (\$1.1M) — This project includes the removal and disposal of the existing underground fuel tanks and replacement with new, above ground fuel tanks and associated fueling systems, along with drainage improvements and security camera installation on the fuel farm at Palm Beach County Glades Airport (PHK).

Palm Beach County Park Airport (LNA) Fuel Farm & Aircraft Wash Rack (\$1.1M) — This project includes the construction of fuel farm and wash rack systems at Palm Beach County Park Airport (LNA), as well as pavement reconstruction of the southern portion of the general aviation west apron pavement in close proximity to the new fuel system and wash rack.

- North Palm Beach County GA Airport (F45) Perimeter Fence Improvements (\$1.1M) This project includes the construction of security fencing around the airfield at North Palm Beach County GA Airport (F45) in order to increase the physical security of the airport and mitigate wildlife activity within the airport operations area.
- Palm Beach International Airport (PBI) Northeast Airfield Improvements Project (\$28.0M) This project includes the rehabilitation, reconstruction and/or realignment of various pavement sections in the northeast corner of the airfield at Palm Beach International Airport (PBI). The project Includes the following elements: Concourse C (east side) apron taxilane rehabilitation and reconstruction, east remote ramp rehabilitation and reconstruction, Taxiway G (new Taxiway C6) reconstruction, demolition of Taxiways D and H and construction of new Taxiway C7, Taxiway M rehabilitation, Taxiway M drainage canal replacement with a box culvert, Taxiway G realignment and Taxiway C rehabilitation.
- Palm Beach International Airport (PBI) Northeast Airfield Improvements Project (\$28.0M) This project includes the rehabilitation, reconstruction and/or realignment of various pavement sections in the northeast corner of the airfield at Palm Beach International Airport (PBI). The project includes the following elements: Concourse C (east side) apron taxilane rehabilitation and reconstruction, east remote ramp rehabilitation and reconstruction, Taxiway G (new Taxiway C6) reconstruction, demolition of Taxiways D and H and construction of new Taxiway C7, Taxiway M rehabilitation, Taxiway M drainage canal replacement with a box culvert, Taxiway G realignment and Taxiway C rehabilitation.
- LNA Part 150 Noise Compatibility Study (\$300,000) This project includes the development of Noise Exposure Maps (NEM) for the existing and future conditions at Palm Beach County Park Airport (LNA), and the development of a Noise Compatibility Plan (NCP). As part of the effort, there will also be a comprehensive stakeholder participation program, including a technical advisory committee, public meetings and a community outreach program.
- **LNA West Apron Rehabilitation** (\$1.5M) This project provides for the pavement rehabilitation of the western-most portion of the aircraft parking apron at Palm Beach County Park Airport (LNA).
- **PBI Interior Airfield Service Roadway** (\$1.0M) This project includes the construction of an extension of the inner airfield service road on the south side of Palm Beach International Airport (PBI), in an effort to provide a vehicular roadway connection between the Golfview Development Area in the northwest corner of the airfield, with the south side general aviation (GA) facilities.
- PHK Runway & Taxiway Rehabilitation (\$2.0M) This project provides for the rehabilitation of Runway 18 -36 and its associated taxiway connectors, as well as the removal and realignment of Taxiway D to meet current design standards at Palm Beach County Glades Airport (PHK).

### **Become Pre-Qualified!!!**

Pre-qualification contracts are a great opportunity for new or existing vendors to bid smaller projects in order to become familiar with the County's processes and to establish a solid working relationship with the County!

A pre-qualification contract is a contract that includes minimum qualifications (e.g. references, licenses, experience, etc.) required from the vendor in order for them to become pre-qualified on a contract for goods and/or services where two or more qualified vendors compete for specific projects. The County will add Vendors to the pre-qualification contract at any time as long as the vendor meets the minimum qualifications stated in the pre-qualification package. Purchases solicited through a pre-qualification contract are generally under \$100,000.

Palm Beach County's Purchasing Department has an assortment of pre-qualification contracts available for a variety of different services that are utilized by multiple departments within Palm Beach County.
