EXPLANATION OF TAX NOTICE

COLUMN 1

“YOUR PROPERTY TAXES LAST YEAR”

This column shows the taxes and millage rates that applied last year to your property. These amounts were based on budgets adopted last year and your property’s previous taxable value.

COLUMN 2

“YOUR TAXES THIS YEAR IF PROPOSED BUDGET CHANGE IS MADE”

This column shows what your taxes and millage rates will be this year under the BUDGET ACTUALLY PROPOSED by each local taxing authority. The proposal is NOT final and may be amended at the public hearings shown on the front side of this notice. The difference between columns 2 and 3 is the tax change proposed by each local taxing authority and is NOT the result of higher assessments.

COLUMN 3

“YOUR TAXES THIS YEAR IF NO BUDGET CHANGE IS MADE”

This column shows what your taxes and millage rates will be this year IF EACH AUTHORITY DOES NOT CHANGE ITS PROPERTY TAX LEVY. These amounts are based on last year’s budgets and your current assessment.

NOTE: Amounts shown on this form do NOT reflect early payment discounts you may have received or may be eligible to receive. (Discounts are a maximum of 4 percent of the amounts shown on this form.)

Non-Ad Valorem Assessments: Non-ad valorem assessments are placed on this notice at the request of the respective local governing boards. Your Tax Collector will be including them in the November tax bill. For details on particular non-ad valorem assessments, contact the levying authority shown on the front of this notice.
