Due to an increase in the number of new buses and the number of parts required to be in stock prior to the buses being put in service, an increase of \$319,400 over the previously authorized amount of \$1,480,600 is needed to meet the County's requirements through the contract expiration. Because of Federal funding, this project must adhere to the Federal DBE program rather than the County's SBE program.
