The County has encumbered \$1,017,023 (\$127,128/month) during this eight (8) month emergency term contract. Due to the necessity to extend the contract for a two (2) month period, an increase of \$175,000 over the previously authorized amount of \$1,071,821 is needed to meet the County's requirements through contract expiration. This contract was extended in order to provide adequate time to complete a competitive process for this need. This term contract has no renewal options. Because of Federal funding, this project must adhere to the Federal DBE program rather than the County's SBE program.

The County has encumbered \$2,962,405 (\$311,832/month) during the previous nine and one half (9.5) months of the current twelve (12) month term contract. ISS has requested an increase of \$2,500,000 over the previously authorized amount of \$3,000,000 to meet the County requirements through the current term and the three (3) month extension approved by the Director of Purchasing. This additional time is necessary in order to conduct a new competitive solicitation for these services. These contracts were established by competitive RFP, which allows up to ten points for SBE participation. Six of the seven consultants received points for subcontracting participation.
