# FIRST AMENDMENT TO THE AIR FREIGHT BUILDING LEASE AGREEMENT BETWEEN PALM BEACH COUNTY AND UNITED STATES POSTAL SERVICE

This Amendment No. 1 ("Amendment") is made and entered into \_\_\_\_\_\_, 2006 by and between Palm Beach County, a political subdivision of the State of Florida (the "COUNTY"), and United States Postal Service, an agency of the Federal Government of the United States, having its Area Facilities Service Office at Building 300, Suite 300, 4000 DeKalb Technology Parkway, Atlanta, Georgia, 30340-2799 ("LESSEE").

#### WITNESSETH:

WHEREAS, pursuant to the Air Freight Building Lease Agreement between the COUNTY and LESSEE, dated and approved May 6, 1997 (R-97-555-D)(the "Lease") LESSEE leases certain ground areas at the Palm Beach International Airport for the purpose of processing air couriered mail and cargo; and

WHEREAS, the parties now desire to amend the Lease to extend the expiration date of the Lease; and

WHEREAS, the Board of County Commissioners has determined that it is in the best interests of the COUNTY to approve this Amendment to the Lease to provide for the extension of term.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants herein contained, and for such other good and valuable consideration, the receipt of which the parties hereby expressly acknowledge, the parties hereto covenant and agree to the following terms and conditions:

- (1) The recitals set forth above are true and correct and incorporated herein by this reference.

  Terms not defined herein shall have the meaning ascribed to them in the Lease.
- (2) Article 1.01 of the Lease is hereby deleted in its entirety and replaced with the following:
  - "This Term of Lease shall commence on December 5, 1996 (the "Commencement Date") and shall terminate on September 30, 2007.
- (3) Except as modified herein all terms and conditions of the Lease shall remain in full force and effect.
- (4) This Amendment shall become effective when signed by all parties and approved by the Palm Beach County Board of County Commissioners.

IN WITNESS WHEREOF, COUNTY has caused this Amendment to be signed by the Chair of the Board of County Commissioners and the seal of the Board to be affixed hereto and attested by the Clerk of the Board, pursuant to the authority granted by the Board, and LESSEE, United States Postal Service, has caused these presents to be signed in its lawful name by its duly authorized officer, the Control of LESSEE, acting on behalf of LESSEE, and the seal of LESSEE to be affixed hereto the day and year first written above.
