I. EXECUTIVE BRIEF

MOTION AND TITLE: Staff recommends motion to approve: a budget transfer of \$5,000 in the Crime Prevention Fund (CPF) to provide funds for Palm Beach County's First Annual Youth Leadership Summit.

SUMMARY: On August 14, 2006, the Executive Committee of the Criminal Justice Commission approved the use of \$5,000 from the CPF to help defray the costs of the School District of Palm Beach County's First Annual Youth Leadership Summit to be held November 30, 2006. Over 1,000 middle and high school students from throughout the county will attend. The goal is to provide students with up-to-date information about keeping drug-fee and safe. Community partnerships will be established to facilitate the Conference. Countywide (DW)

BACKGROUND AND POLICY ISSUES: The Prevention Center in the Department of Safe Schools of the School District of Palm Beach County will host its First Annual Youth Leadership Summit in Palm Beach County. The Summit will be held at the Safe Schools Institute in Boca Raton. Organizers will invite Student Councils, student empowerment groups that include Students Against Destructive Decisions (SADD), Students Working Against Tobacco (SWAT), Safe School Ambassadors, other student leaders and students that participate in the District's drug abuse and violence prevention initiatives. The goal is to empower students to make positive decisions inside and outside of the classroom. The motivational keynote speaker will discuss personal development, responsibility and the benefits of living a drug-free, socially conscious life. Other topics will cover the importance of goals, positive decision making, school safety, bullying behavior, character (respect, responsibility, caring, etc.), saying no to alcohol and drugs and how actions have certain consequences. The Board of County Commissioners approved a \$5,000 budget transfer in the CPF on May 3, 2005 to support the 5th Annual Youth Millennium Conference that was held of April 4, 2005. The Millennium Conference was also sponsored by the School District's Department of Safe Schools Prevention Center

The Crime Prevention Fund Ordinance No. 2001-030 was created in 2001 (amended December 18, 2001, R2001-099) pursuant to Section 775.083 (2) of Florida Statues. The Crime Prevention Fund (CPF) was subsequently established and is the depository for court assessments imposed by law per Florida Statue and the Crime Prevention Fund Ordinance. The CJC administers these funds and revenues are required to be expended toward the purpose area of crime prevention initiatives. The Summit falls under this purpose area.

 - A. Consent Item(s)
 - 1. Palm Beach County School District, Department of Safe Schools Prevention Center, requests sponsorship and financial support of its First Annual Youth Leadership Summit to be held at the Safe Schools Institute in Boca Raton on November 30, 2006. The conference is designed to provide up-to-date information about keeping drug-free and safe to over 1,000 youth from Palm Beach County. The CJC donated \$5,000 the past year to support the 5th Annual Youth Millennium Conference also sponsored by the Department of Safe Schools Prevention Center. The CJC funding source would be the Crime Prevention Trust Fund.
 - 2. Barry Krischer has resigned from the Executive Committee and recommends his seat be filled by U.S. Attorney Andrew Lourie whose seat was filled by Public Defender Carey Haughwout during Mr. Lourie's temporary reassignment to Washington, D.C.
 - 3. Information Systems Services (ISS) will provide contract services for CJC technology planning and implementation of video conferencing and webcasting. Expenses will be approximately \$9,000 for FY06 from the \$1 million funding source.
