I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: A) Budget Transfer of \$270,000 from the General Fund Contingency Reserves to the Summer Camp Scholarship Program; **B)** Budget Transfer of \$200,000 from the Park Improvement Fund Countywide Rap Funding to the General Fund Summer Camp Scholarship Program; and **C)** Budget Amendment of \$200,000 in the General Fund Summer Camp Scholarship Program to establish budget for scholarship expenses.

Summary: On March 14, 2006, the Board approved providing an additional \$470,000 to the Community Action Program's Summer Camp Scholarship Program to ensure that all qualified applicants were funded. Budget transfers of \$270,000 from the General Fund Contingency and \$200,000 from the Park Improvement Fund Countywide RAP Funding to the General Fund Summer Camp Scholarship Program will provide the additional funding needed for FY2006 Summer Camp Scholarships. **Countywide (AH)**

Background and Policy Issues: The Community Action Program received 2,290 applicants for the FY2006 Summer Camp Scholarship Program. In order to adequately fund all qualified applicants, the Board approved the transfer of \$200,000 allocated to Countywide RAP funding and \$270,000 from the contingency reserves. These budget transfers and budget amendment will provide the additional funding necessary to cover the estimated costs of the FY2006 summer camp program.
