FIRST AMENDMENT TO INTERLOCAL AGREEMENT

THIS FIRST AMENDMENT to Agreement R2004-0896, dated May 18, 2004, is made as of by and through its Board of County Commissioners, hereinafter referred to as the County, and Wellington Regional Medical Center, a corporation licensed to do business in the State of Florida ("Hospital"), with a federal tax id number of 23-2306491.

In consideration of the mutual promises contained herein, the County and Hospital agree as follows:

- 1. The term of Agreement R2004-0896, set to expire on May 18, 2007, shall be extended to May 18, 2010.
- 2. All other terms of Agreement R2004-0896 remain unmodified and in full force and effect.
