I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Work Authorization No. 33 to the Water Utilities Department Continuing Construction Contract with Foster Marine Contractors, Inc. (R2005-0781) for Okeechobee Blvd Force Main Extension in the amount of \$247,298.



Summary: On April 19, 2005, the Board approved the Water Utilities Department Continuing Construction Contract with Foster Marine Contractors, Inc. (R2005-0781). This Work Authorization is necessary to integrate the County's Utilities system with the pipelines purchased from the Village of Royal Palm Beach in accordance with the Utility Purchase and Sales Agreement (R2006-0410). By connecting the portable and force main systems, the county can more efficiently operate it system and serve its customers. The Small Business Enterprise (SBE) participation goal established by the SBE Ordinance (R2002-0064) is 15% overall. The contract with Foster Marine Contractors, Inc. provides for SBE participation of 15.20% overall. This authorization includes 15.34% overall participation. The cumulative SBE participation, including this Work Authorization, is 15.41% overall.

Background and Justification: On April 19, 2005, the Board awarded the Water Utilities Department Continuing Construction Contract to Foster Marine Contractors, Inc. (R2005-0781). The construction of the force main and water main is to connect the recently acquired pipelines.

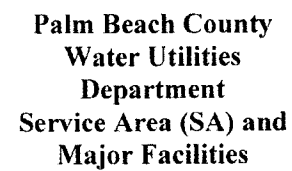

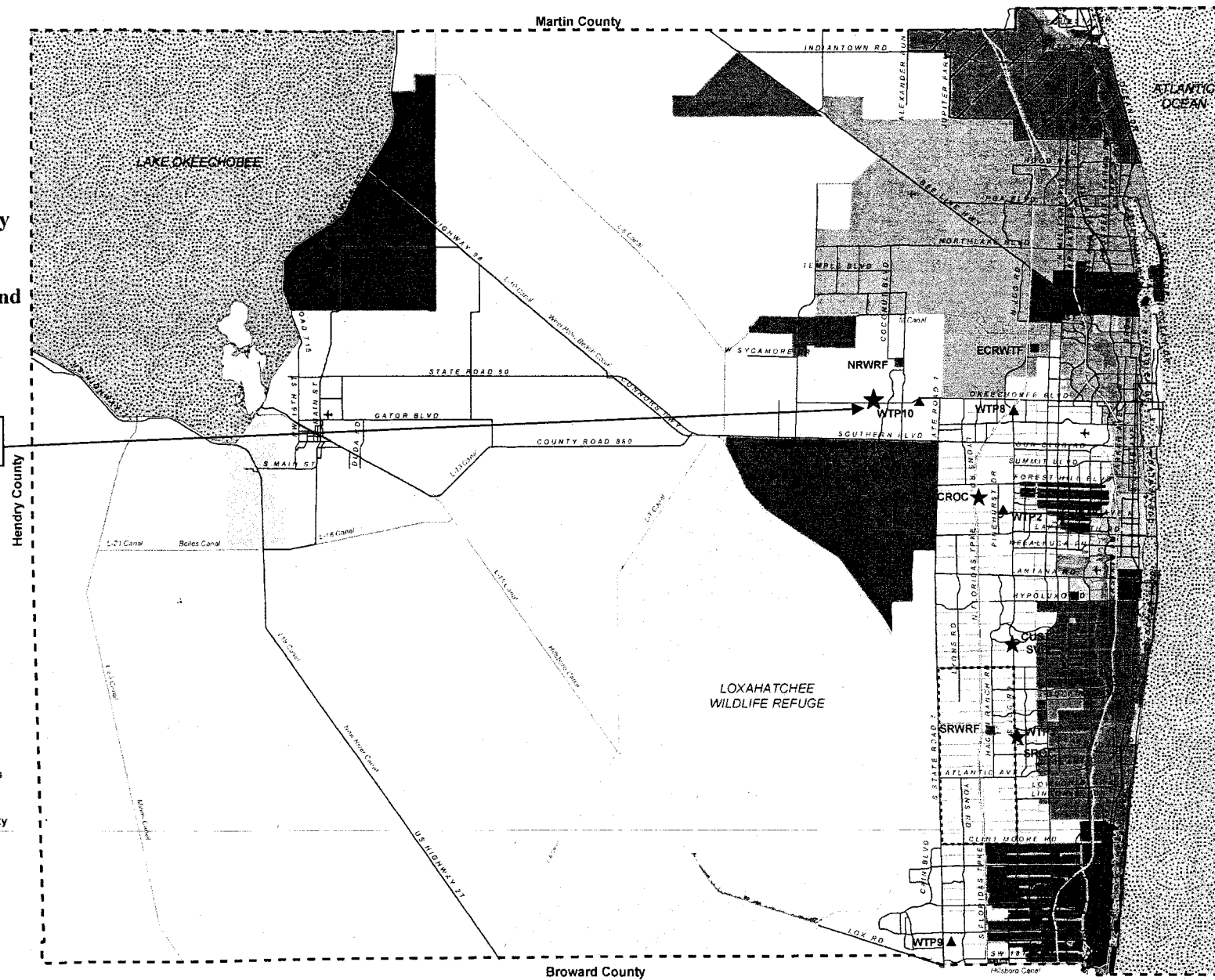

SCOPE OF WORK FOR Okeechobee Blvd. Force Main Extension

INTRODUCTION

Palm Beach County (County) entered into a Contract for Construction Services dated April 19, 2005 (Resolution/Document 2005-0781), by and between Palm Beach County and Foster Marine Contractors, Inc., for the Construction Services of this Authorization.

This Contract for Construction Services is for construction of 3,015 lineal feet of 10-inch force main and 350 lineal feet of 12-inch water main complete with all fittings and appurtenances.

SCOPE OF SERVICES

The Contractor shall provide and install 3,015 lineal feet of 10-inch force main and 350 lineal feet of 12-inch water main complete with all fittings and appurtenances in accordance with Palm Beach County Water Utilities Department Minimum Engineering and Construction Standards, as indicated in the construction plans and contract documents.
