## I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: First Amendment to Agreement (R2005-0344) with the Migrant Association of South Florida, Inc. for funding of the After School/Homework Assistance Program to amend Exhibit "A" to the Agreement and to expand the project timeframe.

Summary: This First Amendment to Agreement expands the list of approved project elements and project timeframe for the After School/Homework Assistance Program. The revised project elements list reflects actual costs expended for this completed Project. The expanded timeframe revises the project initiation date from April 1, 2004, to March 1, 2004, and the project completion date from March 31, 2005, to October 31, 2006. District 5 (AH)

Background and Justification: This First Amendment to Agreement provides a revised Exhibit "A" page 2 of 2 to the Agreement. This revised project/program elements list accurately reflects actual line items for project costs for the After School/Homework Assistance Program, and is necessary to allow for reimbursement of all expenses for this completed project. The revised line items are within the approved scope and intent of the originally approved project, and the amended page 2 of 2 is necessary to allow reimbursement for all program costs. The Amendment also expands the project timeframe from April 1, 2004, through March 31, 2005, to March 1, 2004, through October 31, 2006. Difficulties encountered by the Migrant Association in 2005 involving a traffic accident with fatalities slowed the organization's ability to submit and follow through on its reimbursement request in a timely fashion. All other terms of the Agreement remain the same.

The Amendment has been executed on behalf of the Migrant Association of South Florida, Inc., and now needs to be approved by the Board of County Commissioners.

# FIRST AMENDMENT TO AGREEMENT BETWEEN PALM BEACH COUNTY AND MIGRANT ASSOCIATION OF SOUTH FLORIDA, INC. FOR FUNDING OF THE AFTER SCHOOL/HOMEWORK ASSISTANCE PROGRAM

THIS FIRST AMENDMENT is entered into on \_\_\_\_\_\_, by and between Palm Beach County, a political subdivision of the State of Florida, hereinafter referred to as "County", and Migrant Association of South Florida, Inc., a Florida not-for-profit corporation authorized to do business in the State of Florida, herein referred to as "MASF".

#### WITNESSETH:

WHEREAS, on February 15, 2005, COUNTY entered into an Agreement with MASF (R-2005-0344), hereinafter referred to as "Agreement" to provide Recreation Assistance Program (RAP) funding in an amount not to exceed \$40,000 for funding of the After School/Homework Assistance Program, for the period April 1, 2004, through March 31, 2005, hereinafter referred to as the Project; and

WHEREAS, MASF has requested that County amend Exhibit "A", pg. 2 of 2, to said Agreement, to accurately reflect actual costs expended for this completed Project within the approved scope and budget of the Project; and

WHEREAS, MASF has requested that County expand the Project timeframe from April 1, 2004, through March 31, 2005, to March 1, 2004, through October 31, 2006, to allow for the reimbursement of eligible expenses incurred for the project and to allow time for the completion of the reimbursement process for this completed Project; and

WHEREAS, the Project benefited all citizens of Palm Beach County.

NOW THEREFORE, the parties hereby agree as follows:

- 1. A revised Exhibit "A", pg. 2 of 2, as attached hereto and incorporated herein by reference, shall replace the original Exhibit "A" pg. 2 of 2, attached to the original Agreement.
- 2. The fifth Whereas Clause shall be amended to state: "MASF has requested that County provide \$40,000 to help defray program costs to include personnel costs, payroll taxes & benefits, transportation, equipment, internet access, utilities, insurance, rent, teacher aids, hired cleaning staff, field trips supplies, and other miscellaneous expenses related to the Project for the period March 1, 2004, through October 31, 2006; and"
- 3. Section 3 of the Agreement shall be amended to state: "MASF incurred expenses for the Project beginning on March 1, 2004. Those costs incurred by MASF for the Project, approved and submitted accordingly by MASF subsequent to March 1, 2004, are eligible for reimbursement by County pursuant to the terms and conditions hereof."
- 4. Section 8 of the Agreement shall be amended to state: "The term of this Agreement shall be until October 31, 2006, commencing upon the date of execution by the parties hereto."
- 5. Section 11 of the Agreement shall be amended to state: "MASF shall complete the Project and shall provide its final reimbursement request(s) and final accounting data to County for the completed project on or before October 31, 2006."
- 6. Except as provided herein, each and every other term of the Agreement shall remain in full force and effect and the Agreement is reaffirmed as modified herein.
