I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to: **A) adopt** an Ordinance of the Board of County Commissioners of Palm Beach County, Florida, amending Chapter 10, Section 10-9, Palm Beach County Code, to increase the civil traffic penalty surcharge collected to fund driver education programs in schools; providing for repeal of laws in conflict; providing for severability; providing for inclusion in the code of laws; providing for captions; and providing for an effective date; and **B) approve** Budget Amendment of \$348,000 in the Driver's Education Trust Fund.

Summary: On September 10, 2002, the Board of County Commissioners adopted Ordinance No. 2002-063 as amended by Ordinance 2002-071, dated December 17, 2002, which provides for the collection of \$3.00 with each civil traffic penalty to fund a Driver Education Safety Trust Fund program. This proposed amendment will increase the surcharge from \$3.00 to \$5.00 for each civil traffic penalty. Since the inception of this program 13,547 students have been trained. The Palm Beach County Safety Council conducts the Driver Education classes for the Palm Beach County School Board and has indicated that the current funding is insufficient to keep up with maintenance costs and the number of requests for training. A budget amendment is needed to recognize additional revenue from fees collected. Countywide (SF)

Background and Justification: During the 2006 Legislative session, the Dori Slosberg Driver Education Safety Act, Section 318.1215, Florida Statutes, was amended to increase the amount of the surcharge to be collected on each civil traffic penalty, which is to be used to fund driver education programs in schools. On September 10, 2002, the Board of County Commissioners passed Ordinance No. 2002-063 to implement the Driver Education Safety Trust Fund program, pursuant to the Dori Slosberg Driver Education Safety Act (The "Act"). The original ordinance provided for collection of a \$3.00 surcharge with each civil traffic penalty. The proposed amendment increases the amount of the surcharge the County will collect to \$5.00, as provided for in the amendment to Section 318.1215, Florida Statutes.

ORDINANCE NO. 20 ____ - ____

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, AMENDING CHAPTER 10, SECTION 10-9, PALM BEACH COUNTY CODE, TO INCREASE THE CIVIL TRAFFIC PENALTY SURCHARGE COLLECTED TO FUND DRIVER EDUCATION PROGRAMS IN SCHOOLS; PROVIDING FOR REPEAL OF LAWS IN CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE OF LAWS; PROVIDING FOR CAPTIONS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Palm Beach County adopted Ordinance No. 2002-063, later amended by Ordinance No. 2002-071, which implements Section 98, Chapter 2002-20, Laws of Florida, known as the "Dori Slosberg Driver Education Safety Act," which authorized counties to enact an ordinance requiring the clerk of the court to collect an additional \$3.00 with each civil traffic penalty to be used to fund driver education programs in public and non-public schools; and

WHEREAS, the Legislature has amended the "Dori Slosberg Driver Education Safety Act", now codified as Section 318.1215, Florida Statutes, to increase from \$3.00 to \$5.00 the amount of the surcharge counties may collect on each civil traffic penalty; and

WHEREAS, the Board of County Commissioners of Palm Beach County desires to amend Chapter 10, Section 10-9, Palm Beach County Code, to increase the amount of the surcharge the county may collect on each civil traffic penalty from \$3.00 to \$5.00; and

WHEREAS, the Board of County Commissioners of Palm Beach County finds that collection of the increased surcharge will facilitate the implementation of driver education programs in public and nonpublic schools within the county.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

Section 1. Chapter 10, Section 10-9, Palm Beach County Code, (Ordinance No. Ordinance No. 2002-063, as amended by Ordinance No. 2002-071) is amended to read as follows:

Section 2. CREATION OF DRIVER EDUCATION SAFETY TRUST FUND, COLLECTION OF AN ADDITIONAL \$5.00 ~~\$3.00~~ WITH EACH CIVIL TRAFFIC PENALTY TO BE DEPOSITED IN THE DRIVER EDUCATION SAFETY TRUST FUND, AND ACCOUNTING.

1 a.) Pursuant to the Dori Slosberg Driver Education Safety Act, ~~on and after October 1,~~
2 ~~2002,~~ the clerk shall collect an additional \$5.00 ~~\$3.00~~ with each civil traffic penalty levied in
3 the county to be used for driver education programs.

4 b.) The clerk will keep a record of monies collected under this section. On a monthly
5 basis, the clerk of the circuit court shall forward all monies collected under this section in the
6 previous month to the board of county commissioners for deposit into a special and separate
7 account titled "Driver Education Safety Trust Fund." Once each quarter, the board of county
8 commissioners shall receive a report from the county administrator as to the amount of money
9 received from the clerk and deposited into the driver education safety trust fund, and as to the
10 amount of money disbursed from the driver education safety trust fund.

11 **Section 2. REPEAL OF LAWS IN CONFLICT:**

12 All local laws and ordinances in conflict with any provisions of this Ordinance are
13 hereby repealed to the extent of such conflict.

14 **Section 3. SEVERABILITY:**

15 If any section, paragraph, sentence, clause, phrase, or word of this Ordinance is for any
16 reason held by a court of competent jurisdiction to be unconstitutional, inoperative, or void,
17 such holding shall not affect the remainder of this Ordinance.

18 **Section 4. INCLUSION IN THE CODE OF LAWS AND ORDINANCES:**

19 The provisions of this Ordinance shall become and be made a part of the Code of Laws
20 and Ordinances of Palm Beach County, Florida. The sections of this Ordinance may be
21 renumbered or relettered to accomplish such, and the word "ordinance" may be changed to
22 "section", "article", or other appropriate word.

23 **Section 5. CAPTIONS:**

24 The captions, section headings, and section designations used in this Ordinance are for
25 convenience only and shall have no effect on the interpretations of the provisions of this
26 Ordinance.

27 **Section 6. EFFECTIVE DATE:**

28 The provisions of this Ordinance shall become effective on October 1, 2006 and upon
29 filing with the Department of State.

ORDINANCE NO. 2002-071

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, AMENDING ORDINANCE 2002-063, PROVIDING FOR QUARTERLY DISBURSEMENTS OF DRIVER EDUCATION SAFETY TRUST FUNDS TO THE PALM BEACH COUNTY SCHOOL BOARD; PROVIDING FOR REPEAL OF LAWS IN CONFLICT; PROVIDING FOR INCLUSION IN THE CODE OF LAWS AND ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Palm Beach County enacted Ordinance No. 2002-063 to implement Section 98, Chapter 2002-20, Laws of Florida, known as the "Dori Slosberg Driver Education Safety Act," which authorizes counties to enact an ordinance requiring the clerk of the court to collect an additional three dollars (\$3.00) with each civil traffic penalty to be used to fund driver education programs in public and non-public schools; and

WHEREAS, Ordinance No. 2002-063 provides for annual disbursement of a percentage of Driver Education Trust Fund monies to the School Board of Palm Beach County; and

WHEREAS, the Board of County Commissioners of Palm Beach County finds that quarterly disbursement of Driver Education Trust Fund monies will facilitate implementation of driver education programs in public schools.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

Section 1. QUARTERLY DISBURSEMENT OF DRIVER EDUCATION TRUST FUND MONIES TO THE PALM BEACH COUNTY SCHOOL BOARD

Section 3 of Ordinance No. 2002-063 is amended to read:

Section 3. DISBURSEMENT OF DRIVER EDUCATION SAFETY TRUST FUND MONIES

a.) Monies deposited into the Driver Education Safety Trust Fund shall be used to financially assist driver education safety programs in public and non-public schools in the County. The funds shall be used for

1 direct educational expenses and shall not be used for
2 administration costs.

3 b.) ~~On an annual basis,~~ A percentage of the funds
4 collected under this Ordinance shall be disbursed at the
5 end of each fiscal quarter to the School Board of Palm
6 Beach County for driver education programs in public
7 schools. The percentage of funds disbursed to the School
8 Board shall be based on the number of students enrolled
9 in public schools that are eligible to participate in
10 driver education programs. In order to receive funding
11 under this Ordinance, the School Board shall execute a
12 Grant Acceptance Agreement, acknowledging that funds
13 received under this Ordinance shall only be used for
14 direct educational expenses for driver education
15 programs, and promising that funds received under this
16 Ordinance will not be used to replace existing driver
17 education funding levels or funding sources.

18 c.) A percentage of the funds collected under this
19 Ordinance shall be made available for disbursement to
20 eligible non-public schools as part of a grant program.
21 The percentage of funds disbursed to eligible non-public
22 schools as part of the grant program shall be based on
23 the number of students enrolled in non-public schools
24 that are eligible to take driver education.

25 d.) Grant program procedures shall be developed by
26 the County Administrator and approved by the Board of
27 County Commissioners. A Grant Program Administrator may
28 be designated by interlocal agreement, resolution of the
29 Board of County Commissioners, or other formal directive
30 by the Board of County Commissioners. In order to
31 receive funds from the Driver Education Safety Trust
32 Fund, eligible grant applicants shall apply for funds and
33 receive grant approval in accordance with grant program

1 procedures, and shall execute a Grant Acceptance
2 Agreement, acknowledging that funds received under the
3 Ordinance shall only be used for direct educational
4 expenses for driver education programs, and promising
5 that funds received under this Ordinance will not be used
6 to replace existing driver education funding levels or
7 funding sources.

8 e.) Non-public elementary schools, middle schools,
9 and high schools that offer driver education instruction
10 are eligible to apply for a grant under this Ordinance.

11 f.) Criteria that may be considered as a basis for
12 grant selection includes, but is not limited to the
13 following:

14 1.) The number of years the grant applicant has
15 administered a driver education program;

16 2.) The number of students who have successfully
17 completed the grant applicant's driver education
18 program;

19 3.) The grant applicant's safety record;

20 4.) The extent to which the grant applicant's
21 curriculum meets all applicable local, state, and
22 federal guidelines for driver education programs.

23 g.) Final approval of grant awards shall be made
24 by the Board of County Commissioners upon recommendation
25 by the Grant Program Administrator or the County
26 Administrator.

27 h.) Monies that have not been disbursed at the end
28 of each fiscal year shall be retained for disbursement in
29 the following fiscal year.

Section 2. REPEAL OF LAWS IN CONFLICT:

All local laws and ordinances in conflict with any provisions
of this Ordinance are hereby repealed to the extent of such
conflict.

Dear Mr. Bonvento,

Drivers Education summer school is in full swing right now at six area High Schools. Public and private school students who cannot otherwise take this course during their school year take it during the summer. Parents are very appreciative, and count on us to provide the driving component of the classroom curriculum.

The popularity of Drivers Education is growing everyday not only during summer school but also throughout the entire year.

Palm Beach County has taken a leadership role in adopting this essential program and should applaud its success thus far. Our County Commissioners have set the precedent for other counties around the state to follow. We have the largest program and others contact us to see how to implement a similar program in their counties.

The three-dollar assessment money has enabled us to train many students; however, the demand is greater than the dollars available. We urgently need to increase the assessment to \$5.00 on each moving violation.

We have 21 training vehicles and gas and maintenance prices have skyrocketed in the last year alone. We appeal to the County Commissioners to increase the assessment to \$5.00 so that we may continue this worthwhile program.

This grass roots program that started back in 1999 had many community partners but it is the assessment dollars that has taken this program to the level it is at now. Many students have been trained and we are now into our eighth year of providing Behind the Wheel driving.

I am happy to report that we have trained 13,547 students since its inception. The program has grown each and every year; in fact, since January of this year through today's date we have trained 1,737 students.


