I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Contract with Southeast Drilling Services, Inc. for the Systemwide Wellfield Improvements and East Central Regional Wastewater Treatment Facility (ECRWWTF) Wellhead Replacement Project in the amount of \$4,095,000.

Summary: On August 9, 2006, three (3) construction bids were received for construction of the Systemwide Wellfield Improvements and ECRWWTF Wellhead Replacement Project with Southeast Drilling Services, Inc. being the low bidder in the amount of \$4,095,000. This project provides for construction of four (4) new and five (5) replacement surficial aquifer wells along with modifications to monitoring wells at the ECRWWRF. The Small Business Enterprise (SBE) participation goal established by the SBE Ordinance is 15.0% overall. This contract with the Southeast Drilling Services, Inc. provides for SBE participation of 19.37% overall.

Background and Justification: This project provides for construction of four (4) new wells for the expansion of Water Treatment Plant No. 8. In addition, five (5) replacement wells will be constructed at Water Treatment Plant No. 3 and 9 as the existing wells are approximately 25 to 30 years old and no longer perform at their rated capacity. Also included are modifications to the monitoring wells at the ECRWWTF. The cost for the ECRWWTF work shall be reimbursed to the Department from the ECRWWTF Operations Board. On Wednesday, August 9, 2006, three (3) bids were received with Southeast Drilling Services, Inc. submitting the low bid in the amount of \$4,095,000. Staff and consultants have reviewed the bids and recommend award to the low bidder, Southeast Drilling Services, Inc. in the amount of \$4,095,000.



The bid opening for the above referenced project was held on Wednesday, August 9, 2006. Proposals were received from three (3) contractors as follows not including bid alternates:

Southeast Drilling Services AC Schultes of Florida Florida Design Contractors

\$4,095,000.00 \$5,628,210.00

\$5,640,000.00

The complete Bid Tabulation is attached. The CDM's opinion of probable construction cost was \$6,460,000.00. An evaluation of the low bid not is as follows:

- 1. Southeast Drilling Services bid is 73% of the second low bidder and only 63% of the Engineers cost estimate. However, Southeast Drilling Services has the most experience with our requirements having constructed numerous wells for PBC WUD within the last 5 years. In addition, this project was a re-bid having been previously bid in May of 2006.
- 2. Bid security equal to 5% of the total base bid was enclosed with the bid.
- 3. SBE-M/WBE Schedules #1 and 2 were provided with 19.37% participation. Therefore the contractor did meet 15% SBE goals established under the SBE Ordinance. The Office of Small Business Assistance Compliance Review is attached stating the Contractor meet the SBE goal.
- 4. The contractor and sub-contractors have current licenses.

The overall experience, qualifications, resources and references of the low bidder were carefully considered when evaluating the bids. Contract award is recommended to the

lowest responsive bidder, Southeast Drilling Services. in the amount not to exceed \$4,095,000.00 subject to formal approval by the Board of County Commissioners. A copy of this notice has been posted at the bid opening location and will be left there for a minimum of five (5) business days.

We reviewed the two (2) bids received at the bid opening of August 9, 2006 for the Palm Beach County System Wide Wellfield Improvements Project. We have prepared a bid tabulation and enclosed a copy for your reference. The Bidders are listed in the bid tabulation in numerical order based on the low bidder first.

The two bids received on the Project are as follows:

Bidder	Total Base Bid Item Nos. 1 through 14
Florida Design Contractors, Inc.	\$5,640,000
2. Southeast Drilling Services, Inc.	\$4,095,000

Each of the Bidders attached a bid bond in an amount of 5 percent of the Grand Total Base Bid. Each of the Bidders acknowledged receipt of the Addendum No. 1, issued on July 19, 2006 and Addendum No. 2, issued on July 31, 2006.

We have determined that all of the bids were mathematically correct.

Southeast Drilling Services, Inc. included a small business of 21 percent. There were no errors in the small business schedules.

Florida Design Contractors, Inc. and Southeast Drilling Services, Inc. are certified local business and, as such, provided a valid occupational license issued by the County Tax Collector. Both bidders provided a valid state license.

As stated in the Instructions to Bidders, the contract shall be awarded based upon the Base Bid by the lowest responsive, responsible bidder by the County. The low bidder, Southeast Drilling Services, Inc., is currently under contract to drill the Lake Region Water Treatment Plant (LRWTP) Floridan wells for Palm Beach County. The County is therefore familiar with both the quality of their work and the progress maintained throughout the project.

We have, therefore, determined that Southeast Drilling Services, Inc. is a responsible contractor who, in our opinion, is capable of undertaking the work on the Palm Beach County System Wellfield Improvements Project in a satisfactory and timely manner. Accordingly, we recommend the County award a construction contract to the low bidder, Southeast Drilling Services, Inc. of Florida in the amount of \$4,095,000 for the construction of the wells and wellheads associated with the System Wide Wellfield Improvements Project and the monitoring well no. 2 and 6 wellhead replacement at the East Central Regional Water Reclamation Facility (ECRWRF).
