#### I. EXECUTIVE BRIEF

**Motion and Title:** Staff recommends motion to approve: A) Contract with The Dow Chemical Company/Filtec Corporation (Dow Chemical) for the Lake Region Water Treatment Plant (LRWTP) Reverse Osmosis Membrane Elements in the amount of \$1,398,400; and B) Amendment No. 1 reducing the contract amount to \$786,600 by accepting Dow Chemical's standard terms and warranty provisions.

**Summary:** On June 14, 2006, one (1) bid was received for the supply of reverse osmosis membrane elements for the LRWTP with Dow Chemical being the sole bidder in the amount of \$1,398,400. The Water Utilities Department recommends approval of Amendment No. 1 to accept an unsolicited bid alternate in the amount of \$786,600 by accepting Dow Chemical's standard terms and warranty provisions modifying the general conditions and deleting the Public Construction Bond, resulting in a savings of \$611,800. The Dow Chemical membrane elements have undergone a rigorous proof test using the Floridan test wells for the LRWTP. The Small Business Enterprise (SBE) participation goal established by the SBE Ordinance is 15.0% overall. Due to the specialized nature of the work, this contract with Dow provides for zero SBE participation.

Background and Justification: The cities of Belle Glade, Pahokee and South Bay, as well as the unincorporated areas of the Lake Region, are facing many challenges regarding public water supply. These challenges include difficulty to treat Lake Okeechobee water, outmoded treatment plants, a rapidly changing regulatory environment and funding shortages. In order to help resolve this situation, the Board approved Bulk Water Service Agreements on February 3, 2004 with the cities of Belle Glade (R-2004-0245), Pahokee (R-2004-0246) and South Bay (R-2004-0247) for the construction of a new Lake Region Water Treatment Plant. The membrane pilot testing has been completed and three membrane manufacturers' elements were successfully proof tested. Only two of the three manufacturers purchased bid specifications (Dow Chemical and Koch Fluid System). On June 14, 2006, one (1) bid was received with the Dow Chemical as the sole bidder in the amount of \$1,398,400 which exceeds the Engineer's estimate of \$1,000,000. An unsolicited bid alternate was also submitted by Dow which offered the same membranes for the amount of \$786,600, conditioned upon use of Dow Chemical's standard terms and conditions instead of the County's. WUD approached Koch Fluid Systems and asked if they would bid the project if it were re-advertised utilizing terms and conditions similar to those proposed by Dow. Koch, which did not bid the project, stated by email that they would not submit a bid even if the project were re-advertised using the County's technical criteria (which are unchanged by Dow's alternate proposal) and terms and conditions similar to those proposed in the alternate submitted by Dow Chemical. Staff and consultants have reviewed the bids and recommend award to Dow Chemical as the lowest bidder with approval of Amendment No. 1 to accept the bid alternate in the amount of \$786,600.







The bid opening for the above referenced project was held on Wednesday, June 13, 2006. Proposals were received from one (1) contractor. The Dow Chemical Co./Filmtec Corp. submitted a bid in the amount of \$1,398,400.00 and a bid alternate for the same identical membranes with Dow's standard terms and warranty in the amount of \$786,600.00. The recommendation for award is on the bid alternate (see attached). The bidder was non-responsive to the SBE goal. An evaluation of the Poole & Kent Co. of Florida's bid is as follows:

- 1. Bid security equal to 5% of the total base bid was enclosed with the bid.
- 2. SBE-M/WBE Schedules #1 and 2 were provided with 0.0% participation. Therefore the contractor <u>did not</u> meet 15% SBE goals established under the SBE Ordinance.
- 3. There are no sub-contractors.

The overall experience, qualifications, resources and references of the low bidder were carefully considered when evaluating the bids. Contract award is recommended to the lowest responsive bidder, The Dow Chemical Co./Filmtec Corp. in the bid alternate amount not to exceed \$786,600.00 subject to formal approval by the Board of County Commissioners. A copy of this notice has been posted at the bid opening location and will be left there for a minimum of five (5) business days.
