# FIRSTAMENDMENT BETWEEN PALM BEACH COUNTY AND NEW HOPE CHARITIES, INC. FOR DESIGN COSTS FOR THE CONSTRUCTION OF A COMMUNITY BASKETBALL COURT AND PURCHASE OF EQUIPMENT

THIS FIRST AMENDMENT is entered into on \_\_\_\_\_, by and between Palm Beach County, a political subdivision of the State of Florida, hereinafter referred to as "County", and New Hope Charities, Inc., a not-for-profit corporation authorized to do business in the State of Florida, hereinafter referred to as "New Hope Charities".

### WITNESSETH:

WHEREAS, on September 13, 2005, COUNTY entered into an Agreement with New Hope Charities (R-2005-1734), hereinafter referred to as "Agreement", to provide funding in an amount not-to-exceed \$30,000 for the construction of a community basketball court and purchase of equipment to be completed on or before March 12, 2007, hereinafter referred to as the Project; and

WHEREAS, due to delays because of active hurricane seasons, construction efforts for this project have been delayed, New Hope Charities has requested that the project completion date be amended to March 12, 2008; and

WHEREAS, the Project will benefit all citizens of Palm Beach County.

**NOW THEREFORE,** in consideration of the covenants and promises contained herein, the parties hereby agree as follows:

- 1. Paragraph 11 of the Agreement shall be amended by <u>deleting</u> "New Hope Charities shall complete the Project and shall provide its final reimbursement request(s) and final accounting data to County for the completed project on or before eighteen (18) months, commencing upon the date of execution of this Agreement by the parties hereto. Upon written notification to County at least ninety (90) days prior to that date New Hope Charities may request an extension beyond this period for the purpose of completing the Project. County shall not unreasonably deny New Hope Charities' request for said extension." and <u>inserting</u> "New Hope Charities shall complete the Project and shall provide its final reimbursement request(s) and final accounting data to County for the completed project on or before March 12, 2008. Upon written notification to County at least ninety (90) days prior to that date New Hope Charities may request an extension beyond this period for the purpose of completing the Project. County shall not unreasonably deny New Hope Charities' request for said extension." in its place.
- 2. Except as provided herein, each and every other term of the Agreement shall remain in full force and effect and the Agreement is reaffirmed as modified herein.
