RESOLUTION NO. R-2006-

RESOLUTION **OF** THE **BOARD OF COUNTY** COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR OR HIS DESIGNEE (FIRE-RESCUE ADMINISTRATOR) EXECUTE CERTAIN SATISFACTION AND RELEASE OF CLAIM **FORMS** RELATING TO FIRE-RESCUE EMERGENCY TRANSPORT FEES AND RELATED SERVICE CHARGES.

WHEREAS, from time to time, it is necessary for the County Fire-Rescue Department or its billing agent to file a claim in a probate proceeding in order to collect emergency transport fees and related service charges billed by the County in accordance with Section 13-58, Palm Beach County Code; and

WHEREAS, upon payment of said fees and charges to the County, the probate estate requires documentation that said claims have been satisfied and released; and

WHEREAS, the Board of County Commissioners desires to delegate to the County Administrator, or the Fire-Rescue Administrator as his designee, the authority to execute certain satisfaction and release of claim forms in order to more expeditiously respond in the probate proceedings; and

WHEREAS, the execution of these satisfaction and release of claim forms in a form substantially similar to that set forth in Exhibit "A" and under the conditions set forth herein is a ministerial function and does not constitute policy level decision-making.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

The County Administrator or his designee (the Fire-Rescue Administrator) is hereby authorized to execute, on behalf of the Board of County Commissioners, a satisfaction and release of claim form in favor of a probate estate if all of the following conditions are met:

1) the terms and conditions of such form are substantially similar to those contained in the form set forth as Exhibit "A" attached hereto; 2) such form has been approved as to form and legal sufficiency by the County Attorney or her designee; 3) the claim to be released relates to emergency transport fees and related service charges billed by the County or its billing agent in accordance with Section 13-58, Palm Beach County Code; 4) the total claim to be released is not more than One Thousand Five Hundred Dollars (\$1500.00); and 5) the

claim to be released has been paid in full or otherwise has been settled or compromised in accordance with the appropriate authority and procedures established by the County.
