Summary: Mr. Bruce A. Malasky has been recommended as a new appointee to replace Edward Cury Seat #6 who is not eligible for another term on the CILB, by his respective organization. Mr. Harry Rosen has been recommended as a new appointee to replace Mal Behl seat# 13 who is not eligible for another term. The Palm Beach County Construction Industry Management Council recommends the following individuals: Mr. Steven C. Smith and Mr. John A. Lowen for a second term. Mr. Lee P. Feely has indicated a willingness to continue for another term. The nominations represent seats for the Residential Contractor, HARV Contractor and the Electrical Contractor and two Consumer Members as so cited in the Special Act establishing the Construction Industry Licensing Board. Countywide (GB)

Background and Justification: The Construction Industry Licensing Board was established by Special Act, Chapter 67-1876, Laws of Florida as amended, by Section 489.131. The Special Act sets forth the membership of the Board, which consists of twelve (12) members. The membership consists of two (2) general contractors, one (1) member of the following categories; building; residential; electrical; plumbing; HARV, roofing; swimming pool; architect; engineer and a building official. In addition, F.S. § 489.131 requires that we have three (3) consumer representatives.

FS. 489.131 (CONSUMER REPRESENTATIVES)

(10) No municipal or county government may issue any certificate of competency or license for any contractor defined in s. 489.105(3)(a)-(o) after July 1, 1993, unless such local government exercises disciplinary control and oversight over such locally licensed contractors, including forwarding a recommended order in each action to the board as provided in subsection (7). Each local board that licenses and disciplines contractors must have at least two consumer representatives on that board. **If the board has seven or more members, at least three of those members must be consumer representatives. The consumer representative may be any resident of the local jurisdiction who is not, and has never been, a member or practitioner of a profession regulated by the board or a member of any closely related profession.**

BOARD MEMBER QUALIFICATIONS

(B) To be eligible for appointment each contractor member shall be:

(1) Actively engaged in the construction business in Palm Beach County and have held a certificate of competency in his name and have been so engaged for a period of not less than 5 consecutive years immediately before the date of his appointment, and be a resident of Palm Beach County. The architect and engineer member shall be licensed in the State of Florida and be a resident of Palm Beach County.

(2) Each member of the Board except the Building Official shall hold a valid certificate issued by this Board or the state of Florida in addition to having the qualifications required in subsection (B) (1) above.
