I.EXECUTIVE BRIEF
Motion and Title: Staff recommends motion to approve:
A. A Budget Transfer of \$150,000 in the Transportation Improvement Fund from Reserve for District 4 to Palmetto Park Road Bascule Bridge.
B A Budget Transfer of \$150,000 in the Capital Outlay Fund from Palmetto Park Bascule Bridge to Grant-Centre for the Arts at Mizner Park – District 4.
C. A Reimbursement Agreement in the amount of \$150,000, with the Centre for the Arts at Mizner Park for rental of an events tent.
Summary: These Budget Transfers and Reimbursement Agreement will reimburse the Centre for the Arts at Mizner Park up to \$150,000 for the rental of an events tent in support of the Festival of the Arts Boca.
District: 4 (MC)
Background and Justification: The Centre for the Arts at Mizner Park (Centre) is renting an events tent in support of the Festival of the Arts Boca project. This project serves a public purpose by raising the level of quality of the cultural landscape and promoting the attractiveness of the County as a tourist destination and a quality place to ive. The Centre requested funding assistance from the District 4 Commissioner for this project. The District 4 Commissioner wishes to provide funds for the project up to \$150,000 in the best interest of public health and welfare.



AGREEMENT BETWEEN PALM BEACH COUNTY AND THE CENTRE FOR THE ARTS AT MIZNER PARK FOR RENTAL OF AN EVENTS TENT

THIS AGREEMENT is made and entered into on ______, by and between Palm Beach County, a political subdivision of the State of Florida, hereinafter referred to as "County", and the Centre for the Arts at Mizner Park, Inc., a Florida not-for-profit corporation authorized to do business in the State of Florida, hereinafter referred to as "Centre".

WITNESSETH:

WHEREAS, the CENTRE is a 501(C)(3) not-for-profit organization; and WHEREAS, the CENTRE unites the community through culture; and WHEREAS, the CENTRE has requested that County provide an amount not to exceed \$150,000 to assist with the cost of renting an events tent, hereinafter PROJECT, to assist with the CENTRE's Festival for the Arts, Boca, programs and activities; and

WHEREAS, County desires to provide funding for rental for said PROJECT; and WHEREAS, the CENTRE's activities serve a public benefit by uniting the community through culture; and

WHEREAS, both parties desire to enter into this Agreement.

NOW THEREFORE, in consideration of the covenants and promises contained herein, the parties hereby agree to the following terms and conditions:

- 1. County agrees to fund an amount not to exceed \$150,000 to the **CENTRE** for the rental, for the **PROJECT**, incorporated herein, hereinafter referred to as the "**PROJECT**".
- 2. County will use its best efforts to provide said funds to the **CENTRE** on a reimbursement basis within forty-five (45) days of receipt of the following information:
 - a. A copy of the rental invoice and cancelled check.
- b. A Contract Payment Request Form and a Contractual Services Purchases Schedule Form attached hereto and made a part hereof as Exhibit "A", which are required for each reimbursement requested by the CENTRE. Said information shall list each invoice paid by the CENTRE and shall include the vendor invoice number; invoice date; and the amount paid by the CENTRE along with the number and date of the respective

check and/or proof of payment for said payment. The CENTRE shall attach a copy of each vendor invoice paid by the CENTRE along with a copy of the respective check and/or proof of payment, and shall make reference thereof to the applicable item listed on the Contractual Services Purchases Schedule. Further, the CENTRE's Financial Officer shall certify the total funds spent by the CENTRE on the PROJECT and shall also certify that each vendor invoice, as listed on the Contractual Services Purchases Schedule was paid and approved by the CENTRE as indicated.

- 3. **CENTRE** incurred expenses for the **PROJECT** beginning on October 1, 2006. Those costs incurred by the **CENTRE** for the **PROJECT** approved and submitted accordingly by the **CENTRE** subsequent to October 1, 2006, are eligible for reimbursement by County pursuant to the terms and conditions hereof.
- 4. These funds may be used as a match for other local, state, or federal grant programs, but the **CENTRE** may not submit reimbursement requests for the same expenses to the County as other fund sources to receive duplicate reimbursement for the same expenses.
- 5. The **CENTRE** warrants that it is an active not-for-profit corporation, duly chartered and registered with the Florida Department of State, Division of Corporations.
- 6. The **CENTRE** agrees, warrants, and represents that all of the employees and participants in the **PROJECT** will be treated equally during employment, and for the provision of services without regard to residency, race, color, religion, disability, sex, age, national origin, ancestry, marital status, or sexual orientation.
- 7. The **CENTRE** shall be responsible for all costs of operation and maintenance of the **PROJECT**.
- 8. The term of this Agreement shall be for one (1) year, commencing upon the date of execution by the parties hereto.
- 9. The parties agree that, in the event the CENTRE is in default of its obligations under this Agreement, the County shall provide the CENTRE thirty (30) days written notice to cure the default. In the event the CENTRE fails to cure the default within the thirty (30) day cure period, the County shall have no further obligation to honor reimbursement requests submitted by the CENTRE for the PROJECT deemed to be in default and

CENTRE shall return any funds already collected by the CENTRE for that PROJECT.

- 10. Not withstanding any provision of this Agreement to the contrary, this Agreement may be terminated by the County, without cause, upon thirty (30) days prior written notice to the other party. This Agreement may be terminated by the County with cause, upon expiration of the thirty (30) day cure period provided for in Section 9 above.
- 11. The CENTRE shall complete the PROJECT and shall provide its final reimbursement request(s) and final accounting data to County for the completed PROJECT on or before one (1) year, commencing upon the date of execution by the parties hereto. Upon written notification to County at least ninety (90) days prior to that date, the CENTRE may request an extension beyond this period for the purpose of completing the PROJECT. County shall not unreasonably deny the CENTRE's request for said extension.
- 12. In the event the CENTRE ceases to exist, or ceases or suspends the PROJECT for any reason, any remaining unpaid portion of this Agreement shall be retained by County, and County shall have no further obligation to honor reimbursement requests submitted by the CENTRE. The determination that the CENTRE has ceased or suspended the PROJECT shall be made by County and the CENTRE agrees to be bound by County's determination.
- 13. The CENTRE agrees to abide by, and be governed by, all applicable federal, state, county, and municipal laws, including but not limited to, Palm Beach County's ordinances, as said laws and ordinances exist and are amended from time to time. In entering into this Agreement, Palm Beach County does not waive the requirements of any County or local ordinance or the requirements of obtaining any permits or licenses normally required to conduct business or activity conducted by the CENTRE. Failure to comply may result in County's refusal to honor reimbursement requests for the PROJECT.
- 14. County reserves the right to withhold reimbursement if the **PROJECT** is not completed as specified.
- 15. It is understood and agreed that the **CENTRE** is merely a recipient of County funding and is an independent contractor and is not an agent, servant or employee of County or its Board of County Commissioners. It is further acknowledged that the County

only contributes funding under this Agreement and operates no control over the **PROJECT**. In the event a claim or lawsuit is brought against County or any of its officers, agents or employees, the **CENTRE** shall indemnify, save and hold harmless and defend the County, its officers, agents, and/or employees from and against any and all claims, liabilities, losses, judgments, and/or causes of action of any type arising out of or relating to any act or omission of the **CENTRE**, its agents, servants and/or employees in the performance of this Agreement. The foregoing indemnification shall survive termination of this Agreement.

In consideration for reimbursement of costs incurred prior to the term of this Agreement, the foregoing indemnification shall apply not only during the term of this Agreement but also for the period prior to the Agreement for which the **CENTRE** is eligible to receive reimbursement from the County.

16. the CENTRE shall, at its sole expense, agree to maintain in full force and effect at all times during the life of this Agreement, insurance coverages and limits (including endorsements), as described herein. The requirements contained herein, as well as County's review of acceptance of insurance maintained by the CENTRE are not intended to and shall not in any manner limit or qualify the liabilities and obligations assumed by the CENTRE under this Agreement.

Commercial General Liability. The CENTRE shall maintain Commercial General Liability at a limit of liability not less than \$500,000 Each Occurrence. Coverage shall not contain any endorsement excluding Contractual Liability or Cross Liability unless granted in writing by County's Risk Management Department. The CENTRE shall provide this coverage on a primary basis.

Worker's Compensation Insurance & Employer's Liability. The CENTRE shall maintain Worker's Compensation & Employers Liability in accordance with Florida Statute Chapter 440. The CENTRE shall provide this coverage on a primary basis.

Additional Insured. The CENTRE shall endorse the County as an Additional Insured with a CG 2026 Additional Insured - Designated Person or Organization endorsement, or its equivalent, to the Commercial General Liability. The Additional Insured endorsement shall read "Palm Beach County Board of County Commissioners, a Political Subdivision of the State of Florida, its Officers, Employees and Agents." The CENTRE

shall provide the Additional Insured endorsements coverage on a primary basis.

<u>Waiver of Subrogation</u>. The CENTRE hereby waives any and all rights of Subrogation against the County, its officers, employees and agents for each required policy. When required by the insurer, or should a policy condition not permit an insured to enter into a pre-loss agreement to waive subrogation without an endorsement, then the CENTRE shall agree to notify the insurer and request the policy be endorsed with a Waiver of Transfer of Rights of Recovery Against Others, or its equivalent. This Waiver of Subrogation requirement shall not apply to any policy, when a condition to the policy specifically prohibits such an endorsement, or voids coverage should the CENTRE enter into such an agreement on a pre-loss basis.

Certificate(s) of Insurance. Prior to execution of this Agreement by the County, the CENTRE shall deliver to the County a Certificate(s) of coverage evidencing that all types and amounts of insurance coverages required by this Agreement have been obtained and are in full force and effect. Such Certificate(s) of Insurance shall include a minimum thirty (30) day endeavor to notify due to cancellation or non-renewal of coverage. Certificate holder's address shall read Palm Beach County, Board of County Commissioners, 301 N. Olive Ave., West Palm Beach Florida 33401.

Right to Review. County, by and through its Risk Management Department, in cooperation with the contracting/monitoring department, reserves the right to review, modify, reject or accept any required policies of insurance, including limits, coverages, or endorsements, herein from time to time throughout the term of this Agreement. County reserves the right, but not the obligation, to review and reject any insurer providing coverage because of its poor financial condition or failure to operate legally.

- 17. Upon request by County, the **CENTRE** shall demonstrate financial accountability through the submission of acceptable financial audits performed by an independent auditor.
- 18. The **CENTRE** shall maintain books, records, documents and other evidence that sufficiently and properly reflect all costs of any nature expended in the performance of this Agreement for a period of not less than five (5) years. Upon advance notice to the **CENTRE**, County shall have the right to inspect and audit said books, records, documents

and other evidence during normal business hours.

19. The County and **CENTRE** may pursue any and all actions available under law to enforce this Agreement including, but not limited to, actions arising from the breach of any provision set forth herein.

20. This Agreement shall be governed by the laws of the State of Florida and any and all legal action necessary to enforce this Agreement shall be held in Palm Beach County.

21. As provided in Section 287.132-133, Florida Statutes, by entering into this Agreement or performing any work in furtherance hereof, the **CENTRE** certifies that it, its affiliates, suppliers, subcontractors and consultants who will perform hereunder, have not been placed on the convicted vendor list maintained by the State of Florida Department of Management Services within the thirty six (36) months immediately preceding the date hereof. This notice is required by Section 287.133 (3) (a), Florida Statutes.

22. This Agreement represents the entire agreement between the parties and supersedes all other negotiations, representations, or agreement, either written or oral, relating to this Agreement. This Agreement may be modified and amended only by written instrument executed by the parties hereto.

23. Any notice given pursuant to the terms of this Agreement shall be in writing and hand delivered or sent by U.S. mail. All notices shall be addressed to the following:

beneficiary or otherwise.
