**I. EXECUTIVE BRIEF**

**Motion: Staff recommends motion to approve:** reappointment of Mami Kisner to the Tourist Development Council (TDC) to fill her unexpired term for Seat No. 8 beginning December 12, 2006, through November 16, 2008.

**Summary:** Pursuant to the Local Option Tourist Development Act, Ordinance No. 2003-001, which sets the composition, qualifications, terms and removal of the TDC members, the TDC is composed of nine (9) members. One (1) member is the Chair of the Board of County Commissioners (BCC) or designee, seven (7) members are BCC District appointments and one (1) member is an at-large appointment. Ms. Kisner was removed for absences. The District 7 Commissioner wishes to reappointment Ms. Kisner to Seat No. 8 on the TDC as the absences were due to family illness. Countywide (MC)


