## I. EXECUTIVE BRIEF

**MOTION AND TITLE: Staff recommends motion to approve:** A) a Budget Transfer of \$250,000 in the Criminal Justice Reserve Fund to transfer funds to the Information Systems Services (ISS) Fund for the Visual Planning Technology Project; and, B) a Budget Amendment of \$250,000 in the ISS Fund to recognize the transfer of funds from the Criminal Justice Reserve Fund.

**SUMMARY:** On November 13, 2006, the Criminal Justice Commission (CJC) approved the use of Criminal Justice Reserve Funds to complete the Visual Planning Technology (VPT) Project to link local law enforcement agency's data systems for intelligence sharing. <u>Countywide</u> (DW)

**BACKGROUND AND POLICY ISSUES:** At the November 2006 CJC Annual Planning Meeting, State Attorney Barry Krischer presented a request for CJC approval to use Criminal Justice Reserve Funds to provide partial funding to complete the VPT project. The VPT project was initiated by the Criminal Justice Commission to institute automated ways for sharing crime data between law enforcement agencies in Palm Beach County. The project involves a coordinated commitment from countywide law enforcement agencies and other public safety and criminal justice leaders to integrate management information systems that will become part of a national "Fusion Center" being developed at the Palm Beach County Sheriff's Office linking criminal justice, public safety, emergency operations, corrections and other national intelligence centers. County Information System Services (ISS) staff is managing project implementation. The VPT project was originally funded federal grant money that is not longer available and therefore falls within the purpose area established for the use of Criminal Justice Reserve funds. The total cost to complete the project is approximately \$1 million with the remaining \$750,000 begin pursued by the State Attorney from the Police Chiefs Association, the Emergency Operations Center, the Health Department and various Fire Service agencies.

The CJC voted to approve this one time allocation from this revenue source to complete the VPT project.

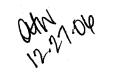
