## I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** Amendment No. 4 to the General Consulting Agreement with CH2M Hill, Inc. for Consulting/Professional Services to exercise the first one-year renewal option for the continued performance of professional planning and design services related to the approved Palm Beach County Airports' Capital Improvement Program.

**Summary:** The Consulting Agreement (R-2005-0319) with CH2M Hill, Inc. for general airport planning and design was approved on February 15, 2005 in order to carry out the approved Capital Improvement Programs for the County's Airports. On February 7, 2006 the County entered into Amendment No. 1 (R-2006-0194) to provide additional services. On May 16, 2006 the County entered into Amendment No. 2 (R-2006-0841) to provide additional services. On October 17, 2006 the County entered into Amendment No. 3 (R-2006-2207) to provide additional services. This Amendment will allow the County, at its sole discretion, to exercise the first one (1) year renewal option for the continuation of services provided under this Agreement. There is no fiscal impact associated with this Amendment. The Disadvantaged Business Enterprise (DBE) Goal will remain at 28.52%. <u>Countywide (JCM)</u>

Background and Justification: In order to carry out the approved Capital Improvement Program for the County, the Department of Airports requires professional planning and design engineering services. On February 15, 2005 the County entered into a Consulting Agreement (R2005-0319) with CH2M Hill, Inc. for General Airport Planning and Design. On February 7, 2006 the County entered into Amendment No. 1 (R-2006-0194) to provide services for Specific Projects such as: System Wide Airport Master Planning Study (Phase II), Cabin Air System Terminal Signage Construction Documents, FEMA Disaster Improvements, Assistance, Property Acquisition Services, Phase I Environmental Site Assessment, 2006 Feasibility Report, PFC Application Support, and Pahokee Facility Reconstruction, as well as Annual Services, and Miscellaneous and Administrative Services. On May 16, 2006 the County entered into Amendment No. 2 (R-2006-0841) to provide Construction Management Services for the Long Term Parking Garage No. 2 at Palm Beach International Airport (PBIA), Concourse B and C Panel Repairs (hurricane repairs) at PBIA, and Terminal Skylight Replacement (hurricane repairs) at PBIA. On October 17, 2006 the County entered into Amendment No. 3 (R-2006-2207) to provide additional services including Property Acquisition Services, Stormwater Management Master Plan and SFWMD Conceptual Environmental Resource Permit Application, Letter of Intent Application and Benefit Cost Analysis, Delay and Capacity Simulation Study, Environmental Impact Statement Planning Support, FEMA Disaster Assistance and Request for Proposal (RFP) Development, as well as various miscellaneous and administrative services, including staff extension, planning and engineering, construction administration, maintenance support and County permitting reviews. The Agreement is for 2 years with 2 one-year renewal options. The base Agreement expires on February 14, 2007, thus requiring the renewal option to ensure continuation of the services provided by the Consultant under the Agreement.

### WITNESSETH

WHEREAS, on February 15, 2005, the County entered in to an Agreement (R2005 0319) with the CONSULTANT for the CONSULTANT to provide General Airport Consulting Services for the Palm Beach County Department of Airports, for a period of 24 months with up to two (2) additional twelve (12) month renewals at the County's Option (the Contract); and

WHEREAS, on February 7, 2006, the County approved Amendment No. 1 (R2006 0194) to agreement (R2005 0319) with the CONSULTANT, and

WHEREAS, on May 16, 2006, the County approved Amendment No. 2 (R2006 0841) to agreement (R2005 0319) with the CONSULTANT, and

WHEREAS, on October 17, 2006, the County approved Amendment No. 3 (R2006 2207) to agreement (R2005 0319) with the CONSULTANT, and

WHEREAS, Article 2 of the Contract defines the performance period of the contract as two (2) years, with two (2) one (1) year renewal options, the exercise of which are within County's sole control and discretion, and

WHEREAS, it is the County's desire to exercise the first one (1) year renewal option for the continuation of services provided by the CONSULTANT under this contract.

NOW THEREFORE, in considerations of the mutual covenants herein contained, and such other good and valuable consideration, the receipt of which the parties hereby acknowledge, the parties agree to the following terms and conditions.

- 1. The parties hereby agree to amend the Contract to include the first one (1) year renewal option for the continuation of services provided by the CONSULTANT under this contract.
- 2. Except as specifically amended herein, all other terms and conditions of the Contract shall remain in full force and effect.
