**Summary:** On January 9, 2007, Resolution No. R2007-0028 was approved to increase the Public Art Committee to ten members to expand Committee expertise and improve efficiency in artist selection process. The Committee recommends that one of the seats be designated for a Landscape Architect professional to assist the Committee to successfully integrate the landscape and outdoor public art projects. In addition, the Committee recommends that an alternate seat be created for a Palm Beach County resident with significant visual art background. The term for both new Committee members will be through September 2009 which is the end date of the term for the current Committee members (FDO Admin) Countywide (MJ)
