

ASSIGNMENT OF RIGHT TO PURCHASE AND WAIVER OF CLAIMS FOR LOSS OF ACCESS

THIS AGREEMENT by and between RUE ANTIBES, LLC., a Florida limited liability company and PALM BEACH COUNTY a political subdivision of the State of Florida,

WITNESSETH that

WHEREAS RUE ANTIBES, LLC. desires to acquire the following described parcel of real property [hereinafter "the Property"]:

Lot 8, Block 68, FRANKLIN PARK, a subdivision of the City of West Palm Beach, Florida, according to the plat thereof on file in the office of the Clerk of the Circuit Court in and for Palm Beach County, Florida, in Plat Book 7, Page 57

and

WHEREAS the current owner of the Property, JOSEPH A. ROSSO, has asserted a claim against Palm Beach County arising from alleged loss or diminution of access to the Property or from the property to Palm Beach Lakes Blvd. or 12th St. as a result of the proposed placement of an overpass on Palm Beach Lakes Boulevard over the Florida East Coast Railway right of way, and

WHEREAS PALM BEACH COUNTY has negotiated a purchase of the Property from JOSEPH A. ROSSO together with a release from ROSSO of any claim for loss or diminution of access, and

WHEREAS PALM BEACH COUNTY is willing to assign its purchase rights to RUE ANTIBES, LLC in return for a release by RUE ANTIBES, LLC of any claim for loss or diminution of access and RUE ANTIBES, LLC is willing to accept such purchase rights and grant such release,

NOW THEREFORE, for and in consideration of the premises the parties agree as follows:

- I. PALM BEACH COUNTY hereby assigns to RUE ANTIBES, LLC, a Florida limited liability company, all rights that it may have to purchase the Property.
- II. RUE ANTIBES, LLC does hereby waive and release in favor of PALM BEACH COUNTY any claim which it may acquire, as owner of the Property, against PALM BEACH COUNTY as a result of any loss diminution of access to the Property or from the property to Palm Beach Lakes Blvd. or 12th St. resulting from the placement or existence of an overpass of Palm Beach Lakes Boulevard over the Florida East Coast Railway right of way. This waiver and release does not include any claims that may arise
