I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: reallocation of \$4,000,000 in project funding within the 2002 \$50 Million Recreational and Cultural Facilities Bond referendum from Boca Raton Cultural Center (\$3,000,000), Old School Square Expansion (\$500,000), and Little Palm Family Theater (\$500,000) to the following projects:

Summary: The District 4 Commissioner has identified \$4,000,000 from the \$50 Million Recreational and Cultural Facilities Bond, which she has requested that the Board reallocate to various municipal and not-for-profit agency projects as listed above in the motion and title. <u>District 4</u> (PK)

Background and Justification: The \$4,000,000 comes from three projects, i.e. the Boca Raton Cultural Center (\$3,000,000), the Little Palm Family Theater at FAU (\$500,000), and the Old School Square Expansion project (\$500,000). The Boca Raton Cultural Center and Little Family Palm Theater projects were not ready to proceed within a reasonable time frame and the Commissioner has indicated her desire to reallocate the \$3.5 Million from these two projects toward more viable and timely projects. The remaining \$500,000 to create the total of \$4,000,000 for reallocation will be made available from the \$1,000,000 Delray Beach/Old School Square parking garage allocation, and that funding will subsequently be replaced with discretionary gas tax funding for which a parking garage is an eligible expenditure.
