## I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve**: First amendment to the agreement (R2004-0897) with Boca Raton Community Hospital, Inc. (Hospital) to extend the term of the agreement until May 18, 2010.

**Summary:** The Agreement provides the terms and conditions under which the Hospital can program into its radios and utilize the countywide and EMS common talk groups for certain types of inter-agency communications, will expire on May 18, 2007. The agreement provides for three (3) - three (3) year renewals but renewals require approval by both parties. Boca Raton Community Hospital has approved a renewal to extend the term of the agreement until May 18, 2010. The renewal now requires Board approval. The terms of the agreement are standard and have been offered to other hospitals and EMS providers. There are no charges associated with this agreement. The Hospital is required to pay all costs associated with subscriber units and to comply with the established operating procedures for the System. The Agreement may be terminated by either party, with or without cause. (FDO/ESS) <u>Countywide</u> (JM)

### FIRST AMENDMENT TO INTERLOCAL AGREEMENT
