I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Agreement with Knights of Pythagoras Mentoring Network, Inc. (Knights of Pythagoras) for the period April 10, 2007, through April 30, 2007, in an amount not-to-exceed \$4,000 for the Y2K '06 Tennis Jamboree and miscellaneous programs.

Summary: This funding is to help offset costs for the Y2K '06 Tennis Jamboree and other miscellaneous programs. The Agreement allows for the reimbursement of eligible project costs incurred by Knights of Pythagoras subsequent to October 1, 2006. Funding is from the Recreation Assistance Program (RAP). District 7 (AH)

Background and Justification: Knights of Pythagoras is a not-for-profit organization whose mission is to educate and inspire young men in Palm Beach County by promoting a healthy lifestyle through positive peer pressure and community leadership. Knights of Pythagoras offered the Y2K '06 Tennis Jamboree and other miscellaneous programs designed to expose program participants between ages seven through seventeen to recreational activities such as tennis, field trips, assembling of Thanksgiving baskets for 100 families, and a Christmas toy drive to provide toys for 300 area children. Knights of Pythagoras activities served over 650 participants.

The total cost of the events was approximately \$12,700 for transportation, lunch, breakfast, tennis rackets and balls, turkeys, toys appropriate for young children, and other miscellaneous expenses related to the Y2K '06 Tennis Jamboree and other programs. The \$4,000 from the Recreation Assistance Program – District 7 will offset a portion of the total project cost. The Agreement has been executed on behalf of Knights of Pythagoras Mentoring Network, Inc., and now needs to be approved by the Board of County Commissioners.

AGREEMENT BETWEEN PALM BEACH COUNTY AND KNIGHTS OF PYTHAGORAS MENTORING NETWORK, INC. FOR THE Y2K '06 TENNIS JAMBOREE AND MISCELLANEOUS PROGRAMS

THIS AGREEMENT is made and entered into on _____, by and between Palm Beach County, a political subdivision of the State of Florida, hereinafter referred to as "County" and the Knights of Pythagoras Mentoring Network, Inc., a Florida not-for-profit corporation, hereinafter referred to as "Knights of Pythagoras".

WITNESSETH:

WHEREAS, Knights of Pythagoras is a not-for-profit organization whose mission is to educate and inspire young men in Palm Beach County by promoting a healthy lifestyle through positive peer pressure and community leadership; and

WHEREAS, Knights of Pythagoras offered the Y2K '06 Tennis Jamboree and other miscellaneous programs designed to expose program participants between ages seven (7) through seventeen (17) to recreational activities such as tennis, a Florida History field trip to Rosewood, Florida, a Thanksgiving turkey ride to provide thanksgiving baskets for one hundred (100) families, and a Christmas toy drive to provide toys for three hundred (300) area children; and

WHERAS, the Y2K '06 Tennis Jamboree and miscellaneous programs cost approximately \$12,700 and served over six hundred and fifty (650) participants; and

WHEREAS, Knights of Pythagoras has requested that County provide \$4,000 to help offset costs paid for the Y2K '06 Tennis Jamboree and miscellaneous programs for transportation, food, tennis rackets and balls, turkeys, toys appropriate for young children, and other miscellaneous expenses associated with the Y2K '06 Tennis Jamboree and miscellaneous programs; and

WHEREAS, funding for the Tennis Y2K '06 Jamboree and miscellaneous programs in an amount not-to-exceed \$4,000 is available from District 7 Recreation Assistance Program (RAP) reserves; and

WHEREAS, cultural and recreational programs for youth serve a public benefit; and WHEREAS, both parties desire to enter into this Agreement.

NOW THEREFORE, in consideration of the covenants and promises contained herein, the parties hereby agree to the following terms and conditions:

1. County agrees to fund an amount not-to-exceed \$4,000 to Knights of Pythagoras to help offset costs for the Y2K '06 Tennis Jamboree and other miscellaneous programs for transportation, lunch, breakfast, tennis rackets and balls, turkeys, toys appropriate for young

children, and other miscellaneous expenses related to the Y2K '06 Tennis Jamboree and other programs, as described in Exhibit "A", attached hereto and incorporated herein, and hereinafter referred to as the "Project".

2. County will use its best efforts to provide said funds to Knights of Pythagoras on a reimbursement basis within forty-five (45) days of receipt of the following information:

a. A written statement that the Project, as specified herein, was carried out in accordance with this Agreement; and

b. A Contract Payment Request Form and a Contractual Services Purchases Schedule Form attached hereto and made a part hereof as Exhibit "B", which are required for each and every reimbursement requested by Knights of Pythagoras. Said information shall list each invoice paid by Knights of Pythagoras and shall include the vendor invoice number; invoice date; and the amount paid by Knights of Pythagoras along with the number and date of the respective check or proof of payment for said payment. Knights of Pythagoras shall attach a copy of each vendor invoice paid by Knights of Pythagoras along with a copy of the respective check or proof of payment and shall make reference thereof to the applicable item listed on the Contractual Services Purchases Schedule. Further, Knights of Pythagoras' Program Administrator and Project Financial Officer shall certify the total funds spent by Knights of Pythagoras on the Project and shall also certify that each vendor invoice, as listed on the Contractual Services Purchases Schedule was paid by Knights of Pythagoras and approved by Knights of Pythagoras as indicated.

3. Knights of Pythagoras incurred expenses for the Project beginning on October 1, 2006. Those costs incurred by Knights of Pythagoras for the Project, approved and submitted accordingly by Knights of Pythagoras subsequent to October 1, 2006, are eligible for reimbursement by County pursuant to the terms and conditions hereof.

4. RAP funds may be used as a match for other local, state, or federal grant programs, but Knights of Pythagoras may not submit reimbursement requests for the same expenses to the County as other fund sources to receive duplicate reimbursement for the same expenses.

5. Knights of Pythagoras warrants that it is an active not-for-profit corporation, duly chartered and registered with the Florida Department of State, Division of Corporations.

6. Knights of Pythagoras agrees, warrants, and represents that all of the employees and participants in the Project will be treated equally during employment and for the provision of services without regard to residency, race, color, religion, disability, sex, age, national origin, ancestry, marital status, or sexual orientation.

7. Knights of Pythagoras shall be responsible for the operation and maintenance of the Project, including all associated costs.

8. The term of this Agreement shall be until April 30, 2007, commencing upon the date of execution by the parties hereto.

9. The parties agree that, in the event Knights of Pythagoras is in default of its obligations under this Agreement, the County shall provide Knights of Pythagoras thirty (30) days written notice to cure the default. In the event Knights of Pythagoras fails to cure the default within the thirty (30) day cure period, the County shall have no further obligation to honor reimbursement requests submitted by Knights of Pythagoras for the Project deemed to be in default and Knights of Pythagoras shall return any County RAP funds already collected by Knights of Pythagoras for that Project.

10. Notwithstanding any provision of this Agreement to the contrary, this Agreement may be terminated by the County, without cause, upon thirty (30) days prior written notice to the other party. This Agreement may be terminated by the County with cause, upon expiration of the thirty (30) day cure period provided for in Section 9 above.

11. Knights of Pythagoras completed the Project by December 31, 2006, and invoices and checks submitted for reimbursement must be dated within the project time frame of October 1, 2006, through December 31, 2006. Knights of Pythagoras shall provide its final reimbursement request(s), including a project completion statement and reimbursement documentation as indicated in Section 2 above on or before April 30, 2007. Upon written notification to County at least ninety (90) days prior to that date Knights of Pythagoras may request an extension beyond this period for the purpose of completing the Project. County shall not unreasonably deny Knights of Pythagoras's request for said extension.

12. In the event Knights of Pythagoras ceases to exist, or ceases or suspends the Project for any reason, any remaining unpaid portion of this Agreement shall be retained by County, and County shall have no further obligation to honor reimbursement requests submitted by Knights of Pythagoras. The determination that Knights of Pythagoras has ceased or suspended the Project shall be made by County and Knights of Pythagoras agrees to be bound by County's determination.

13. Knights of Pythagoras agrees to abide by, and be governed by, all applicable federal, state, county, and municipal laws, including but not limited to, Palm Beach County's ordinances, as said laws and ordinances exist and are amended from time to time. In entering into this

Agreement, Palm Beach County does not waive the requirements of any County or local ordinance or the requirements of obtaining any permits or licenses normally required to conduct business or activity conducted by Knights of Pythagoras. Failure to comply may result in County's refusal to honor reimbursement requests for the Project.

14. County reserves the right to withhold reimbursement if the Project is not completed as specified in Exhibit "A".

15. It is understood and agreed that Knights of Pythagoras is merely a recipient of County funding and is an independent contractor and is not an agent, servant or employee of County or its Board of County Commissioners. It is further acknowledged that the County only contributes funding under this Agreement and operates no control over the Project. In the event a claim or lawsuit is brought against County or any of its officers, agents or employees, Knights of Pythagoras shall indemnify, save and hold harmless and defend the County, its officers, agents, and/or employees from and against any and all claims, liabilities, losses, judgments, and/or causes of action of any type arising out of or relating to any act or omission of Knights of Pythagoras, its agents, servants and/or employees in the performance of this Agreement. The foregoing indemnification shall survive termination of this Agreement.

In consideration for reimbursement of costs incurred prior to the term of this Agreement, the foregoing indemnification shall apply not only during the term of this Agreement but also for the period prior to this Agreement for which Knights of Pythagoras is eligible to receive reimbursement from the County.

16. Knights of Pythagoras shall, at its sole expense, agree to maintain in full force and effect at all times during the life of this Agreement, insurance coverages and limits (including endorsements), as described herein. The requirements contained herein, as well as County's review and acceptance of insurance maintained by Knights of Pythagoras are not intended to and shall not in any manner limit or qualify the liabilities and obligations assumed by Knights of Pythagoras under this Agreement.

Commercial General Liability. Knights of Pythagoras shall maintain Commercial General Liability at a limit of liability not less than \$500,000 Each Occurrence. Coverage shall not contain any endorsement excluding Contractual Liability or Cross Liability unless granted in writing by County's Risk Management Department. Knights of Pythagoras shall provide this coverage on a primary basis.

<u>Automobile.</u> Knights of Pythagoras shall maintain, during the life of this Agreement, comprehensive automobile liability insurance in the minimum amount of \$500,000 combined

single limit bodily injury and property damage for claims arising from damages for bodily injury including wrongful death, as well as from claims for property damage which may arise from the ownership, use, or maintenance of owned and non-owned automobiles, including rented automobiles, whether such operations be by Knights of Pythagoras or by anyone employed by or contracting with Knights of Pythagoras. Should Knights of Pythagoras use independent bus companies for transportation, it shall require such company or companies to provide automobile liability on such buses in the minimum amount of \$1,000,000 combined single limit bodily injury and property damage liability and shall include Knights of Pythagoras and Palm Beach County as Additional Insured.

Worker's Compensation Insurance & Employer's Liability. Knights of Pythagoras shall maintain Worker's Compensation & Employers Liability in accordance with Florida Statute Chapter 440. Knights of Pythagoras shall provide this coverage on a primary basis.

Additional Insured. Knights of Pythagoras shall endorse the County as an Additional Insured with a CG 2026 Additional Insured - Designated Person or Organization endorsement, or its equivalent, to the Commercial General Liability. The Additional Insured endorsement shall read "Palm Beach County Board of County Commissioners, a Political Subdivision of the State of Florida, its Officers, Employees and Agents." Knights of Pythagoras shall provide the Additional Insured endorsements coverage on a primary basis.

Waiver of Subrogation. Knights of Pythagoras hereby waives any and all rights of Subrogation against the County, its officers, employees and agents for each required policy. When required by the insurer, or should a policy condition not permit an insured to enter into a pre-loss agreement to waive subrogation without an endorsement, then Knights of Pythagoras shall agree to notify the insurer and request the policy be endorsed with a Waiver of Transfer of Rights of Recovery Against Others, or its equivalent. This Waiver of Subrogation requirement shall not apply to any policy when a condition to the policy specifically prohibits such an endorsement, or voids coverage should Knights of Pythagoras enter into such an agreement on a pre-loss basis.

Certificate(s) of Insurance. Prior to execution of this Agreement by the County, Knights of Pythagoras shall deliver to the County a Certificate(s) of coverage evidencing that all types and amounts of insurance coverages required by this Agreement have been obtained and are in full force and effect. Such Certificate(s) of Insurance shall include a minimum thirty (30) day endeavor to notify due to cancellation or non-renewal of coverage. Certificate holder's address

shall read Palm Beach County, c/o Parks and Recreation Department, 2700 Sixth Avenue South, Lake Worth, FL 33461, Attention: Administrative Support Manager.

Right to Review. County, by and through its Risk Management Department, in cooperation with the contracting/monitoring department, reserves the right to review, modify, reject or accept any required policies of insurance, including limits, coverages, or endorsements, herein from time to time throughout the term of this Agreement. County reserves the right, but not the obligation, to review and reject any insurer providing coverage because of its poor financial condition or failure to operate legally.

17. Upon request by County, Knights of Pythagoras shall demonstrate financial accountability through the submission of acceptable financial audits performed by an independent auditor.

18. Knights of Pythagoras shall maintain books, records, documents and other evidence that sufficiently and properly reflect all costs of any nature expended in the performance of this Agreement for a period of not less than five (5) years. Upon advance notice to Knights of Pythagoras, County shall have the right to inspect and audit said books, records, documents and other evidence during normal business hours.

19. The County and Knights of Pythagoras may pursue any and all actions available under law to enforce this Agreement including, but not limited to, actions arising from the breach of any provision set forth herein.

20. This Agreement shall be governed by the laws of the State of Florida and any and all legal action necessary to enforce this Agreement shall be held in Palm Beach County.

21. As provided in Section 287.132-133, Florida Statutes, by entering into this Agreement or performing any work in furtherance hereof, Knights of Pythagoras certifies that it, its affiliates, suppliers, subcontractors and consultants who will perform hereunder, have not been placed on the convicted vendor list maintained by the State of Florida Department of Management Services within the thirty six (36) months immediately preceding the date hereof. This notice is required by Section 287.133 (3) (a), Florida Statutes.

22. This Agreement represents the entire agreement between the parties and supersedes all other negotiations, representations, or agreement, written or oral, relating to this Agreement. This Agreement may be modified and amended only by written instrument executed by the parties hereto.

23. Any notice given pursuant to the terms of this Agreement shall be in writing and hand delivered or sent by U.S. mail. All notices shall be addressed to the following:

24. This Agreement is made solely and specifically among and for the benefit of the parties hereto, and no other person shall have any rights, interest, or claims hereunder or be entitled to any benefits under or on account of this Agreement as a third-party beneficiary or otherwise.


