I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: First Amendment to Agreement (R2006-2488) with The Acreage Athletic League, Inc. for funding of uniforms and equipment for the Acreage Coyotes.

Summary: This fully executed First Amendment to Agreement extends the project completion date for the previously approved Agreement from December 30, 2006, to March 31, 2007, in order to allow additional time to accommodate dates of payment and completion of the reimbursement process. The Amendment is in accordance with Resolution R2005-1738, authorizing the delegation of authority for amending RAP agreements to the County Administrator or his designee. All other terms of the Agreement remain the same. Funding for the project is from the Recreation Assistance Program (RAP). <u>District 6</u> (AH)

Background and Justification: Resolution R2005-1738 was adopted by the Board on September 13, 2005, to streamline the RAP reimbursement process. It establishes terms and conditions for amending RAP projects and delegates authority for the execution of the amendments to the County Administrator or his designee, which is the Director of the Parks and Recreation Department. The criteria for delegated signature of amendments on behalf of the Board include:

- · Changes in project scope/elements within the intent of the approved RAP project;
- Adjustments in budgetary line items within the intent of the approved RAP Project which do not change the contractual amount.;
- Changes to the approved project time frame including the initiation date and/or project completion date for periods of less than one year; and
- Other miscellaneous modifications approved by the awarding Commissioner within the overall intent of the approved RAP project.

This delegation of authority allows for more efficient and timely reimbursements for RAP projects by streamlining the existing RAP process for amendments to agreements. The attached Amendment meets criteria listed above, and was executed on behalf of the Board of County Commissioners by the Director of the Parks and Recreation Department.

FIRST AMENDMENT TO AGREEMENT BETWEEN PALM BEACH COUNTY AND THE ACREAGE ATHLETIC LEAGUE, INC. FOR THE PURCHASE OF UNIFORMS AND EQUIPMENT FOR THE ACREAGE COYOTES

__, by and between Palm Beach THIS AMENDMENT is entered into on _ County, a political subdivision of the State of Florida, hereinafter referred to as "County", and The Acreage Athletic League, Inc., a Florida not-for-profit corporation, herein referred to as "Acreage Athletic League".

WITNESSETH:

WHEREAS, on November 21, 2006, COUNTY entered into an Agreement (R-2006-2488) with Acreage Athletic League, hereinafter referred to as "Agreement" to provide Recreation Assistance Program (RAP) funding in an amount not to exceed \$2,000 for the purchase of uniforms and equipment for the Acreage Coyotes, hereinafter referred to as the "Project"; and

WHEREAS, Acreage Athletic League has requested that County extend the Project completion date from September 30, 2006, to December 31, 2006, and extend the end date for the Project term from December 30, 2006, to March 31, 2007, in order to allow for additional time to accommodate dates of payment and completion of the reimbursement process; and

WHEREAS, the Project will benefit all citizens of Palm Beach County.

NOW THEREFORE, the parties hereby agree as follows:

- 1. Section 8 of the Agreement is amended to read "The term of this Agreement shall be until March 31, 2007, commencing upon the date of execution by the parties hereto".
- 2. Section 11 of the Agreement is amended to read "Acreage Athletic League shall complete the Project by December 31, 2006, and invoices and checks and/or proof of payments submitted for reimbursement must be dated within the Project time frame of May 1, 2006, through December 31, 2006. Acreage Athletic League shall provide its final reimbursement request(s), including a project completion statement and reimbursement documentation as indicated in Section 2 above on or before March 31, 2007.
- 3. Except as provided herein, each and every other term of the Agreement shall remain in full force and effect and the Agreement is reaffirmed as modified herein.
