I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: A Resolution authorizing the County Engineer, the Deputy County Engineer, or designee, to execute the Release of Easement Rights instruments for self-extinguished Temporary Construction Easements that are associated with completed and accepted roadway construction projects.

Summary: This action will authorize the County Engineer, the Deputy County Engineer, or designee, to execute the Release of Easement Rights instruments for the Temporary Construction Easements that have self-extinguished upon completion and acceptance of roadway construction projects.

District: Countywide (PK)

Background and Justification: Palm Beach County is frequently granted Temporary Construction Easements for roadway construction and improvement projects. These easements are only necessary during construction, and are intended to self-extinguish upon completion and acceptance of the construction project. Temporary Construction Easements are recorded in Public Record at the time of acquisition, which creates an easement encumbrance on the parcel. Currently the County does not record any release of these easements in Public Record when the construction is completed and accepted. Property owners have often requested that the County record such a document. To remove this encumbrance, a Release of Easement Rights instrument must be prepared and recorded in Public Record.

It is recommended that the Board approve the Resolution that authorizes the County Engineer, the Deputy County Engineer, or designee, to execute the Release of Easement Rights instruments on behalf of the Board of County Commissioners. This procedure will save the Board's time, and simplify the recording process to remove the easement encumbrances from private property more expeditiously.



RESOLUTION NO. R-2007

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, AUTHORIZING THE COUNTY ENGINEER, DEPUTY COUNTY ENGINEER OR DESIGNEE, TO HAVE THE AUTHORITY TO EXECUTE THE RELEASE OF EASEMENT **INSTRUMENTS** RIGHTS FOR TEMPORARY CONSTRUCTION EASEMENTS ACQUIRED FOR ROADWAY CONSTRUCTION AND IMPROVEMENT PROJECTS ON BEHALF OF THE BOARD OF COUNTY COMMISSIONERS.

WHEREAS, the County Engineer has recommended the acquisition of Temporary Construction Easement parcels to the Board of County Commissioners of Palm Beach County, for the purpose of roadway construction and improvement projects, in Palm Beach County, Florida; and,

WHEREAS, the Temporary Construction Easement parcels are required only during construction in order to give construction forces legal access to areas outside of the road right-of-way; and,

WHEREAS, the Temporary Construction Easement parcels are temporary and selfextinguish upon completion and acceptance of the road construction project; and

WHEREAS, an easement encumbrance against the parcel is created at the time of acquisition by recording the Temporary Construction Easement instrument in the Public Record of Palm Beach County, Florida; and

WHEREAS, the legal instrument entitled Release of Easement Rights, is necessary for recordation in Public Record of Palm Beach County, Florida, to remove the easement encumbrance from the parcel when the roadway construction is completed and accepted; and,

WHEREAS, a Release of Easement Rights instrument, as identified In Exhibit "A", will be prepared upon the completion and acceptance of roadway projects; the document will contain the project identification information, the completion and final

acceptance date of the project and the Temporary Construction Easement recordation information that will be released in Public Record of Palm Beach County, Florida, by the recording of this document.

NOW, THEREFORE, BE IT FURTHER RESOLVED by the Board of County Commissioners of Palm Beach County, Florida, that the County Engineer, Deputy County Engineer or designee, are hereby given the authorization to execute the Release of Easement Rights instruments for self-extinguished Temporary Construction Easements that are associated with completed and accepted roadway construction projects. This execution authority will be given on behalf of the Board of County Commissioners of Palm Beach County for the following public purpose: To release the Temporary Construction Easement encumbrance on property owners land parcels in Public Record of Palm Beach County, Florida.
